REPORTS ON PROJECT/PROGRAMME IMPLEMENTATION: CSE

Background

- 1. At the 15th Adaptation Fund Board meeting, the Board reviewed document AFB/EFC.6/6, *Report on Project/Programme Implementation: CSE* and took note of the semi-annual report submitted by CSE. The Board requested the secretariat communicate to CSE the observations made about the status report and to request that CSE provide more detailed information on the purpose of the contracts and the operational expenses registered under the financial statements.
- 2. CSE provided additional data and information to the secretariat on October 12, 2011. The additional information is contained in the Annex to this document.

Review of the additional information provided by CSE

- 3. The information provided sufficiently addresses the observations made by the secretariat. Specifically, the report provides more detailed information on disbursements to date, the work plan and associated disbursement schedule for the coming year, and procurement details.
- 4. Several important issues were clarified through this additional information, including:

<u>Disbursements</u>: CSE currently has six contracts awarded and signed with a start date. The total value of these contracts amounts to \$2.43 million USD. An additional three contracts are expected to be awarded and signed by November 15, 2011, totaling \$2.65 million USD. The total value of these eight contracts amounts to \$5.08 million USD, over 60% of the total project grant.

5. Given the detailed information on contract amounts and the associated disbursement schedule, it is likely CSE will disburse over 55% of the contract amounts over the course of the next six months (or \$2.8 million USD).

<u>Procurement</u>: CSE has provided information on the competitive bidding process it has undertaken to award contracts. All contracts over \$10,000 USD were either done through an open invitation to tender or limited call for tenders. At least three organizations were considered for each contract.

- 6. For one large contract on the building of the protection dike of Thiawlene (Rufisque-Est), the report notes that "the building of the projection dike ... will be done in synergy with other projects operation in the same area and for the same goal. The State of Senegal had already identified AGETIP as delegated project owner (DPO). For purposes of consistency in the building of works, AGETIP will act as the DPO for the whole works."
- 7. By utilizing the same contractor, CSE is addressing one of the risk factors that the secretariat flagged "disruption in the coordination of building the coastal protection facilities in the area of Rufisque, with possible delays that could be attributed to other donors involved in that activity." The close collaboration with work already taken place should ameliorate this particular risk.

<u>M&E Disbursement</u>: CSE has provided more detailed information about disbursements for M&E. The money has been used to hire full time staff and spend on start-up costs (i.e. office equipment and car rental to monitor the project). The total amount disbursed totals 28% of the total M&E budget. Now that the M&E unit has been set up, the remaining budget will be spent predominantly on monitoring project progress and evaluation.

Conclusion

- 8. The secretariat considers the information provided adequate to address its observations at this time. The second tranche for CSE totals \$1,765,000, which would bring the total amount released to CSE to \$4,689,000. The release of the second tranche would allow CSE to manage its current and future contracts without having to delay work due to a shortage of funds.
- 9. From the disbursement plan it is clear that the bulk of the work is scheduled to be undertaken between now and September 2012; this implies that the majority of funds will also be spent over this time.
- 10. Following the decision made at the 15th Board meeting, the EFC may want to consider recommending the Board to approve the disbursement of the second tranche of funds to CSE.

6. Details on the disbursement of the monitoring and evaluation

Regarding the information provided on the current level of disbursement for M&E, more detailed information on the purpose of these contracts and the operational expenses would be necessary to justify these early expenses before implementation on the ground has started

Please note that the line 6.0 "Monitoring and Evaluation" (M&E) includes three sections (6.1: Monitoring/Follow up; 6.2: External Evaluation and audit; 6.3: Control of realization) for a projected budget of US\$ 390,000.

Out of the US\$ 390 000, only US\$ 108,597.19 have been spent, which is about 28% of budget dedicated to the M&E. This amount was essentially used by DEEC, one of the executing entity, to reinforce its capacity and to face early expenses which are done only once during a project life cycle. The future expenses will be used more specifically for M&E.

Details of operational expenses:

- Equipment and Supply (Materials, Office supplies, Printing, Communication);
- Community-level consultations and meeting (roundtable meetings, quick-off of local and national meetings, project committee meetings, etc.)
- Logistics (rental of two cars for 12 months, fuel, maintenance)

Contracts: (contractors hired by DEEC)

- Contract for Technical Assistant (Mrs. Aida Gueye), fully dedicated to the project, with responsibility of executing routine administrative and technical functions; prepare, drafting and review of technical documents including correspondence, terms of references, technical reports, follow-up, arrange meetings
- Contract for Administrative and Financial Assistant (Mr. Djibril Diallo), fully
 dedicated to the project, with responsibility of support the monitoring and the
 processes of the financial activities of the project. Prepare and review the
 administrative and financial parts of the documents including contracts, terms of
 references, reports and follow-up in accordance with AF procedures.
