PROVISIONAL ANNOTATED AGENDA

1. Opening of the meeting

The meeting will be opened by the outgoing Chair of the Project and Programme Review Committee (PPRC), Mr. Amjad Abdulla (Maldives, SIDS).

2. Transition of the Chair and the Vice Chair

Document: none.

Background: The Board at its 12th meeting decided to endorse the nominations of Mr. Hans Olav Ibrekk (Norway, Western European and Others Group) as Chair, and Mr. Jeffery Spooner (Jamaica, Latin American and Caribbean Countries), as Vice-Chair for a term beginning in March 2011 and ending in March 2012.

Action expected: The outgoing Chair and Vice-Chair will hand over the Chairmanship to the incoming Chair and Vice-Chair.

3. Organizational matters

The PPRC will also be invited to consider the Project Formulation Grant request contained in the document AFB/PPRC.4/4/Add.2 and to make a recommendation on it to the Board for adoption.
