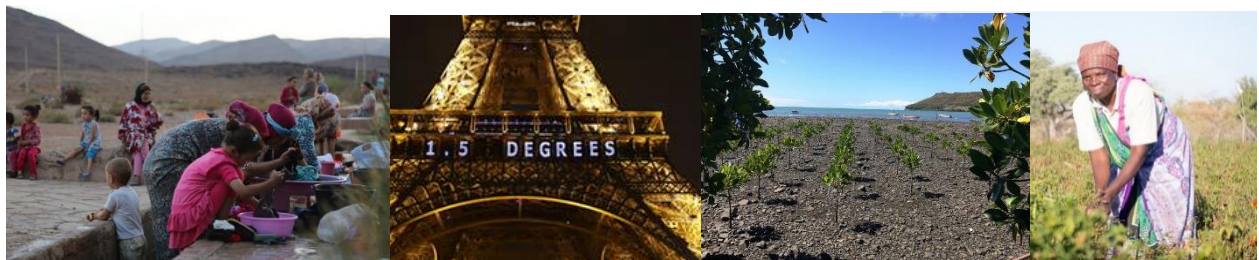

Adaptation Fund – Pioneering Adaptation Finance: Event highlights pioneering work of the Adaptation Fund in climate finance, including groundbreaking experiences in Direct Access, and how the Fund brings value to implementing the Paris Agreement by increasing access to finance and funding concrete replicable climate change adaptation projects in vulnerable communities. The Agreement calls for a balance between mitigation and adaptation, and the Fund helps build national capacities to adapt to climate change. Projects are developed in a transparent process that includes local stakeholders and NGOs. The event also recognizes innovations of the Fund as its 10th anniversary approaches later this year.

Speakers: Adaptation Fund-accredited National Implementing Entities (NIEs) from Antigua and Barbuda, Morocco and South Africa, as well as civil society and Adaptation Fund representatives will provide concrete examples of the Fund's impacts to countries and beneficiaries.
