### **Baseline at time of application submission**

The Ministry of Environment and Energy (MEE) was nominated on 4 January 2017 as the NIE to the Adaptation Fund for the Maldives (see endorsement letter in Annex 1). The MEE has a dedicated staff member working on its accreditation application to the Adaptation Fund, who is coordinating the accreditation process for the MEE. The Department of Environment (DOE) in Antigua and Barbuda will support the accreditation process of the MEE by presenting strategies for capacity building in a SIDS context, providing guidance on the development of policies and manuals for direct access which requires segregation of roles and responsibilities, and lessons learned with leading multi-sector stakeholder engagement processes. The following activities are proposed.
