REQUEST FOR DIRECT PROJECT SERVICES: UNEP (PARAGUAY)

Background

- 1. The Adaptation Fund Board (the Board) at its twenty-ninth meeting, approved a four-year project titled "Ecosystem-based approaches to reduce the vulnerability of food security to the impacts of climate change in the Chaco region of Paraguay" submitted by the United Nations Environment Programme (UNEP) for a request amount of US\$ 7,128,450 (decision B.29/19). The overall project is to reduce the vulnerability of the population (selected family agriculture producers and indigenous communities) of the Chaco Region of Paraguay to the impacts of climate change on food security. In order to do so, the project plans to address the main barriers for adaptation in the selected region. Specifically, the project will seek to i) improve information and knowledge for climate resilience; ii) implement concrete cost-effective on-the-ground adaptation measures; and iii) strengthen the institutional capacities to adequately address climate change adaptation issues. As mandated by the decision, an agreement was prepared and signed between the Board and UNEP.
- 2. The first tranche of disbursement for the implementation of the project was released following signature of the agreement in July 2017. To date, the project has not started implementation. Following signature of the agreement, UNEP and the government of Paraguay, through the Executing Entity for the project, the Secretariat of the Environment (SEAM), have been discussing arrangements for receiving the funds from UNEP. In April 2018, the secretariat has received a correspondence from UNEP informing that SEAM requested UNEP to provide execution services notably direct project services on procurement and personnel administration. Following discussions with the secretariat, UNEP submitted in May 2018 a formal request letter (Annex 1) along with a letter signed by SEAM requesting UNEP to provide such services (Annex 2), and a document explaining the details of the execution costs (Annex 3).
- 3. The execution services proposed to be devolved to UNEP are as follows:
 - Preparation of the Procurement Plan's execution in coordination with SEAM, and
 - Procurement of goods and services, hire individual and institutional consultants and engage in supplementary agreements with non-third parties in compliance with UN implementing Rules and Regulations, and as established in the annual procurement plan previously coordinated and agreed with SEAM.
- 4. To this end, SEAM will hold the national direction of the Project, and will:
 - Ensure that requests to procure goods and services, hire individual and institutional consultants and engage in supplemental agreements with third parties are discussed during the Project Steering Committee meetings and communicated in writing to the UN Environment, and
 - Prepare the terms of reference for acquisition of goods, services and consultant contracts, according to the procurement plan, and submit them to UN Environment for no objection.

Secretariat's review of the request

- 5. Following a review of the request, the secretariat finds that the request from the government of Paraguay is based on the fact that receiving project funds would require SEAM prior approval in the framework of the national budget, implying a long and cumbersome internal procedure which would substantially delay project implementation.
- 6. The original administrative costs remain unchanged, with a suggested allocation of US\$ 99,130 (representing 1.5% of the total budget of the project excluding the implementing entity fees) to UNEP, to cover the direct services for procurement and payment services. The secretariat finds, therefore, the request reasonable and relevant for a timely implementation of the approved project.

Recommendation

7. Therefore, the Board may consider and decide to approve, on an exceptional basis, the provision by UNEP of Direct Project Services up to the amount of US\$ 99,130 for the project "Ecosystem-based approaches to reduce the vulnerability of food security to the impacts of climate change in the Chaco region of Paraguay".

I am writing about the project "Ecosystem Based Approaches for Reducing the Vulnerability of Food Security to the Impacts of Climate Change in the Chaco region of Paraguay".

As you may know, Paraguay's Secretariat of the Environment (SEAM, Spanish acronym), executing entity of the project, has asked UN Environment to provide administrative support for the execution of the project (see letter of request attached).

After exchanges with SEAM and UN Environment Headquarters, Paraguay's SEAM and UN Environment have jointly drafted an agreement that we believe can respond to Paraguay's request while maintaining SEAM's appropriation and respecting UN Environment internal procedures.

In this agreement, UN environment will support SEAM on procurement and personnel administration. To do this, UN Environment will prepare the Procurement Plan in coordination with SEAM, and will procure goods and services, hire individual and institutional consultants and engage in supplementary agreements with non-third parties in compliance with UN implementing Rules and Regulations.

SEAM will hold the national direction of the Project, and will ensure that requests to procure goods and services, hire individual and institutional consultants and engage in supplemental agreements with third parties are discussed during the Project Steering Committee meetings and communicated in writing to UN Environment, and will prepare the terms of reference for acquisition of goods, services and consultant contracts, according to the procurement plan, and submit them to UN Environment for no objection.

To do that, direct project services costs (procurement and payment services) have been reallocated in the reviewed budget. Please note that the total budget of Project Execution Costs does not change. However, part of the costs initially allocated for providing direct project services at the Project Management Unit have been reallocated to UN Environment to cover these direct project services. Also, some items' budget has been slightly reduced to reflect the costs of the procurement and payment services.

Please find attached (i) a table comparing the approved administrative costs with the reviewed administrative costs and (ii) the detailed administrative costs.
