### 4. Options for a window on Enhanced Direct Access

Documents: AFB/PPRC.24/3 Options for a window on Enhanced Direct Access.

Background: The Fund pioneered enhanced direct access (EDA) when the Adaptation Fund Board (the Board) approved at its twenty-fourth meeting two regular sized projects for Costa Rica and South Africa through decisions B.24/8 and B. 24/15, respectively. The projects were unique in that they were the first to put into practice an implementation model that had been presented as a theoretical solution<sup>1</sup>, in which decision-making on the programming of climate finance would be devolved further downstream at the national level, beyond the donor and grant applicant. In EDA, national mechanisms can be used to make decisions on which projects will be funded at the national and sub-national level.

At its thirty-first meeting, the Board subsequently approved the implementation plan for the Medium Term Strategy (MTS) and included new funding windows that could be opened under the MTS in complement of the Fund's existing funding windows. Having recognized that there was a high level of interest among the Fund's stakeholders on EDA, a specific funding window on EDA was included in the MTS implementation plan to complement the Fund's existing funding window for single-country projects.

Document AFB/PPRC.24/3 responds to Board decision B.31/32 and outlines the objectives, review criteria, review process, implementation modalities and several options to fund the window for EDA, based on the Fund's experience with approved EDA projects and lessons learnt by other stakeholders involved with EDA.

Action expected: The PPRC will be invited to discuss the document and to form a recommendation to be forwarded to the Board.

#### 5. Guidance to multilateral implementing entity (MIE) aggregators

Document: AFB/PPRC.24/4 <u>Guidance to multilateral implementing entity (MIE)</u> <u>aggregators</u>

Background: The Medium Term Strategy was adopted by the Adaptation Fund Board (the Board) in its thirtieth meeting, and it included specifically the establishment of a dedicated Innovation Facility in order to (a) roll out successful innovations; (b) scale up viable innovations; (c) encourage and accelerate innovations; and, (d) generate evidence of effective and efficient innovation in adaptation; which would include support via grants of up to \$250,000. At its thirtyfirst meeting, the Board approved the implementation plan for the Medium Term Strategy (MTS) and included new funding windows that could be opened under the MTS in complement of the Fund's existing funding windows, and that would be accessible to both National Implementing Entities via direct access, and entities that are not accredited with the Adaptation Fund via an MIE that would serve as an aggregator for small grant requests. Subsequent to that decision, there was an open request for expressions of interest to serve as MIE aggregator and the review the ensuring responses, which presented document are in

At its thirty-second meeting, the Board decided to approve document AFB/PPRC.23/5/Rev.1, Programme on Innovation: Selection of the Multilateral Entity to administer small grants projects, where the Board decided to invite United Nations Development Programme and the United Nations Environment Programme to serve as the MIE aggregators for small grants for innovation. The Board also requested the secretariat to develop guidance to the MIE aggregators for preparing proposals for small grant programmes for innovation.

Document AFB/PPRC.24/4 responds to Board decision B.32/5 and outlines the objectives, review criteria, and other guidance.

Action expected: The PPRC will be invited to discuss the document and to form a recommendation to be forwarded to the Board.

### 6. Report of the full cost of adaptation reasoning

Documents: AFB/PPRC.24/5 Report on the full cost of adaptation reasoning

Background: At its second meeting in November 2006, the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP) decided that the Adaptation Fund would be guided by a series of principles, among which was "Funding on full adaptation cost basis of projects and programmes to address the adverse effects of climate change" (Decision 5/CMP.2). This principle has been reflected in the Operational Policies and Guidelines (OPG) of the Fund, and state that, while "co-financing is not required, it is possible and often cost-effective to implement Adaptation Fund projects in parallel with projects funded from other sources. In such a situation, the Adaptation Fund project should be able to deliver its outcomes and outputs regardless of the success of the other project(s)."

At its nineteenth meeting, PPRC identified the need to explore ways to address cases where the delivery of Fund-supported activities was dependent on delivery of co-financed activities. The Board subsequently decided to request the secretariat to prepare a proposal for consideration by the PPRC at its twentieth meeting clarifying the scope of application of the full cost of adaptation reasoning criteria (Decision B.28/33).

At its twenty-second meeting, the PPRC discussed an update on the full cost of adaptation reasoning criterion, following which the Board decided to request the secretariat to prepare an analysis of the full-cost-of-adaptation-reasoning criterion (document AFB/PPRC.22/25), revised in accordance with the medium-term strategy implementation plan contained in the Annex I to document AFB/B.31/5/Rev.1 and considering the views of governments of developing countries and relevant stakeholders of the Adaptation Fund on the issue, and to submit the analysis to the PPRC at its twenty-fourth meeting (Decision B.31/23)

Document AFB/PPRC.24/5 responds to Board decision B.31/23.

Action expected: The PPRC will be invited to discuss the document and to form a recommendation to be forwarded to the Board.

## 7. Report on the intersessional review cycle for readiness grants
