Adaptation Fund National Implementing Entities (NIEs) discuss findings from projects that benefit and empower the most vulnerable communities such as women, youth, the elderly, and indigenous populations, and incorporate local and traditional knowledge.

When Parties decided at COP24 that the Adaptation Fund (AF) “shall serve” the Paris Agreement (PA), they recognized the wide recognition and demand for AF’s concrete, tailored adaptation actions to support the most vulnerable and its pioneering Direct Access modality that builds national capacities to adapt to climate change.

Since the Fund started serving the PA on January 1, 2019, it is helping to operationalize it. Even prior to that it was contributing to the goals of the Agreement through its concrete adaptation actions on the ground for the most vulnerable countries. Its [5-year strategy](#) aligned with the PA & UN Sustainable Development Goals further accelerates action and fosters innovation, [learning and sharing](#), while empowering the most vulnerable and promoting gender-responsiveness.

AF leaders, country implementers, governments and CSOs will provide concrete examples during the side event.
