Background: Recognizing the extraordinary circumstances and challenges due to the outbreak of the novel coronavirus COVID-19 which have prevented organization of face-to-face meetings of the Adaptation Fund Board (the Board) and its two committees, as well as the need for the Adaptation Fund to continue serving its mandate, the Board in its Decision B.35.a-35.b/39 *Approval of Ad Interim Review Process to Consider First Time Submission Proposals and Small Grant Proposals in an Intersessional Project Review Cycle* decided to:

(b) Organize an Ad Interim Review Process, as described in document AFB/B.35.a-35.b/15, in order to discuss and consider such proposals that have been submitted to be considered at the thirty-fifth meeting of the Board originally scheduled for March 31st-April 3rd, 2020 and the second part of the thirty-fifth meeting of the Board, originally scheduled for 23-26 June 2020, and that are not eligible for being considered in accordance with the regular intersessional review process following decisions B.23/15 and B.25/2.

During the current intersessional review cycle, which was named the intersessional period between the first and the second sessions of the thirty-fifth meeting of the Board (AFB35.a-35.b), 18 proposals were processed and the decisions taken on the affirmative no-objection basis. In line with the Decisions B.25/2 and B.34/50, this did not include first submissions of concrete project/programme proposals and proposals for small grants previously submitted for AFB35 (originally scheduled for March/April 2020) or AFB35.b (originally scheduled for June 2020), neither of which could take place due to COVID-19.

There are currently 23 concrete project/programme proposals that have been processed and technically reviewed by the secretariat that could not be presented to the PPRC and Board through the regular intersessional review process. Of these 23 proposals, 15 proposals are eligible to be processed by the Board through its regular intersessional review process. The remaining nine proposals are first-time submissions and are thus presented during the *Ad Interim Review* process.

The report contained in document AFB/PPRC.26.a-26.b/22 (Part II) presents a summary of 23 concrete project/programme proposals, including the nine first-time submissions under consideration at this Virtual Meeting of the PPRC. The nine first-time submissions include eight single-country proposals, of which two are fully-developed proposals and six are concept notes. There is one first-time submission of a regional proposal as a concept.
