REPORT ON ACTIVITIES OF THE SECRETARIAT AND AF-TERG SECRETARIAT

Background

1. This report lists the activities undertaken by the Adaptation Fund Board Secretariat (the secretariat) and the Adaptation Fund Technical Evaluation Reference Group (AF-TERG) secretariat during the period of 12 months between the thirty-fourth in October 2019 and the second part of the thirty-fifth meetings of the Adaptation Fund Board (the Board) in October 2020. Typically, under normal circumstances, the report covers a period of six months between two Board meetings. Due to the COVID-19 pandemic, the physical Board meetings scheduled earlier in 2020 were cancelled and hence no report was published in the interim.

Finalization and posting of the report of the thirty-fourth and thirty-fifth meetings

2. Following the thirty-fourth meeting held in Bonn, Germany on 8-11 October 2019 and the first session of the thirty-fifth (procedural) meeting held virtually on 2 April 2020, the secretariat supported the respective Chairs who had presided over those meetings, in finalizing the reports of the meeting. As agreed by the Board, the reports were completed and circulated to Board members and alternates for comments and approval. The Board approved the reports and they was posted on the website of the Adaptation Fund (the Fund) as documents AFB/B.34/20 and AFB/B.35.a/3.

Events and meetings

3. During the reporting period, the secretariat participated in, and presented at, the following events and meetings (excluding meetings of the readiness programme that are described in a separate section below).

- (a) International Symposium and High-level Event on Action for Climate Empowerment (ACE) (14-15 October 2019, Pamhagen, Austria): A member of the secretariat attended and participated in proceedings of two events to explore opportunities for collaboration and partnership with the UNFCCC's ACE and to raise awareness of the Fund's activities to donors and ACE country focal points present at the meetings.
- (b) 24th Meeting of the GCF Board (12-14 November 2019, Songdo, the Republic of Korea): A member of the secretariat attended the 24th Meeting of the GCF Board as observer. The work of the GCF discussed at the meeting included: strategic planning for 2020-2023; consideration of funding proposals; consideration of accreditation proposal; Updated Gender Policy and Action Plan 2020-2023; matters related to the formal replenishment of the GCF; Co-Chairs consultations on decision-making in the event that all efforts at reaching consensus have been exhausted and guidelines on decisions without a Board meeting; integrity policies; risk management framework; matters related to the accreditation framework.

(c) Madrid Climate Change Conference (the twenty-fifth session of the Conference of the Parties (COP) to the United Nations Framework Convention on Climate Change (UNFCCC) (COP 25), the fifteenth session of Conference of the Parties serving as the meeting of Parties to the Kyoto Protocol (CMP 15), and the second session of the Conference of the Parties serving as the meeting of Parties to the Paris Agreement (CMA 2), 2-13 December 2019, Madrid, Spain): The manager and members of the secretariat participated in the meeting and supported the Chair during the negotiations on the agenda item of CMP and CMA related to the Adaptation Fund. The secretariat also supported the Chair in presenting the Fund's work in a panel discussion as part of the technical part of the stocktake on pre-2020 implementation and ambition, in the signing event of the Declaration for the Alliance for Hydromet Development organized by the World Meteorological Organization (WMO), and in the signing event of a regional adaptation project. The secretariat organized several well-attended side events, including one on the topic of innovation in adaptation. Another side event was organized to launch the new virtual course on project preparation and design and accreditation, along with case studies drawn from the accreditation and re-accreditation process. The secretariat also organized two similar events where the same knowledge tools were launched for the Frenchspeaking and Spanish-speaking audiences; the French-speaking event was organized together with the Institut de la Francophonie pour le développement durable (IFDD). Additionally, the secretariat organized a side event with the theme of gender and climate change, titled "Advancing Gender Equality and Women's Empowerment in Climate Finance" among the three climate funds including the Adaptation Fund, Global Environment Facility (GEF) and Green Climate Fund (GCF), which was the first of its kind. and a second French-speaking side event with the IFDD on the topic of "Financing resilience through the instruments of the Adaptation Fund - experiences of implementing entities". The secretariat and the Vice-Chair presented the Fund's work in a press conference announcing a suite of new knowledge, innovation and scale-up tools. The manager of the secretariat participated in as a panelist in Technology Mechanism side event on the topic "Delivering technological transformation to support countries in implementing the Paris Agreement", in a TERI side event "Accelerating adaptation action and knowledge to support action", in the launching event of the WMO report on the State of Climate Services and in a related press conference, and in the GCF Independent Integrity Unit side event "Best practices and join actions to strengthen results and integrity across trust funds". The secretariat participated in a side event organized by member organizations of the Adaptation Fund NGO Network on the topic of "How to effectively channel adaptation finance to those most vulnerable to climate change", in a side event hosted by the Latin American Development Bank (CAF) aimed at presenting the projects approved by the Adaptation Fund to be implemented in Argentina, Chile, Ecuador and Uruguay, in a side event organized by WMO on "Science and Innovation in Support of Climate Action for the Poor and the Vulnerable", and in a UN-Habitat side event on "Building the climate resilience of the Urban Poor". The secretariat participated in the roundtable on coherence and coordination organized by the Paris Committee on Capacity-Building (PCCB) at the Capacity-Building Hub. The secretariat hosted a side-event for the Community of Practice for Direct Access Entities (CPDAE) in partnership with the GCF.

The Chair and the secretariat launched the first issue of the bulletin by providers of readiness and capacity-building support for adaptation in partnership with the Climate Technology Centre and Network (CTCN) and PCCB. The bulletin provides information from a range of organizations providing readiness and capacity-building support to developing country Parties to the UNFCCC, Kyoto Protocol and Paris Agreement, and includes information on the type of readiness and capacity-building support available and how Parties can access the support. The secretariat also presented the Fund's work at the Koronivia workshop on the topic of "Improved nutrient use and manure management towards sustainable and resilient agricultural systems". The secretariat, together with the Chair, participated in the third annual dialogue of Climate Finance Delivery Channels organized by the GCF. In addition, the secretariat arranged a successful contributor dialogue, featuring a number of distinguished opening speakers, including the President of COP 25, Minister of Environment of Chile, H.E. Ms. Carolina Schmidt, Minister of Climate and Environment of Norway, H.E. Mr. Ola Elvestuen, Deputy Executive Secretary of the UNFCCC, Mr. Ovais Sarmad, the Chair of the Board, among others. The secretariat also had several meetings with ministers and heads of delegations from both contributor and recipient governments and met with applicant National Implementing Entities (NIEs) in relation to the ongoing accreditation and re-accreditation process as well as with new potential applicants. The secretariat hosted a multimedia exhibit on innovation and youth engagement at the conference and handed out informational materials. The manager of the secretariat participated in video interviews by Climate Home News and Climate Action Studio, promoting the Fund's work.

- (d) 57th meeting of the GEF Council (17-19 December 2019, Washington, D.C., United States): the manager of the secretariat presented the amended and restated memorandum of understanding between the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol and the Council of the GEF regarding secretariat services to the Adaptation Fund Board, which had been adopted by CMP 15, to the Council for its consideration. The Council approved the memorandum of understanding.
- (e) 10th Session of the World Urban Forum (9 13 February 2020, Abu Dhabi, United Arab Emirates): A member of the secretariat attended the 10th Session of the World Urban Forum (WUF10) as speaker and participated in several panel discussions and networking sessions showcasing the Fund's work on urban resilience and innovative financing modalities for local-national collaborations in the area of climate finance. A flagship initiative was launched for building up the climate resilience of the urban poor.
- (f) Alliance for Hydromet development and Systematic Observations Financing Facility (SOFF) workshops (25 26 February, Offenbach, Germany): As a founding member of the Hydromet Development Alliance signed at COP 25, the secretariat was invited to participate in the two events organized by the World Meteorological Organization. The SOFF meeting discussed the proposed SOFF facility as part of the joint commitment of the alliance members that is expected to provide equitable, predictable, sustainable, and

performance-based finance to achieve and maintain global basic observations network; and which contributes to maximize adaptation benefits for developing countries. In addition, the secretariat attended a meeting of the Alliance for Hydromet Development members, to discuss the Alliance principles and 2020 actions plan including the design of the SOFF. The meetings were attended by the following organizations: World Bank, UNDP, UNEP, UK Met Office, InsuResilience, DWD, GEF, GIZ, DFID, and remotely by GCF, IsDB, EBRD and IaDB.

- (g) NDC Partners Consultation meeting (27-28 February 2020, New York): The manager and a member of the secretariat represented the Fund where the manager participated in a panel discussion on "Accelerating technical assistance and capacity development for investment readiness".
- (h) 25th board meeting of the Green Climate Fund (10-12 March 2020, Geneva, Switzerland): A member of the secretariat participated in the meeting as observer. Considering the extraordinary circumstances imposed by the COVID-19 pandemic and on an exceptional basis, the 25th meeting of the GCF Board initially scheduled to take place from 10-12 March 2020 in Songdo, Incheon, Republic of Korea was moved to Geneva, Switzerland during the same period. The meeting was chaired by new Co-Chairs Mr. Nauman Bhatti of Pakistan and Ms. Sue Szabo from Canada, who represent the developing and developed country constituencies, respectively. The meeting approved a total of six new funding proposals and considered several policy matters including the updated GCF strategic plan for 2020-2023 which was not approved at this meeting. Other important matters include among others a review of the simplified approval process pilot scheme, approval of two new national Direct Access Entities and an upgrade in the scope of accreditation of an already accredited national Direct Access Entity, annual guidance from the COP to the UNFCCC and a contingency planning of GCF in the context of the covid-19 pandemic. The meeting did not discuss any item related to cooperation with the Adaptation Fund including the strategic discussion under the operational framework for complementarity and coherence.
- (i) 17th meeting of the Adaptation Committee (24-27 March 2020, Virtual): A member of the secretariat participated in the meeting as observer. During the meeting the following items were discussed: (i) Adaptation Communications; (ii) Methodologies for assessing adaptation needs; (iii) The Global Goal on Adaptation; (iv) Information collection and preparation for the Global Stocktake; and (v) Modalities for recognizing the adaptation efforts of developing country Parties. The Adaptation Committee (AC) and observers exchanged views on different items discussed and the AC members agreed to continue working in the inter-sessional period until the next meeting (which will take place from 9 to 12 November 2020).
- (j) Adaptation Futures 2020 Pre-Conference Webinar Series: "Adaptation with a Human Face" (28–30 April 2020, Virtual): the manager of the secretariat provided welcome remarks for the Day 2 session of the webinar co-hosted by TERI and the World Adaptation Science Programme, referring to the local and human-centered activities of the Fund.

- (k) Responding to the COVID-19 Pandemic Economic Crisis: Building Back Better Aligned to the SDGs and the Paris Agreement (4 May 2020, Virtual). The manager of the secretariat presented the Fund's work in Dialogue 2 of the webinar with the theme "Toward Recovery and Long-term Resilience" co-hosted by the Federal Environment Ministry of Germany and the World Resources Institute.
- (I) Dialogue between grassroots organizations and donors on locally-led actions webinar (21 May 2020, virtual) co-hosted by the Adaptation Fund in collaboration with WRI/Global Commission on Adaptation and Climate Wise Women: A member of the secretariat joined the meeting as a speaker and presented the Adaptation Fund's work on locally led actions including the EDA projects and other initiatives.
- (m)A webinar on building resilience in the agriculture sector in Africa in the light of the COVID-19 pandemic (28 May 2020, Virtual): The secretariat and its partners shared experience from the project implemented by Sahara and Sahel Observatory (OSS) in Uganda.
- (n) June Momentum on Climate Change Effective Delivery of Needs-based Climate Finance Virtual Special Event (4 June 2020, Virtual): The manager of the secretariat joined a panel discussion on the double threats of climate change and COVID-19 and presented how the Fund's works supports broad-based resilience.
- (o) "Panama on the road to climate change adaptation" webinar (18 June 2020, Virtual) hosted by Fundación Natura, Panama: Two members of the secretariat participated in the meeting as speakers where they gave a general overview of the Fund including the MTS funding windows and a presentation of the Readiness and capacity building program of the Fund.
- (p) Fourth meeting of the Paris Committee on Capacity-Building (PCCB), held virtually (22–25 June 2020). Two members of the secretariat participated in the PCCB meeting sessions which included: Technical support and guidance on building climate-related capacity; Awareness-raising, outreach and knowledge- and information-sharing; the Informal Coordination Mechanism (ICM) of the PCCB; and Development of a workplan for 2021–2024. In addition, on 23 June the representatives from the secretariat joined UNFCCC Constituted Bodies, Operating Entities representatives and PCCB members in a Roundtable on Coherence and Coordination of Capacity-Building under the Convention.
- (q) Virtual inaugural meeting of the PCCB Network (26 June 2020): A representative of the secretariat participated in the meeting and provided content of the Fund's capacitybuilding activities for the Newsletter of the Network. The PCCB Network was established by the PCCB to become a leveraging platform to enhance coherence and coordination of climate-related capacity-building initiatives and activities, foster the engagement of relevant stakeholders in such efforts, draw expertise from a broad range of members in identifying gaps and needs of developing countries, and facilitate access to information and knowledge on capacity-building to support climate action.

(r) "Stepping-Up Knowledge Exchange between Climate Adaptation Knowledge Platforms (KE4CAP)" webinar (30 June 2020, Virtual) hosted by University of Oxford and Stockholm Environment Institute: A member of the secretariat participated in the meeting as observer where opportunities were explored to how climate adaptation platforms can contribute to national plans and strategies and how they can help in promoting informed decisionmaking and climate action.

- (a) Webinar entitled "Adaptation Fund Engagement Pathways: First Steps for Women's Organization" hosted by Women's Environment & Development Organization (WEDO) (8 July 2020, Virtual): two members of the secretariat were invited and participated as speakers in the webinar, presenting the Fund's gender work and recently launched elearning and engaging discussions with the participating women's groups and organizations.
- (b) Webinar entitled "Adaptation Fund Projects in South and Southeast Asia: Insights from CSO Perspectives" co-hosted by Adaptation Fund NGO Network, Development Alternatives, Climate Action Network South Asia (CANSA) and Climate Action Network Southeast Asia (CAN) (14 July 2020, Virtual): a representative of the secretariat was invited to share the Fund's perspective regarding the Fund's experiences and views on the value of the CSO engagement with the Fund.
- (c) Water and Climate Coordination Climate Finance webinar (23 July 2020, Virtual) organized by Global Water Partnership (GWP) in partnership with UNDP-Cap-Net, Alliance for Global Water Adaptation (AGWA) and Stockholm International Water Institute (SIWI): A representative of the secretariat participated in the event and gave a presentation at the event. The webinar highlighted climate and water inter-linkages, coordination across climate and water decision-makers during implementation and climate finance opportunities.
- (d) Launch of the French version of the E-Learning Course on Direct Access Designed to Help Countries and Stakeholders Unlock Climate Finance (21 July 2020, Virtual) coorganized by the *Institut de la Francophonie pour le Développement Durable (IFDD)* and attended by more than 600 participants from French speaking countries. The Secretariat presented the course by providing an overview of the Adaptation Fund (the Fund) accreditation process and the Environmental, Social and Gender considerations in project design and implementation.
- (e) "Adaptation Fund: Innovation for Adaptation to Climate Change" event at the World Water Week (25 August 2020, Virtual). This event was organized by the secretariat and it included presentations and a discussion by representatives of the AF-funded UNDP Aggregator for Innovation, a representative of a NIE and a CSO, as well as the secretariat.

Preparations for the thirty-fifth Board meeting

Meeting arrangements

- 4. The secretariat issued letters of invitation to the Board meeting originally scheduled on 31 March 3 April 2020 in Bonn, Germany to the Board members and alternates and made travel arrangements for eligible Board members. Due to the development of the coronavirus (COVID-19) pandemic and the decision by the Board to hold a procedural virtual meeting, the secretariat canceled the arranged travels and changed the arrangements to organize the virtual (procedural) meeting (the first session of the thirty-fifth meeting) on 1 April 2020.
- 5. Following the Board's decision to hold the second part of the thirty-fifth meeting in Bonn, Germany on 23-26 June 2020, the secretariat made a reservation of conference rooms for physical meeting but cancelled it when it became evident that it was not possible to hold that meeting as planned.
- 6. The secretariat made arrangements for another Board meeting in a virtual format (the second session of the thirty-fifth meeting) to take place in October 2020.

Meeting documents

- 7. The secretariat, working closely with the Board Chair and the Committee Chairs and Vice-Chairs, and the trustee, was preparing the documents for the thirty-fifth meeting of the Board and for the twenty-sixth meetings of the Project and Programme Review Committee (PPRC), and of the Ethics and Finance Committee (EFC), which were supposed to be discussed by the Board on 31 March 3 April 2020. Due to the cancellation of the meeting on a physical format, the documents were not published.
- 8. Following consultation with the Chair and Vice-Chair of the Board, some of the pressing agenda items among the documents prepared for the meetings in March 2020, such as project proposals, work plans and administrative budgets for FY21 were presented to the Board for consideration intersessionally. The secretariat consulted with the Chair and Vice-Chair on a short list of prioritized agenda items to be taken up at the second session of the thirty-fifth meeting of the Board and the twenty-sixth meetings of the Board committees in October 2020.

Implementation of decisions adopted by the Board at its thirty-fourth meeting and during the ensuing intersessional period

Secretariat

The designation of Regional Implementing Entities and Multilateral Implementing Entities

12. In line with Decision B.34/2, the secretariat prepared a document which contains an analysis on how to classify IE applicants as MIE or as RIE taking into account relevant Board discussions on designation of Multilateral Implementing Entity (MIE) and RIE at its twenty-third and twenty-fourth meetings as recorded in documents AFB/B.23/7 and AFB/B.24/7. This document was initially supposed to be presented for consideration at the twenty-sixth meeting of the Ethics and Finance Committee (EFC) scheduled for 15-16 October 2020. However, owing to lack of time, the document was not submitted to the twenty-sixth meeting of the EFC.

Implications of an implementing entity's accreditation expiration and a possible revision of reaccreditation policy

13. The secretariat communicated the decision on the revised re-accreditation process and the revised standard legal agreement to the implementing entities. (Decision B.34/3)

Annual performance report (APR)

14. The secretariat prepared and published a summarized version for the general public in a reader friendly format on the Fund's website, following the approval of the APR by the Board. (Decision B.34/43)

Revision of the results tracker and an updated guidance on the revised results tracker

15. The secretariat made available the amended PPR template and the results tracker guidance document on the Fund's website; and revised the Draft Guidance to Complete PPRs as contained in document AFB/EFC.9/4/Add.1, to align it with the new PPR template and circulated it for intersessional approval by the Board between the Board's thirty-fourth and thirty-fifth meetings (Decision B.34-35/20).

Further analysis of project inception delays

16. The secretariat revised the Policy for Project/Programme Delays by reflecting the changes as referred to in subparagraphs a) and b) of Decision B.34/45, and presented the Updated Policy for Project/Programme Delays for intersessional approval by the Board between its thirty-fourth and thirty-fifth meetings (Decision B.34/45). Subsequently, the updated policy was approved by the Board (Decision B.34-35/12).

Assessment of the accreditation standards of the Green Climate Fund, including a gap analysis

17. The secretariat initiated discussion with the GCF secretariat with a view to facilitating the exchanges between the accreditation panels of the two funds; and assessed, in collaboration with the Accreditation Panel, the GCF accreditation standards, including a gap analysis when the need arises, given the continuing evolution of the GCF accreditation process and related policies. (Decision B.34/46)

Strategic discussion on objectives and further steps of the Fund. Potential linkages between the Fund and the Green Climate Fund

18. The secretariat gathered available information related to the legal analysis on arrangements between the GCF and the Fund, which was received from the GCF secretariat, to report to the Board at its thirty-fifth meeting; and continued discussions with the GCF secretariat to advance the collaborative activities identified at the Annual Dialogue in November 2017, the Technical Workshop in February 2018 and the informal meetings between the Chair and Vice-Chair of the AFB and the Co-Chairs of the GCF in May and September 2018 and at the margins of the of the twenty-fourth session of the Conference of Parties to the United Nations Framework Convention on Climate Change (COP 24) held in Katowice, Poland. (Decision B.34/47)

Late-stage withdrawals of proposals by multilateral implementing entities

19. The secretariat prepared a response to the letter dated 10 October 2018, from the Multilateral Development Banks (MDBs), namely the African Development Bank (AfDB), the Asian Development Bank (ADB), the Inter-American Development Bank (IADB) and the World Bank, containing a summary of the Board's discussion on this matter during its thirty-fourth meeting and, having been signed off by the Chair of the Board sent it to the MDBs on behalf of the Board. (Decision B.34/48)

Issues arising from fourteenth session of the Conference of the Parties serving as meeting of the Parties to the Kyoto Protocol (CMP 14), and the third part of the first session of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA 1-3)

20. The secretariat prepared the Board's report to the CMP and the addendum at its fifteenth session, which contained the Board's recommendation to the CMP that: (1) the CMP adopt the amendment of the Terms and Conditions of the trustee services to be provided by the World Bank as interim Trustee (T&Cs) at the fifteenth session for the timely extension of the arrangement for the trustee services beyond May 2020; and (2) the CMP adopt the amendment of the institutional arrangement (MoU) with GEF for Secretariat services to the Board at the fifteenth session for the timely extension of the arrangement for the secretariat services beyond May 2020. The Board's report to the CMP at its fifteenth session also included: (1) the summary of the Board's consideration of the Rules of Procedure of the Adaptation Fund Board as contained in document AFB/B.34/9/Add.4 in the addendum to the Report of the Board to the CMP at the fifteenth session; (2) the summary of the Board's consideration of the matter of 'Implications of the Fund receiving the share of proceeds from activities under Articles 6, 12 and 17 of the Kyoto Protocol when the Fund serves the Paris Agreement' and 'any other matter so as to the Fund serves the Paris Agreement smoothly'; (3) the 'Board's recommendations for actions to be taken by the CMP' at its fifteenth session as contained in document AFB/B.34/9/Add.6; and (4) the Board's invitation to the CMP and/or the CMA to provide guidance on the issue of 'the Parties eligible for funding from Adaptation Fund' as referred to in paragraph 1 of decision 1/CMP.3, which is reflected in paragraphs 10 and 5 of the Adaptation Fund's Strategic Priorities, Policies and Guidelines (SPPG) which was adopted by Decision 1/CMP4. At CMP 15, Parties discussed the report by the Board and, in decision 3/CMP.15, took note of it. CMP 15 adopted the amended and restated terms and conditions of services to be provided by the World Bank as an interim trustee of the Adaptation Fund and the amended and restated memorandum of understanding between the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol and the Council of the GEF regarding secretariat services to the Adaptation Fund Board. Subsequently, the World Bank and the Council of the GEF approved the respective instruments. The secretariat prepared the report of the Adaptation Fund Board to the CMP at its sixteenth session and to the CMA at its third session, which was approved by the Board (Decision B.35.a-35.b/44).

Options to further enhance civil society participation and engagement in the work of the Board

21. The secretariat circulated the survey on the options provided in document AFB/B.34/11 to the Board from 27 January to 17 February 2020 and prepared a document which compiles

comments and input received from the Board. The presentation of the document has been postponed due to the cancellation of the physical Board meetings since March 2020.

Readiness Programme

22. During the reporting period, the secretariat implemented the following activities under the Readiness Programme¹:

Fiscal Year 2020

- (a) The ninth readiness webinar was held on 24 October 2019. The webinar discussed the topic: Evidence-based interventions Assessing vulnerability and feasibility for sustained local-level resilience: experiences and lessons learned from Adaptation Fund. The report of the webinar is available on the Fund website.
- (b) The secretariat launched and reviewed readiness grants for the 2019 calendar year. Three technical assistance grants for the environmental and social policy and gender policy (TA-ESGP) and two South-South cooperation (SSC) grants were approved intersessionally by the Board between its thirty-fourth and thirty-fifth meetings. These TA-ESGP were for the Environmental Management Agency (EMA) of Zimbabwe, the Ministry of Water and Environment (MoWE) of Uganda and the National Environment Management Council (NEMC) of Tanzania and the SSC grants were for Botswana and Mozambique.

Fiscal Year 2021

- a) The 2020 annual Climate Finance Readiness Seminar for accredited NIEs, was held as a virtual event from 1-3 September 2020. The seminar, which is a closed event for the Fund's accredited NIEs was attended by 27 of the 32 accredited NIEs and nearly 60 participants in total. Participants discussed best practice in sharing project successes, learning from responses to COVID-19, reaccreditation best practices, information on project scale-up, innovation & learning grants, and shared further learning through the Community of Practice for Direct Access Entities (CPDAE).
- b) Development and dissemination of the third issue of the bulletin by providers of readiness and capacity-building support for adaptation (1 September 2020). The bulletin is produced through a partnership between the Adaptation Fund, Climate Technology Centre and Network and the Paris Committee on Capacity-building under the UNFCCC and provides content on readiness and capacity-building support for adaptation from organizations delivering readiness and capacity-building to developing countries. The bulletin is widely disseminated to developing country Parties of the UNFCCC and Paris Agreement.

Communications

- The secretariat continued to raise significant awareness for the Fund's work, and extend 23. its audience reach by delivering a high volume of quality new content across diverse and emerging communications and news platforms. It developed new stories promoting Fund projects that have adapted and built resilience to the COVID-19 pandemic in creative ways and contributed to building broader resilience in vulnerable groups. The secretariat created and circulated 14 news releases on Fund programmes and news (nine from the current reporting period), two project stories on Antiqua and Barbuda and Lao People's Democratic Republic, , four stories with Climate Home News (two from the current reporting period, including on ecosystem-based adaptation, and various Fund projects such as Seychelles and Chile), three Flickr photo sharing albums, updated flyers including on Direct Access and Earth Day, and three videos (including one from the new reporting period depicting aerial footage of projects around globe, and others on projects in Antigua and Barbuda and Direct Access, gender and innovation). The partnership with Climate Home News helps expand audience reach to key targets and was extended. The Secretariat also translated four stories/brochures into Spanish and French, prepared flyers in support of virtual events, and distributed many e-news posts.
- 24. The steady flow of fresh content has continued to enhance the visibility of the Fund which has resulted in marked growth across platforms and helped generate media interest. From 12 October 2019 through 3 February 2020, website page views totalled 205,345while web users totalled 31,257, a 17 per cent increase. On Twitter, the Fund put out 193 tweets, Facebook had 11,393 likes, and LinkedIn was steadily growing with 846 followers. In particular, media visibility of the Fund has grown significantly. The Fund received at least 263 media mentions worldwide (157 in English, 60 in French, 46 in Spanish). The secretariat sent out 19 Constant Contact enews posts to Fund stakeholders to raise awareness of the Fund's work and events. During the new reporting period from April 1-June 30, social media was very active with 153 tweets posted and 332 new followers gained, garnering 218.9k impressions. LinkedIn grew to 1,048 followers. There were 25 media mentions about the Fund, with 23 in English and two in Spanish. The Fund's website had 153,407 page views and 22,533 users, and the average web user session duration went up by 30.32%. These collective digital, media and outreach activities reflect the secretariat's robust and expanding online communications presence across key platforms.
- 25. The secretariat had a strong presence at COP 25 in Madrid, Spain. A mini-website summarizing the Fund's activities and goals was published a month before the event and updated throughout it. Promotional post cards were developed and distributed with Quick Response (QR) codes directing users to the mini website and fostering the use of digital platforms over paper. A multimedia exhibit was developed featuring posters showing the Fund's work in innovation and youth involvement in projects. The exhibit also featured videos of the Fund's Country Exchange in Chile, and a project visit to Antigua and Barbuda that included interviews with beneficiaries, NIEs, government, COP 25, secretariat and project officials, and footage of innovative Fund projects. The Fund promoted a suite of new innovation, project scale-up and learning tools to help

developing countries further access climate finance via press releases and webcasts, as well as other events hosted by the Fund in French and Spanish through photo and social media coverage. A press conference was organized on these themes featuring representatives from implementing entities, the Board and Secretariat, and was well-received with more than 30 attendees. The secretariat participated in four video interviews at COP25 through media outlets such as UNFCCC's Facebook Live, Climate Action Studio, Climate Home News, and Chilean National Commission for the Environment (Conama). During COP 25, the secretariat diligently communicated with the public and stakeholders via on-site exhibit, meetings and events, the web and social media, four press releases, 117 tweets and 11 e-news messages. The Fund also contributed quotes to joint press releases on partnerships in gender, climate and hydromet services. The Fund's website received 32,069 page views during COP 25, a 36 percent increase from COP 24. The Fund received 101 media mentions during the conference (49 in English, 36 in Spanish, 16 in French), and the Secretariat distributed promotional pins, pens, stories and flyers.

26. The secretariat regularly monitored media and social media, reposted project stories and relevant social media by Fund implementing entities, press and other stakeholders to amplify key messages, and kept website content fresh, working with IT services to help ensure the website is user-friendly. The Secretariat also organized a training to enhance presentation skills, tools and templates for Fund staff, which was well-received and has been applied on numerous occasions during the reporting period.

- 27. From July 1 to date, the Secretariat has developed and distributed four press releases, three videos (including an innovative approach utilizing 360-degree technology on a project in Antigua, and others focused on the Fund's ecosystem-based adaptation approaches, and Fund projects adapting and building broader resilience during the pandemic, such as in Costa Rica, Sri Lanka, India and others), one Climate Home News story focused on several projects funded by the Fund that are adapting directly to the Covid-19 pandemic in creative ways and building broader resilience to climate, environmental, health and economic risks.
- 28. The Secretariat continues to innovate and develop emerging communications products, including the 360-video and a related blog, two new podcasts as part of a new podcast series on 'Building Climate Resilience' focused on the Fund's programmes adapting and continuing to deliver to the most vulnerable during the pandemic, and new brochures on the Fund's emerging innovation programme, and a comprehensive Briefing Note on the Fund's overall programmes.
- 29. Website performance has done well so far in FY21, with 165,757 page views (12.33% increase from last year) and 23,505 users (24.42% increase from last year). The Fund has also put out 150 tweets, and received 368 new followers, reaching 147.7k impressions. Facebook has 11,455 likes and LinkedIn 1,191 followers. Media mentions grew, with 48 received to date (43 in English, 5 in Spanish).

Knowledge Management

Fiscal Year 2020

- 30. As part of the support offered to the CPDAE, the secretariat provided input to the design of the survey aimed at collecting project information from NIEs and Direct Access Entities supported by the Green Climate Fund for the quarterly news bulletin.
- 31. The secretariat completed the Spanish and French versions of the virtual learning course aimed at implementing entities seeking accreditation or re-accreditation with the Fund and accredited entities prepared to submit project proposals for funding. The French and Spanish versions, similar to the English one, are highly interactive, featuring various learning methods, case studies and guizzes and the user will be awarded a certificate of completion.
- 32. The secretariat completed the content of a study on "Local Leadership in Adaptation Finance" which offers an overview of locally-led adaptation actions and interventions in projects and programmes funded by the Fund, including case studies drawn from the Fund's portfolio so as to advance knowledge and learning among the implementing entities (IEs) and the wider climate adaptation community about institutional and individual capacity strengthening, modalities, and approaches for harnessing successful locally-led adaptation measures and strategies.
- 33. The secretariat also completed the content of a study on "Readiness and Capacity-building for Direct Access to Adaptation Finance" aimed at examining how readiness and capacity building for Direct Access are understood globally within the climate finance architecture, and how they are provided by the Fund and other environment and climate funds under the UNFCCC.
- 34. The secretariat completed the translation into French and Spanish of three case studies on addressing the Environmental and Social Policy in project proposals submissions.
- 35. The secretariat has continued to work intensely with IEs through remote or face-to-face bilateral meetings, including at COP 25, and more recently the Fund's 2020 Global Annual NIE Seminar on providing more clarifications on learning grants and activities eligible to be funded under this funding window.

- 36. The secretariat completed and released the graphic versions of the study on "Local Leadership in Adaptation Finance" and the study on "Readiness and Capacity-building for Direct Access to Adaptation Finance" mentioned above.
- 37. The secretariat is in the process of producing content for a virtual training course on learning grants aimed at enhancing the understanding of NIEs of learning grants requirements, activities eligible for funding and how to further develop the knowledge management and learning

component for learning grant application. The training course will first be available in English with plans to translate it into Spanish and French.

38. The secretariat is in the process of working towards the structure and content of a knowledge fair to be part of the virtual country exchange hosted by CSE, Senegal including documenting lessons learned from NIEs around the topic of coastal zone management.

Accreditation

Fiscal Year 2020

- 39. The secretariat has continued to work intensely with potential applicants, ongoing applicants, and implementing entities through remote or face-to-face bilateral meetings, including COP 25, and more recently the Fund's 2020 Global Annual NIE Seminar held virtually. The direct approach to problem solving through ongoing conversations with entities has been highly appreciated by all the applicants and potential applicants. The secretariat's facilitation of ongoing interactions between the Panel and the entities to resolve pending issues in the applications has helped improve efficiency and effectiveness of the accreditation and reaccreditation process.
- 40. During the reporting period, the secretariat has intensified work on knowledge sharing with regard to accreditation and direct access. The secretariat has worked closely across teams to finalize content materials for the first *e-learning* course on accreditation and project preparation which was launched at COP 25 and is now available in English, French and Spanish. The secretariat has sent out invitations to NIE focal persons and Designated Authorities, to complete the e-learning course.
- 41. The secretariat worked closely with the Chair and Vice-Chair of the Accreditation Panel (the Panel) and assisted the Panel in its deliberations. The thirty-third meeting of the Panel was held on 6-7 February 2020, in Washington, D.C., USA.

Fiscal Year 2021

42. The Panel held its thirty-fourth meeting, for the first time, in a virtual manner on 9-10 September 2020. For the meeting, , the secretariat had received three new complete accreditation applications for 2 potential NIEs and 1 potential MIE The Panel has continued reviewing 12 reaccreditation applications (6 NIEs, 1 RIE and 5 MIEs) and 13 accreditation applications of 9 potential NIEs, 3 potential RIEs and 1 potential MIE that were previously reviewed but required additional information for the Panel's review. At its thirty-fourth meeting, the Panel held discussions on: (a) the review of Section 10.b of the application form, related to applicant institution's anti-money laundering and countering the financing of terrorism (AML/CFT) internal controls, as part of the re-accreditation process as per AF Board Decision B.34/3; (b) possible process for Panel's review upon the request (to be made before re-accreditation) of re-evaluation of conditions attached to the accreditation of Implementing Entities under the streamlined process; (c) the efficiency and effectiveness of the review of individual accreditation/re-accreditation applications, including (i) the length of both the Report to the Panel and the length

of the Note to the Board; (ii) the content of both reports; and (iii) the characteristics and modalities of the comments to be raised by Panel members on draft reports submitted for review; and (d) the issue of the IE's/Applicant IE's High-level Environmental and Social Policy (ESP) and Gender Policy (GP) commitment letter which is a requirement for accreditation and re-accreditation with the Adaptation Fund. During the intersessional period, the Board accredited the General Directorate of Sectoral and Special Programs and Projects (DIPROSE) of the Ministry of Agriculture, Livestock and Fisheries of Argentina (MAGyP), successor entity of the Unidad para el Cambio Rural (UCAR) of Argentina as NIE; accredited the Interprofessional Fund for Agricultural Research and Advice (FIRCA) of Côte d'Ivoire as NIE; accredited, using the fast-track process, the World Food Programme (WFP) as MIE, the Food and Agriculture Organization (FAO) as MIE and the Corporación Andina de Fomento (CAF) as RIE; and re-accredited the United Nations Human Settlements Programme (UN-Habitat) as MIE of the Fund. Screening/technical review of project/programme proposals

- 43. In preparation for the thirty-fifth Board meeting in March-April 2020, the secretariat screened and prepared technical reviews of 19 fully-developed single-country project documents and six single country concepts, as well as three regional fully-developed project documents and one regional project concept. In addition, the secretariat screened and technically reviewed three innovation small grant proposals and one learning small grant proposal. In performing these tasks, the dedicated team of officials of the secretariat was supported by GEF Secretariat technical staff, and seven contracted technical experts, including ones with environmental and social expertise.
- 44. Furthermore, as the March-April meeting could not take place as planned, all the eligible submissions were subsequently processed using the normal intersessional review process. Additionally, the secretariat developed an *Ad Interim* intersessional project and programme review process in order to allow processing of projects and programmes that are otherwise ineligible for the normal intersessional review. Furthermore, an additional review cycle (corresponding to the usual summer intersessional review cycle) was initiated and subsequently completed on 23 September 2020.
- 45. In total, including the submissions for the March-April meeting and not including submissions for the October 2020 Board meeting, 45 submissions were considered over the two

review cycles in the period since October 2019, Some of the submissions were for the same projects, submitted for both review cycles processed in the intersessional period between the first and second sessions of the thirty-fifth meeting of the Board. In terms of distinct projects, there were 23 single country project proposals, seven regional project proposals, three small-grants for innovation proposals and one learning-grant proposal that were submitted. Of those, 17 and three, respectively, were fully-developed projects. All 23 single country project proposals, seven regional proposals, three small grants for innovation and one for learning completed the full review process during the intersessional project/programme review period. Some of the project proposals were submitted twice.

Review of Project Performance Reports (PPRs)

- 46. Following the Board Decision B.28/47 at its twenty-eighth meeting to delegate to the secretariat its authority to approve technical review and clearance of the PPRs prior to authorization by the Chair of the cash transfer of funding tranches, the secretariat has completed the review and cleared:

Gender

- 48. The Fund's Gender Policy (GP) indicates under the section of 'review and revision' that "the gender mainstreaming approach of the Fund's gender policy is a long-term undertaking demanding a sustained commitment and a regular tracking of its progress. As experience is gained and lessons learned in the implementation of the gender policy throughout the Fund's operations, the Fund as a learning institution might adjust its approach. In light of this, the Fund will review its gender policy three years after it becomes operational." In line with the GP, with around three years of the implementation of GP and GAP, the secretariat started the process for the update of the Fund's GP and Gender Action Plan (GAP) in May 2019. The secretariat concluded the first phase of the process in September 2019, which is to conduct an overall review of the implementation of the GP and GAP to assess. The outcome of the first phase of the process consists of (i) assessment on the implementation of GP and GAP including the results of the tailored survey targeting the Fund's implementing entities, Board members and alternates, the secretariat, and the AF NGO Network/Civil Society Organizations (CSO); (ii) assessment on the need of alignment of GP and GAP with the Fund's Medium-Term Strategy; and (iii) analysis on other climate fund's practices related to gender. The outcome document of the first phase of the process for update of GP and GAP, "From Policy Mandate to Implementation: Assessment Report on Progress in Realizing the Mandate of the Adaptation Fund's Gender Policy and Gender Action Plan," was submitted as information document to the thirty-fourth meeting of the Board. Based on the assessment report, the draft of updated Gender Policy and Action Plan of the Adaptation Fund was prepared. The public call for comments on the draft of updated Gender Policy was launched in January 2020, and the comments were received from the Board members, AF-TERG, Designated Authorities, Implementing Entities, AF NGO Network, and other civil society organizations and partner organizations. The comments were considered and reflected in the updated Gender Policy and Action Plan which is proposed to be circulated for consideration by the Board intersessionally between the thirty-fifth and thirty-sixth meetings.
- 49. Among the Fund's knowledge products, the case study on gender in selected Fund projects and programmes was conducted to capture the lessons learned and identify challenges and opportunities relevant for improving the gender mainstreaming efforts of the Fund projects

and programmes. The case study "Assessing Progress: Integrating Gender in Adaptation Fund Projects and Programmes" was published in March 2020. The study offers an overview of gender in the projects financed by the Fund, including case studies drawn from the Fund's portfolio, so as to advance understanding among the IEs as well as generate and share knowledge on good practices and methodologies in promoting gender equality and women's empowerment in projects that will enhance project impact. As part of capacity-building efforts, a self-paced e-learning course on addressing environmental and social and gender considerations in project and programme design and implementation was developed and is now available in English, French and Spanish. This is expected to help enhance understanding of how to integrate gender considerations into the Fund's projects and programmes among the Fund's designated authorities, the IEs and IE candidates, as well as other Fund's stakeholders.

- 50. In line with the GAP, the secretariat is reviewing the draft Fund's Gender Score Card at the portfolio level to be used by the secretariat and report on to the Board as part of the Annual Performance Report (APR) as a way to monitor the gender policy implementation portfolio-wide by tracking and reporting annually on quality at entry of Fund projects and programmes and quality during implementation and at exit (both elements are incorporated in the PPR Template now).
- 51. In terms of collaboration and communication efforts on gender, the secretariat continued collaboration with other institutions, including the GEF, the GCF, UNFCCC Secretariat and the Climate Investment Funds, on exchanging knowledge and lessons learnt.
- 52. In the margins of the COP 25 in Madrid, the secretariat organized a COP side event with the theme of gender and climate change, in collaboration with the UNFCCC Secretariat and other climate funds including the Global Environment Facility (GEF) and Green Climate Fund (GCF), titled "Advancing Gender Equality and Women's Empowerment in Climate Finance", which was the first of its kind.

- 53. As part of collaboration and communication efforts on gender, the secretariat continued collaboration with the UNFCCC secretariat gender team, GEF and CTCN and other partner organizations in developing a roster of gender experts which could contribute to countries, communities and people enhancing their capacity on gender.
- 54. The secretariat collaborated with the Women's Environment & Development Organization (WEDO) in hosting the webinar entitled "Adaptation Fund Engagement Pathways: First Steps for Women's Organization" in July 2020. Two members of the secretariat participated as speakers in the webinar, presenting the Fund's gender work and recently launched e-learning and engaging discussions with the participating women's groups and organizations. The secretariat also provided support for the WEDO in developing a brief entitled "Engaging with the Adaptation Fund: First Steps for Women's Organizations." ⁴ The brief aimed at providing the latest information on

and outlining the Fund's specific opportunities for promoting and implementing gender responsive climate finance.

55. The updated Gender Policy and Gender Action Plan are in the process of finalization, and they are expected to be submitted intersessionally to the Board for consideration, together with a compilation of the public comments.

Resource mobilization

- 56. The Fund has continued to be very active in its effort to support activities related to Resource Mobilization both at the communication level and at a policy level. The secretariat has continued to have bilateral conversations with potential and ongoing contributors. In particular the secretariat has followed up with EU and the Trustee to finalise the disbursement of the EU pledge for contribution made in October 2018.
- 57. As per Board decision B.33-34/33, the secretariat communicated the approval of the Board on the engagement of the Fund in the 'Research Phase" of the "Corporate Air Passenger Solidarity (CAPS)" proposal to BVRio Institute and Oxford Climate Policy. The secretariat also reviewed the outcome of the Research Phase in view of the Fund's potential engagement in the 'Development Phase' and the 'Campaign Phase' of the CAPS Proposal in consultation with the Resource Mobilization Task Force, and submitted its review to the Board for its consideration.
- 58. The secretariat liaised with the United Nations Foundation (UNF) to transfer the financial donations received through the UNF's private donation route ("Donate Button"), which included the donations collected through the VISA's interactive social giving kiosk at COP 24.
- 59. In preparation of the Annual Donor Dialogue for COP 25/CMP 15 the secretariat has reached out to sovereign and sub-sovereign entities both in face-to-face meeting and through dedicated correspondence. The secretariat was also involved in the preparatory work of the *Third annual dialogue of climate finance delivery channels* with other climate funds in the margins of COP 25/CMP 15.
- 60. The secretariat supported the work of the Board's Resource Mobilization Task Force, by facilitating a virtual meeting of the Task Force on 17 June 2020, in which the topic of resource mobilization target for years 2020-2021 and a possible virtual pledging event were discussed. On the topic of resource mobilization target the secretariat prepared, in consultation with the Task Force, a proposal to be presented to the Board at the second part of its thirty-fifth meeting. The secretariat has also liaised with the UNFCCC secretariat and the incoming U.K. COP 26 Presidency in order to jointly explore possible activities.

Ad Hoc Complaint Handling Mechanism

61. The secretariat has been continuing the update on the information of the grievance mechanisms of the implementing entities of the Fund to be reflected on the Fund's dedicated webpage.⁵ The secretariat has not received any eligible complaint during this reporting period.

Technical Evaluation Reference Group (AF-TERG)

Fiscal Year 2020

- 62. From November 2019 to February 2020, the TERG Chair and TERG Members had a series of consultations with the Board Secretariat manager and staff to deepen understanding of the Fund's strategies, policies and position in the global climate finance architecture. Also discussed was how the AF-TERG will relate to the Board Secretariat through its three functions; evaluation, advice and oversight.
- 63. During that same period consultations took place with Board members, observers and implementing entities through online on-demand interviews, a survey and follow-up online interviews between TERG Chair, TERG Members and interviewees.
- 64. The AF-TERG prepared an internal document which contains the theory of change of the AF-TERG, being a working interpretation of what the function is about. This is an internal work in progress, for which the main points are included in the AF-TERG Strategy and Work Programme document (AFB/EFC.26.a-26.b/3) approved by the Board.
- 65. The AF-TERG also prepared an internal culture document which sets out the principles to optimize the contributions of our varied and strong individual capacities. Also this is an internal work in progress, for which the main points are included in the AF-TERG Strategy and Work Programme document (AFB/EFC.26.a-26.b/3).
- 66. The AF-TERG prepared a gap analysis of the current Evaluation Framework and terms of reference for review and revision of the Evaluation Framework, to feed into future revising.
- 67. Four consultants were hired in October 2019 to execute three studies feeding into the AF-TERG's work programme:
 - a) Two consultants were hired to execute an evaluability assessment of the Fund's projects and portfolio to explore the extent to which projects have in place structures, processes and resources capable of supporting robust monitoring, evaluation and learning (MEL);
 - b) A consultant was hired to execute an ex-post evaluation study to map the landscape of approaches currently being used and to develop a Fund-specific approach to conduct

- ex-post evaluations, five years after closure, with a focus on process, impact, sustainability and learning of funded projects and programmes;
- c) A consultant was hired to execute a study to identify and assess innovative MEL practices in the climate adaptation space, and to advice how innovative MEL approaches, processes and technological developments could inform innovation thinking and MEL practices in the Fund.
- 68. The three studies resulted in deliberative working papers which were not in line with the Fund's Open Information Policy (Annex VII of document AFB/B.21/8/Rev.1) published, given their nature and their main purpose to inform the development of the AF-TERG Strategy and Work Programme. In case of the evaluability assessment and the ex-post study the material is foundational and will feed into future work, which will at that point be published.
- 69. In collaboration with the Board Secretariat communications staff the AF-TERG secretariat staff developed a web-presence on the Fund's website that went live 27 November 2019.
- 70. The AF-TERG secretariat also developed a web presence on social media, covering the platforms Issuu, Instagram, LinkedIn, Twitter and YouTube. These channels will be more actively used once the AF-TERG branding exercise discussed below is completed.
- 71. A graphical editor was contracted to develop a logo for the AF-TERG and provided branding guidance. The new AF-TERG branding is presented at the thirty-fifth Board meeting.
- 72. AF-TERG Chair and AF-TERG members were requested to provide input and provided input on the draft updated Gender Policy of the Adaptation Fund, with a focus on the evaluability of the policy and gender action plan, completed by 14 January 2020. AF-TERG Chair and AF-TERG members also provided input on the draft updated Gender Action Plan of the Adaptation Fund, completed by completed by 12 February 2020.
- 73. TERG Secretariat coordinator and staff participated in the thirty-third Accreditation Panel meeting on 6 and 7 February 2020.
- 74. The AF-TERG prepared a document which contains its strategy, multiyear work programme and budget (AFB/EFC.26.a-26.b/3), which was presented by the AF-TERG Chair to the EFC for consideration during the intersessional period between the first and second session of the thirty-fifth meeting of the Board.
- 75. On June 4, 2020, the Board approved, through intersessional decision B.35.a-35.b/29, the strategy and work programme of the AF-TERG contained in Annex 1 of the document AFB/EFC.26.a-26.b/3. Through intersessional decision B.35.a-35.b/27 the Board approved the proposed two-year budget to cover the costs of the operations of the AF-TERG and its secretariat for fiscal years 2021 (FY21) and 2022 (FY22). The AF-TERG strategy and work programme takes a longer-term planning perspective covering FY21 to FY23 for the work items, and FY21 to FY22 budget-wise.

- 76. The approved multiyear work programme responds to the broad mandate and the three functions of the AF-TERG: evaluation, advisory and oversight. The work elements laid out in the work programme will be managed and implemented in three workstreams that broadly correspond to the three functions of the AF-TERG. The advisory and oversight functions will span the three workstreams, while the evaluation function is embedded in Workstream 1:
 - Workstream 1: Conducting Strategy and Programme Evaluations;
 - Workstream 2: Enhancing MEL Capacity and Tools;
 - Workstream 3: Co-generating Evaluative Knowledge and Insights.
- 77. The AF-TERG had a facilitated forward-looking year in review reflection session on 20 May 2020, resulting in a number of recommendations and the start of a prioritization exercise to improve internal work processes.

- 78. The AF-TERG Chair, Ms. Eva Lithman, stepped down 15 July 2020. TERG Member, Mr. Mutizwa Mukute took over as acting Chair and the process for the hiring of a new Chair was initiated, under the supervision by the Board's AF-TERG Recruitment Working Group, to be completed by the end of October 2020.
- 79. An annual implementation plan was developed to guide the implementation of the AFTERG work programme.
- 80. A first element of work after the approval of the AF-TERG strategy and work programme was the development of a terms of reference for the review and revision of the Fund's Evaluation Framework. The objectives are to: (1) identify and propose necessary revisions to the Fund's Evaluation Framework; and (2) produce a draft Evaluation Framework for the Fund to be presented to the EFC for its consideration with a view to its subsequent approval by the Board.
- 81. AF-TERG Member, Mr. Mutizwa Mukute became the TERG focal point for the reviewing and revision work and a senior consultant was hired in August 2020 to support the work. A data analyst is currently being hired to be part of the evaluation team.
- 82. Terms of reference was developed in August 2020 for the mid-term review of the Adaptation Fund Medium-Term Strategy. The mid-term review will ask if the Medium-Term Strategy is fit-for-purpose in the context of the Fund's mandate and for the era the world and climate financing are in today and for the future. The mid-term review will also track the implementation of the Medium-Term Strategy, so far, identifying progress and recommend to the Board, possible course confirmation or correction and suggestions to be incorporated into the development of the next Medium-Term Strategy.

- 83. AF-TERG Member, Mr. Claudio Volonte became the TERG Focal point for the mid-term review of the Medium-Term Strategy and a senior consultant was hired in October 2020 to support the work. A data analyst is currently being hired to be part of the evaluation team.
- 84. Two chapters in an edited volume are being developed as part of AF-TERG sharing and outreach. The edited volume is a follow-up on the Third International Conference on Evaluating Environment and Development, held in Prague, Czech Republic, in October 2019. One of the chapters will focus on the process of developing and applying an evaluability assessment framework, while the second chapter will focus on innovations in MEL of climate change adaptation. The launch of the publication is expected for July 2021.
- 85. A concise work update report (AFB/EFC.26.b/Inf.1) will be presented at the 26.b EFC meeting by acting Chair, Mr. Mutizwa Mukute, with a focus on completed and ongoing work.
- 86. The deliberative working papers resulting from the three studies were used to synthesize common challenges faced by the Adaptation Fund and adaptation evaluation practitioners. A document titled "Evaluating adaptation: common challenges identified across three commissioned studies" (AFB/EFC.26.b/Inf.2) will be presented at the twenty-sixth EFC meeting as information document, outlining five identified challenges and their implications for both Adaptation Fund stakeholders, and for the broader constituency of individuals and groups involved in the management and delivery of adaptation-focused MEL.
- 87. The development of a final evaluation review / synthesis is ongoing and aimed to be completed by November 2020. This will be the first quality review of final evaluations reports, complying with the requirement originally tasked to the EFC and Board Secretariat to assess the overall quality of final evaluation reports according to a set a criteria described in Guidelines for Project/Programme Final Evaluations (AFB/EFC.5/.5).
- 88. As part of continued co-learning a first consultation took place with the core members of the AF NGO Network, to be followed up with a wider consultation. A facilitated discussion is being planned for November with interested implementing entity stakeholders.
