 - Preparing the report of the Board to the CMP and CMA;
 - Launching the recruitment of a new Chair for the Technical Evaluation Reference Group (AF-TERG);
 - Writing letter to H.E. Carlos Manuel Rodriguez, Minister of Environment and Energy of Costa Rica, selected as CEO of the GEF, 3 June 2020;
 - Providing opening remarks in the virtual seminar organized with the *Institut de la Francophonie pour le développement durable* (IFDD) on 21 July 2020;
 - Writing letters to contributor governments: three letters to the Government of France, 21 September 2020;
 - Extending Board members' and alternates' terms as advised by UNFCCC COP Bureau;
