REPORT OF THE THIRTY-FOURTH MEETING OF THE ACCREDITATION PANEL

WORK OF THE ACCREDITATION PANEL

- 1. The Accreditation Panel (the Panel) continued its work reviewing both new and existing applications. For the first time, due to COVID-19-related challenges, the Panel held its thirty-fourth meeting in a virtual manner on 9–10 September 2020. The Chair of the Accreditation Panel Ms. Eleonora Cogo (Italy, Western Europe and Others) presided over the meeting.
- 2. For the thirty-fourth Panel meeting, the Adaptation Fund Board Secretariat (the secretariat) has received 3 new accreditation applications for 2 potential National Implementing Entities (NIEs) and 1 potential Multilateral Implementing Entity (MIE). The Panel has continued reviewing 12 re-accreditation applications (6 NIEs, 1 RIE and 5 MIEs) and 13 accreditation applications of 9 potential NIEs, 3 potential RIEs and 1 potential MIE that were previously reviewed but required additional information for the Panel's review. Four NIE candidates' applications have been dormant as of June 2020. Therefore, in accordance with Board Decision B.31/26, the secretariat sent the first letters of notification to the Designated Authorities (DAs) of two of the dormant NIE applicants informing them of the inactivity of the applicant entities on 25 June 2020. On the same date, the second and third letters of notification were also sent separately to the DAs of the two others dormant NIE applicants entities informing them of the inactivity of the applicant entities.
- 3. After considering the recommendations by the Panel, the Board had intersessionally approved during the period from 20 March 2020 to 1 October 2020: accreditation of the Interprofessional Fund for Agricultural Research and Advice (FIRCA) as NIE of Côte d'Ivoire (Decision B.35.a-35.b/2); fast-track re-accreditation of the World Food Programme (WFP) as MIE of the Fund (Decision B.35.a-35.b/8); fast-track accreditation of the Food and Agriculture Organization (FAO) as MIE of the Fund (Decision B.35.a-35.b/34); fast-track re-accreditation of the Corporación Andina de Fomento (CAF) as RIE of the Fund (Decision B.35.a-35.b/43); and re-accreditation of the United Nations Human Settlements Programme (UN-Habitat) as MIE of the Fund (Decision B.35.a-35.b/78).
- 4. As of the thirty-fourth meeting of the Panel,13 accreditation applications, comprising of 9 potential NIEs, 3 potential RIEs, and 1 potential MIE were under review by the Panel as per the following list. For purposes of confidentiality, the assigned code is used to report on the status of each nominated Implementing Entity's application.

GENERAL TRENDS




Figure 2. LDCs and SIDS among accredited NIEs





Figure 3. Accredited NIEs and RIEs by region

5. As at 1 October 2020, the total number of accredited implementing entities amounted to 51: 32 NIEs, 6 RIEs, and 13 MIEs (Figure 1). Among the 32 NIEs, there were 9 accredited NIEs that were from Least Developed Countries (LDCs) and 7 accredited NIEs that were from Small Islands Developing States (SIDS) (Figure 2). Out of the 51 accredited implementing entities of the Adaptation Fund (the Fund), 27 entities (53%) had been re-accredited: 12 NIEs, 4 RIEs and 11 MIEs. With respect to the geographic coverage of the 32 NIEs and 6 RIEs, 14 entities were from Latin America and the Caribbean, 15 were from Africa, 8 were from Asia-Pacific and 1 entity was from Eastern Europe (Figure 3).

Figure 1. Accredited Implementing Entities by type

The Panel's October 2019 list of residual questions was subsequently shared with the applicant on 31 July 2020. The applicant acknowledged receipt on 2 August 2020. As at the time of the AP34 meeting, no further updates have been received from the applicant.

The accreditation Panel review process resumed with the submission of some supporting documentations on 25 March and 13 May 2020. Following the secretariat's request for updates on 1 July 2020, the applicant replied on 7 July 2020 advising that the team is working towards obtaining internal approvals to recommence the accreditation process. On 15 September 2020, the secretariat shared with the applicant the Panel's updated list of outstanding information and documents. No further updates have been received from the applicant.

Upon review of the documents, the Panel updated its report and produced a list of further requests which was sent to the applicant on 31 August 2020. No updates have so far been received.

OTHER MATTERS

7. Discussion on the review of Section 10.b of the application form, related to applicant institution's anti-money laundering and countering the financing of terrorism (AML/CFT) internal controls, as part of the re-accreditation process as per AF Board Decision B.34/3: This discussion is related to the Panel's request for clarification on whether they should, in the process of reviewing fast-track re-accreditation applications, continue to look at elements of fraud, financial mismanagement and investigation function together with the policies and procedures related to AML/CFT or just focus on the three criteria listed in paragraphs 21 and 22 of the Re-accreditation Process approved by the Board (Decision B.34/3) at the 34th meeting in October 2019 (AFB/B.34/.5). The Panel suggested that a review be conducted by the secretariat to provide

further clarity on paragraphs 21 and 22, and the current practice for the Panel's review of fast-track re-accreditation applications to ensure the review is in line with Decision 32/36.

- 8. Discussion on possible process for Panel's review upon the request (to be made before re-accreditation) of re-evaluation of conditions attached to the accreditation of Implementing Entities under the streamlined process: This agenda item is related to the Fund's Streamlined Accreditation Process (Ref. Document AFB/EFC.16/7/Rev.1), and was intended to help the Panel understand two issues: (i) whether an entity initially accredited under the streamlined process can be considered for re-accreditation under the streamlined approach; and (ii) whether an entity initially accredited under the regular accreditation route can be considered for re-accreditation under the streamlined approach based on the Panel's assessment of the applicant's eligibility for the streamlined accreditation process. In line with paragraph 15 of Document AFB/EFC.16/7/Rev.1, the secretariat explained that the streamlined accreditation process was originally designed for accreditation. The Panel was of the view that it is up to the Board to consider and decide whether the streamlined approach can apply to re-accreditation application. The secretariat reiterated that the streamlined approach is linked to, among others, funding limitation and projects under implementation by the concerned IEs, and consequently maintained that any re-evaluation of conditions attached to the accreditation of IEs under the streamlined process should be country-driven and be based on the capacity of IEs to be assessed by the Panel.
- 9. Discussion on efficiency and effectiveness of the review of individual accreditation/re-accreditation applications: (i) the length of both the Report to the Panel and the length of the Note to the Board; (ii) the content of both of the reports; and (iii) the characteristics and modalities of the comments to be raised by Panel members on draft reports submitted for review: The Panel considered and discussed a request to improve the review process for accreditation and re-accreditation applications, with focus on the resizing of the reports to the Panel and the notes to the Board with a view to enhance efficiency and effectiveness of the review process; the essential content for both documents; and ways to ensure the efficient use of references and comments in the process of preparing the Panel reports. While these concerns were considered valid, some Panel members explained that there had been new accreditation/re-accreditation requirements by the Board such as AML/CFT requirements, which necessitated expansion in the scope of the Panel review: in light of this, it is difficult or not advisable to fix maximum page limits for Panel reports and notes to the Board. The Panel agreed that the discussion had been valuable and suggested they be guided by the substance of the documents as opposed to the quantity of the pages. It was also suggested that flexibility in the length and content of the Panel reports and notes to the Board be allowed on a case-by-case basis, mindful of the specific requirements for the review of the different types of accreditation and re-accreditation applications.
- 10. Discussion on the issue of the IE's/Applicant IE's High-level Environmental and Social Policy (ESP) and Gender Policy (GP) commitment letter which is a requirement for accreditation and re-accreditation with the Adaptation Fund: The purpose for this discussion was for the secretariat to brief the Panel on the common responses it had received from some applicant entities and relevant issues regarding the requirement to provide high-level statements

to abide by the Fund's ESP and GP. The secretariat reminded the Panel that the Board would consider the matter at the next AFB meeting.

11. The thirty-fifth meeting of the Accreditation Panel will be held on 3-4 February 2021, in Washington DC or virtually, depending on how the COVID-19 situation evolves.
