11. Programme on innovation: Large Grants Projects' call for proposals

Document: AFB/PPRC.27/28 <u>Operationalization of the large grants for innovation</u> (Funding Proposal template and review criteria).

Background: This document presents the Adaptation Fund Programme on Innovation: Large Grants Call for Proposals, as per the Medium-Term Strategy that was adopted by the Board in its thirtieth meeting which refers to support via grants of up to \$5 million. The Board approved through decision B.35.b/8 the process for providing funding for innovation through large grants to Implementing Entities (IEs) as described in document AFB/PPRC.26.b/16, including the proposed objectives, review criteria, expected grant sizes, implementation modalities, review process and other relevant features. Through the same decision, under subparagraph (c), the Board requested the secretariat to prepare the first Request for Proposals to IEs for US \$30 million to be launched by the first quarter of calendar year of 2021. In order to launch the large grants as mandated by Decision B.35.b/8, the secretariat has developed, and is submitting for approval, the application templates (Annex II), the review template (Annex III) and 'Instructions for Preparing a Request for Innovation Large Grants' (Annex IV), to accompany the 'Call for proposals for innovation large grant' presented in Annex I.

Action expected: The PPRC will be invited to take note of the report on the operationalization of the large grants for innovation contained in document AFB/PPRC.27/28 and to make recommendations to the Board if necessary.

12. Report on the Readiness Support Package Pilot

Background: The Board approved the readiness support package grant as a pilot as included in the workplan for the Readiness Programme for Fiscal Year 2018 at its twenty-ninth meeting in March 2017. Following completion of the pilot, this document presents an analysis of the pilot readiness package grant, including grant benefits and added value, challenges faced, and a proposed way forward regarding the Fund's financial support for NIE accreditation.

Action expected: The PPRC will be invited to take note of the report on the Readiness Support Package Pilot contained in document AFB/PPRC.27/29 and to make recommendations to the Board as necessary.

13. Report of the secretariat on the intersessional review cycle for readiness grants

Document: AFB/PPRC.27/30 <u>Report of the secretariat on the intersessional review cycle</u> for readiness grants.

Background: Three readiness grants were approved by the Board during the intersessional review period between the thirty-fifth and thirty-sixth meetings of the Board. The grants included two Technical Assistance Grants for the Environmental and Social Policy and Gender Policy (TA-ESGP) and one Technical Assistance Grant for the Gender Policy (TA-GP). This document presents an analysis of the review cycle for this intersessional period and presents a proposed way forward for increasing access to readiness grants.

Action expected: The PPRC will be invited to take note of the report of the secretariat on the intersessional review cycle for readiness grants contained in document AFB/PPRC.27/30 and to make recommendations to the Board if necessary.

14. Request for a change in project approval conditions

Background: The Board through Decisions B.30/24 and B.30/26 approved projects in Fiji and Solomon Islands implemented by the United Nations Human Settlement Programme (UN-Habitat) with approval conditions that required an updated Environmental and Social Management Plan (ESMP) be submitted to the Board no later than the date of submission of the first Project Performance Report (PPR). The updated ESMP for both projects is linked with the finalization of comprehensive climate change vulnerability and disaster risk assessments in the target cities and informal settlements to remove any unidentified subproject and reflect all environmental and social risks inherent with the identified adaptation activities. However, the IE has informed the secretariat that the condition of submitting an updated ESMP at the time of the first PPR is not in line with the approved projects workplan. The projects are unable to comply with the Board condition because specific activities to be undertaken in years two and three of the project implementation directly contribute to the finalization of the environmental and social and gender assessments which in turn would lead to the finalization of ESMP after year 3. In this respect, the IE has submitted a request for a change in the projects' approval conditions.

Action expected: The PPRC will be invited to take note of the documents for the request for a change in project approval conditions for the projects in Fiji (UN-habitat) and Solomon Islands (UN-Habitat), contained in documents AFB/PPRC.27/31 and AFB/PPRC.27/32, respectively and to make recommendations to the Board if necessary.

15. Report on the full cost of adaptation reasoning

Document: AFB/PPRC.27/3, Report on the full cost of adaptation reasoning

Background: At its twenty-second meeting, the PPRC discussed an update on the full cost of adaptation reasoning criterion, following which the Board decided to request the secretariat to prepare an analysis of the full-cost-of-adaptation-reasoning criterion (document AFB/PPRC.22/25), revised in accordance with the medium-term strategy implementation plan contained in the Annex I to document AFB/B.31/5/Rev.1 and considering the views of governments of developing countries and relevant stakeholders of the Adaptation Fund on the issue, and to submit the analysis to the PPRC at its twentyfourth meeting (Decision B.31/23). Document AFB/PPRC.27/4 was developed but was repeatedly deferred due to lack of time in the PPRC agenda. Given that the paper was originally prepared to be presented at the first Board after the approval of the implementation plan of the Medium-term Strategy (MTS), it does not include recent programmatic developments of the Fund. Moreover, since then, a growing number of proposals submitted for the Board's consideration have included different financing schemes, including different kinds of co-financing. This note includes the background on the full cost of adaptation and a rationale of why the PPRC would recommend to the Board to ask the secretariat to present a more comprehensive report in light of its technical but also political dimension. The original paper prepared is included as an annex to this note.

Action expected: The PPRC will be invited to take note of the report on the proposed process for an analysis on the full cost of adaptation reasoning AFB/PPRC.27/4 and to make a recommendation to the Board.

16. Other matters

17. Adoption of the recommendations and report
