GUIDANCE TO IMPLEMENTING ENTITIES FOR APPLICATION OF INNOVATION INDICATORS FOR FULLY DEVELOPED PROJECT/PROGRAMME PROPOSALS

Introduction

- 1. The Adaptation Fund Board (the Board), through its decision B.35.b/8, requested its secretariat (the secretariat) to develop specific objectives and indicators for the innovation aspects of the large innovation projects. At its 37th meeting the Board discussed the document AFB/B.37/6, on strategic objectives and indicators for the innovation aspects of projects and programmes including specific proposed indicators.
- 2. Having considered the information contained in document AFB/B.37/6 on the specific objectives and indicators for the innovation aspects of projects and programmes, the Board decided:
 - (a) To take note of the information presented in document AFB/B.37/6;
 - (b) To request the secretariat to pilot the use of the indicators set out in document AFB/B.37/6;
 - (c) To request the secretariat to report on the progress and status of the use of the indicators, including any recommendations, to the Project and Programme Review Committee at its twenty-ninth meeting;
 - (d) To encourage the secretariat, while piloting the use of indicators, to continue consulting with the Technical Evaluation Reference Group of the Adaptation Fund as needed;
 - (e) To request the secretariat to provide an update on the matter to the Board at its thirty-ninth meeting, in the light of any relevant developments for the Fund, including those following from subparagraphs (b) and (c) above.

(Decision B.37/39)

Objective of the document

3. The current document therefore aims to 1) report on the progress for piloting the use of indicators laid in document AFB/B.37/6, 2) recommend a revision of outcome 8 of the Strategic Results Framework pertaining to innovation in project/programmes and, 3) presents guidance to implementing entities on how to report on the set of pilot innovation indicators set out in document AFB/B.37/6 and the current document in the funding application template for fully developed proposals with innovative components.

What is this guidance document for?

4. This guidance document is relevant Implementing Entities (IEs) submitting proposals at the fully developed proposal stage, considering that the sections in the application template that focus on result-based management are requested under Implementation Arrangements i.e., Part III of the application template. For Large Innovation Projects, this applies specifically to Section III. E ('Include a results framework for the project / programme proposal, including milestones, targets, and indicators') and Section III. F ('Demonstrate how the project / programme aligns with the Results Framework of the Adaptation Fund') of the application template for Large Innovation Projects. For Innovation Small Grants proposals, this guidance is applicable for Section III. C ('Include a simple results framework for the project proposal, including milestones, targets and

indicators'), and **Section III. D** ('Demonstrate how the project / programme aligns with the Results Framework of the Adaptation Fund').

5. This document may also apply to <u>projects and programmes under the action pillar</u> (single country, regional and Enhance Direct Access projects), that may have innovation as component or sub-objective of the project/programme. This applies to **Section III. E** ('Include a results framework for the project / programme proposal, including milestones, targets, and indicators') and **Section III. F** ('Demonstrate how the project / programme aligns with the Results Framework of the Adaptation Fund') of the application template.

Results Framework for the project/programme proposal, including milestones, targets, and indicators

- 6. **Section III. E** of the **Large Innovation Project Application Form** and **Section III. C** of the **Innovation Small Grant Application Form**, request that the funding proposal include a results framework with realistic, quantified expected results. Whenever possible, the indicators and targets should be gender responsive and disaggregated by sex as appropriate. More guidelines on preparing the project/programme results framework, including a list of standard AF indicators, can be found in the Strategic Results Framework (Amended in March 2019).
- 7. However, given the more recent developments under the innovation facility, the Board during its 37th meeting approved a set of five pilot indicators¹ for setting targets and monitoring results for the Innovation Small and Large Grants, including the Adaptation Fund Climate Innovation Accelerator (AFCIA) programme.
- 8. A key consideration is to ensure that additional indicators would complement those already available under the existing Strategic Results Framework (SRF) (e.g., 'Number of Beneficiaries' which is already a core indicator, for measuring progress towards impact level results.) Another is that the indicators should be SMART², and appropriate for project level use by IEs at project development and implementation stage (as opposed, for instance, for impact evaluation stage or indicators appropriate at the level of the portfolio). Table 1 displays the set of performance indicators to measure innovation aspects of projects/programmes of the Fund, and that should be incorporated in the project/programme results framework.

Alignment with the Strategic Results Framework of the Fund

- 9. The Adaptation Fund Strategic Results Framework (SRF) includes long-term goal, outcome, outputs, and a small set of indicators for the Fund as a whole. The AF works toward the achievement of the overall goal and outcomes. Consequently, any project or programme funded through the AF must align with the Fund's results framework and directly contribute to the overall objective and outcomes outlined.
- 10. The SRF of the Fund, amended in March 2019 (AFB/EFC.24/4/Rev.1)⁶ consists of impact level results, with five associated core indicators, as well as outcomes (of which there are eight) and outputs, and indicators associated with the outcomes and outputs. The SRF is intended for all the adaptation projects and programmes of the Fund and, therefore, applies to the funding windows under the Innovation Facility of the Fund.
- 11. Specifically, for innovation projects and programmes, project outcomes should be aligned with the Fund level outcome for innovation (Outcome 8) of the Strategic Results Framework and all others that may apply in the context of the project /programme.
- 12. The alignment table is requested under **Section III. F** ('Demonstrate how the project/programme aligns with the Results Framework of the Adaptation Fund') of the application template for Innovation Large Projects. For Innovation Small Grants proposals, the alignment table is requested in **Section III. D** ('Demonstrate how the project/programme aligns with the Results Framework of the Adaptation Fund').
- 13. Any project or programme funded through the Adaptation Fund (AF) must align with the Fund's results framework and directly contribute to the Fund's overall objectives and outcomes outlined. At least one outcome and one output indicator from the Adaptation Fund's Strategic Results Framework must be included at the project design stage.
- 14. Among the eight outcomes listed in the current SRF, Outcome 8, is focused specifically on innovation. Indeed, the objective of the Innovation Strategic Focus under the Implementation Plan of the Medium-Term Strategy (MTS), which is to "support the development and diffusion of innovative adaptation practices, tools, and technologies" is aligned to Outcome 8. Its associated

outcome indicators in the current SRF cover some of the ground with respect to measuring the results under the innovation pillar.

- 15. However, in order to ensure that Outcome 8 of the SRF comprehensively captures the five specific innovation indicators presented in Table 1 above, Table 2 presents a revised strategic results framework for outcome 8. It should be noted that all other outcomes of the Strategic Results Framework remain the same.
- 16. The revised indicators presented in Table 2 below, should be referenced when presenting alignment of project objectives and outcomes with the Fund level strategic outcome for innovation (Outcome 8). The below indicators are introduced on a pilot basis and SRF will be amended in due time to reflect the new innovation indicators after the pilot phase, should the Board decide to endorse them beyond the pilot phase.

Proposed next steps

- 18. The current guidance document will be made available to implementing entities and other relevant stakeholders via the AF innovation microsite and through readiness webinars/ knowledge sharing events hosted by the secretariat.
- 19. Once a project is approved and the first funds are transferred to the project, the implementing entity is required to submit a project/programme performance report (PPR) on an annual basis using the PPR template approved by the Board through Decision B.16/21. In order to enhance reporting consistency in the PPRs some sections were partially revised through decision B.18/29. With the approval of the MTS, the PPR template was further updated to be aligned with the MTS to allow capture key information, including for example, lessons learned on innovation stemming from projects. Amendments to outcome 8 of the results tracker were also included through Decision B.34/44 (October 2019).
- 20. The Adaptation Fund's results tracker is a core part of the annual PPR to track specific indicators across its portfolio. It includes indicators from both (i) the Adaptation Fund Strategic Results Framework, and (ii) the Fund's five core indicators. Therefore, following the pilot phase for innovation indicators, and taking into consideration any relevant developments resulting from the launch of the next MTS, the secretariat will propose amendments to the Strategic Results Framework (October 2019), the 'Results tracker', 'Lessons learned' and other relevant sections of the PPR to monitor the performance of innovation indicators and capture learning from innovation projects/programmes.
- 21. Following the pilot phase for application of innovation indicators, the secretariat will propose revisions to the SRF, the PPR and other relevant documents for consideration of the Project and Programme Review Committee and a decision by the Board. Following a decision from the Board, the Board would give a mandate to the secretariat to implement the revised SRF, PPR and relevant documents.

Proposed recommendation

- 22. Having considered the information contained in document AFB/PPRC.29/44 on the indicators for the innovation aspects of projects and programmes, the Board may wish to decide:
 - a) To approve the revised outcome 8 of the Strategic Results Framework (SRF), as laid out in Table 3 on a pilot basis, as well as the guidance to implementing entities for application of innovation indicators in projects/programmes described in document AFB/PPRC.29/44; and
 - b) To request the secretariat to propose amendments to the Strategic Results Framework, Project Performance Reports and other relevant documents following the pilot

phase for application of innovation indicators to the Project and Programme Review Committee.
