# **REPORT ON ACTIVITIES OF THE CHAIR**

1. During the intersessional period between the thirty-seventh meeting and the thirty-eighth meetings of the Adaptation Fund Board (the Board), the Chair, Mr. Mattias Broman (Sweden, Western Europe and Others) carried out the below-listed activities for the Fund.

- (a) Finalized the report of the thirty-seventh meeting, assisted by the secretariat;
- (b) Liaised with and provided guidance to the secretariat on planning of work after the thirtyseventh meeting, including:
  - Resource mobilization initiatives under the resource mobilization action plan;
  - Report of the Board to the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP) at its sixteenth session, and to the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA) at its third session, and preparations for developing its addendum;
  - Preparations for and moderating the Glasgow Climate Change Conference (COP 26), and contributor dialogue organized there;
  - The Adaptation Fund joining the COP26 Catalyst Access to Finance "Call to Action" and representing the Adaptation Fund at the Catalyst launch event at COP26;
  - Nomination of Board officers for 2022;
