REPORT ON ACTIVITIES OF THE SECRETARIAT

Background

1. This report lists the activities undertaken by the Adaptation Fund Board Secretariat (the secretariat) during the period of six months between the thirty-eighth meeting in April 2022 and the thirty-ninth meeting of the Adaptation Fund Board (the Board) in October 2022.

Finalization and posting of the report of the second session of the thirty-eighth meeting

2. Following the thirty-eighth meeting held in a hybrid modality on 5-8 April 2022, the secretariat supported the Chair in finalizing the report of the meeting. As agreed by the Board, the report was completed and circulated to Board members and alternates for comments and approval. The Board approved the report, and it was posted on the website of the Adaptation Fund (the Fund) as document AFB/B.38/12.

Events and meetings

- 3. During the reporting period, the secretariat participated in, and presented at, the following events and meetings (excluding meetings of the readiness programme that are described in a separate section below).
 - (a) Ministerial Discussion on Climate Impacts on Small Island Developing States, convened by the Government of Canada during the 2022 World Bank Spring Meetings (21 April 2022, Washington DC, USA): the Manager of the secretariat represented the Fund and spoke on a panel with representatives from other climate funds on AF support to SIDS.
 - (b) Addressing land degradation and ecosystem restoration through transformative projects and programmes: financing opportunities for increased impact" and "The Programme for Integrated Development and Adaptation to Climate Change in the Zambezi Watercourse (5-6 May 2022, Abidjan, Côte d'Ivoire):
 - (c) The fifteenth session of the Conference of the Parties (COP15) of the United Nations Convention to Combat Desertification (UNCCD) (9-10 May 2022, Abidjan, Côte d'Ivoire): the secretariat organized an AF side event, a joint side event with the GEF secretariat, as well as participated on panels at the UNCCD COP15.
 - (d) National forum on Climate Change Adaptation Ivory Coast- SENACC (16-20 May 2022, Abidjan, Côte d'Ivoire): The secretariat was invited to present its funding windows and recent developments as part of its active portfolio. The Fund also shared its perspective on adaptation financing gap and overall adaptation finance discussion in the context of UNFCCC Paris agreement.
 - (e) Thirty-second meeting of the GCF Board (16 19 May 2022, hybrid): the secretariat observed the meeting virtually.

- (f) Climate Change-induced loss and damage: an informal event on the latest state of play, organized by Irish Aid and ODI (17- 18 May 2022, virtual): the secretariat participated in a panel discussion and presented on AF support in sectors relevant for some aspects of averting or minimizing loss and damage, including disaster risk reduction and early warning systems.
- (g) Training workshop on Climate Finance access and mobilization in the island states in the Indian Ocean (23-26 May 2022, Bandos, Maldives): a member from the secretariat presented and facilitated thematic discussions at training sessions organized by the UNFCCC Secretariat Climate Finance team on an overview of the AF, project formulation, climate change adaptation reasoning, Environment and Social Policy and Gender Policy compliance, and results-based management.
- (h) AF-TERG Member Meeting (31 May 3 June 2022, Washington DC, USA): The secretariat attended the AF-TERG hybrid meeting which was held in Washington DC to discuss various matters including the Fund's evaluation function, the overall AF operations (portfolio, accreditation, readiness, knowledge management, etc.), the AF-TERG current work program and recent developments as well as the recently approved evaluation policy. The manager provided an introductory remark on the first day and several members of the secretariat attended specifics sessions in line with their work stream.
- (i) "Stockholm+50: a healthy planet for the prosperity of all our responsibility, our opportunity" (Stockholm+50) (2-3 June 2022, Stockholm, Sweden): Members of the secretariat attended Stockholm+50 speaking at high-level discussions, including a high-level political dialogue on ways to support partners countries in the implementation of adaptation priorities, a roundtable discussion between the philanthropic sector and global funds and a number of side events, and held a number of bilateral meetings with partner organizations actively engaging with participants.
- (j) SB56 Bonn Climate Change Conference: Fifty-sixth session of the UNFCCC subsidiary bodies (6-16 June 2022, Bonn, Germany): the secretariat attended the session for the whole duration and observed AF relevant negotiations, including on the Fourth Review of the AF and on membership of the AFB. The secretariat presented on relevant AF support during the Glasgow Dialogue on Loss and Damage, and observed sessions related to the Global Goal on Adaptation. The secretariat also organized a side event on "New Strategic Directions for Enhancing Adaptation Finance Ambition and Impact" that gathered various stakeholder perspectives on the Fund's next Medium-Term Strategy (MTS). The Manager of the secretariat spoke at a side event on ambition in adaptation finance organized by the Stockholm Environment Institute. The secretariat further engaged with stakeholders, including the incoming COP 27 and COP 28 Presidencies, contributor and recipient governments, IEs, and the IPCC during bilateral meetings.

- (k) United Nations for National Adaptation Plans (UN4NAPs) Side Event during SB56 Bonn Climate Change Conference (13 June 2022, Bonn, Germany): the secretariat represented the AF as one of the participating organizations of the UN4NAPs initiative and introduced AF funding opportunities;
- (I) CHANCE Conference: Climate and Health Africa Network for Collaboration and Engagement (23-24 June 2022, virtual): the secretariat represented the AF and introduced AF funding opportunities and available support to the climate and health initiatives.
- (m) Caribbean Safe School Initiative Third Caribbean Ministerial Forum on School Safety (28-30 June 2022, Sint Maarten): A member of the secretariat was invited to speak in the Forum and presented the overview of the Adaptation Fund and how to access funding from the Adaptation Fund, and shared examples of the Fund's projects related to disaster risk reduction and school safety.
- (n) SADC Great Green Wall (GGW) Stakeholder Engagement and Capacity Building Workshop (2-4 August 2022, Pretoria, South Africa) organized by UNCCD. Whilst the secretariat did not directly participate in this event due to capacity and time constraints, the readiness team liaised with the organizers and sent a presentation which was screened for participants during one of the workshop sessions.
- (o) United Nations Climate Week in the Latin America and the Caribbean region hosted by the Government of Dominican Republic (18-22 July 2022, Santo Domingo, Dominican Republic). Members of the secretariat organized a side event jointly with the Fund's National Implementing Entity *Instituto Dominicano para el Desarrollo Sostenible* (IDDI), which included an overview of the Fund's funding opportunities, accreditation and readiness support.
- (p) Botswana Global Adaptation Week, including the NAP Expo 2022 and UN4NAPs Forum (22-26 August 2022, Gaborone, Botswana). A member of the secretariat gave a presentation, and had several bilateral discussions with recipient governments and partner organizations.
- (q) In-person official-level meeting on the second Climate and Development Ministerial organized by the United Kingdom (1-2 September 2022, Dar es Salaam, United Republic of Tanzania). A member of the secretariat participated.
- (r) GCA Youth summit organized by the Global Center on Adaptation (3-4 September 2022, Rotterdam, the Netherlands). A member of the secretariat spoke on a panel and presented the Fund's new knowledge report on youth engagement.
- (s) Second Climate and Development Ministerial hosted by the governments of the United Kingdom and Rwanda (20 September 2022, New York City, the United States). The Manager of the secretariat joined the roundtable discussion on four policy areas:

- response to climate impacts; access to finance; climate finance; and fiscal space and debt sustainability.
- (t) "Innovation in Adaptation Financing: from concept to implementation", organized by the NDC Partnership Support Unit and the International Fund for Agricultural Development (20 September 2022, New York City, the United States). A member of the secretariat joined as a panelist.
- (u) Side Event on Early Warnings during the High-Level Week of the 77th session of the United Nations General Assembly (21 September 2022, New York City, the United States). A member of the secretariat spoke on a panel in the event.
- (v) "The Road to Resilience: Realizing the benefits of the energy transition", organized by the Climate Finance Access Network coordinated by RMI (22 September 2022, New York City, the United States). A member of the secretariat spoke on a panel in the event.

Preparations for the thirty-ninth Board meeting

Meeting arrangements

- 4. Following the Board decision B.37-38/11 and recognizing the continuing extraordinary circumstances and challenges due to the COVID-19 pandemic on several continents, the Board held its thirty-eighth meeting as a hybrid meeting on 7-8 April 2022, preceded by hybrid meetings of the Project and Programme Review Committee and the Ethics and Finance Committee, respectively, on 5-6 April 2022.
- 5. The Board decided to hold its thirty-ninth meeting In Bonn, Germany, on 11-14 October 2022, including the meetings of the Project and Programme Review Committee (PPRC) and the Ethics and Finance Committee (EFC) and the meeting of the Board.

Meeting documents

- 6. The secretariat, working closely with the Board Chair and the Committee Chairs and Vice-Chairs, and the trustee, prepared the documents for the thirty-ninth meeting of the Board and for the thirtieth meetings of the Project and Programme Review Committee (PPRC), and of the Ethics and Finance Committee (EFC).
- 7. The full list of documents is contained in document AFB/B.39/Inf.1, List of documents.

Implementation of decisions adopted by the Board at its thirty-eighth and earlier meetings and during the ensuing intersessional period

Management response to the mid-term review of the Medium-term Strategy

10. Through decision B.37-38/7, the Board approved the updated management response and action plan to the mid-term review (MTR) of the Medium-term Strategy (MTS) and requested the secretariat to report to the Ethics and Finance Committee, at its thirtieth meeting (October 2022), on the progress made in implementing the action plan. The secretariat prepared a report to the EFC on the progress made in implementing the action plan to respond to the recommendations arising from the MTR of the MTS of the Adaptation Fund. (Decision 37/36).

Update on implications of the fiduciary issues related to the United Nations Development Programme

11. The secretariat continued coordinating with the secretariats of the Green Climate Fund and the Global Environment Facility regarding fiduciary issues associated with the projects implemented by the United Nations Development Programme (UNDP). (Decision B.37/37). In accordance with Board decision B.37/37, the secretariat prepared a report on the update of the Board request to UNDP to commission a review of its compliance with the Adaptation Fund's policy on fiduciary standards. (Decision B.37/37).

Objectives and indicators for innovation aspects of projects

12. In line with Decision B.37/39 secretariat prepared an update on the progress and status of the use of the indicators, and made recommendations to the Board at its thirty-eighth meeting with respect to a proposed revised outcome 8 of the Strategic Results Framework (SRF), as laid out in table 3 of document AFB/PPRC.29/44 on a pilot basis, as well as the guidance to implementing entities for application of innovation indicators in projects/programmes described in the same document. (Decision B.37/39)

Report of the Accreditation Panel

13. The secretariat, with the task force addressing the top-level management statement (TLMS) related matters, will report to the Board at its thirty-ninth meeting updates on the implementing entities that have failed or refused to submit the TLMS required for accreditation and reaccreditation and additional input on the nine options for addressing the TLMS-related matters outlined in document AFB/B.35.b/4/add.1. (Decision B.38/4)

Report of the secretariat on the intersessional review cycle for the readiness grants

14. The secretariat made available on the Fund website, the updated review templates and application form for readiness package grants and notified all accredited national implementing

entities (NIEs) of the amended and new application form and review templates for readiness package grants. (Decision B.38/38)

Analysis of the issues related to the use of unidentified subprojects

15. The secretariat prepared a document containing updated guidance on unidentified subprojects (USPs), including further elaborated criteria on the use of USPs in a project/programme and to present it for consideration by the PPRC at its thirtieth meeting (Decision B.38/41).

Report on indicators for innovation

16. In line with Decision B.38/43, the secretariat disseminated the guidance to implementing entities for application of innovation indicators in projects/programmes on the innovation microsite as well as through courtesy notices to implementing entities on relevant policies and guidance documents ahead of the review cycle. Pursuant to decision B.37/39, the secretariat has developed a document for consideration at the thirty-nineth meeting of the Board to report on the progress and status of the use of the innovation indicators, including options for defining duration for piloting innovation indicators.(Decision B.38/43)

Options for further supporting the work of the Project and Programme Review Committee

17. The secretariat prepared an updated document, taking into account the outcome of the discussion on the subject, which will be presented at the 30th meeting of the PPRC. (Decision B.38/44)

Medium-term strategy of the Fund for the period 2023–2027

- 18. The secretariat, under the guidance of the task force on the second medium-term strategy of the Adaptation Fund, (i) prepared a draft MTS 2023–2027 that builds on the strategic framework and achievements of the MTS 2018–2022 and further enhances it by proposing strategic updates and adjustments aimed at consolidating the Fund's comparative advantage and optimizing its impact (in line with option 2, as set out in document AFB/B.38/5), and reflecting the views expressed by the Board at its thirty-eighth meeting and (ii) undertook further stakeholder consultations on the draft MTS 2023–2027, to present for consideration by the Board at its thirty-ninth meeting. (Decision B.38/49).
- 19. The secretariat organized two virtual meetings of the Board's task force to guide the preparation of the draft MTS 2023 –2027 including proposed strategic amendments to the current MTS and related stakeholder consultations.
- 20. The stakeholder consultations included various formats, such as targeted consultation of NIEs during the readiness programme's annual NIE seminar, written inputs from the AF-TERG, AF CSO Network, as well as authors of the IPCC report on impacts, adaptation and vulnerability.

AFB/B.39/3

Draft resource mobilization strategy and action plan for the period 2022-2025

21. The secretariat (a) conducted a survey of the Board during the intersessional period (B.38-B.39), with a view to receiving input on the draft resource mobilization strategy set out in document AFB/B.38/6 /Add.1 and the draft resource mobilization action plan set out in document AFB/B.38/6/Add.2 and (b) updated the draft resource mobilization strategy and the draft resource mobilization action plan to reflect the input provided by the Board through the intersessional survey referred to in subparagraph (a), above, for the Board's consideration at its thirty-ninth meeting. (Decision B.38/50)

Issues arising from sixteenth session of the Conference of the Parties serving as meeting of the Parties to the Kyoto Protocol (CMP 16), the third session of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA 3) and the twenty-sixth session of the Conference of the Parties (COP 26)

22. The secretariat (a) conducted a survey of the Board during the intersessional period, with a view to receiving input on the proposed amendments to the Strategic Priorities, Policies and Guidelines of the Fund adopted by the CMP (SPPG) and the Operational Policies and Guidelines for Parties to Access Resources from the Adaptation Fund (OPG), respectively, as set out in documents AFB/B.38/10/Add.1 and AFB/B.38/10/Add.2; and (b) prepared a document setting out the proposed amendments to the SPPG and the OPG, respectively, reflecting the Board's discussions at its thirty-eighth meeting and the input received from the Board through the intersessional survey referred to in subparagraph (a), above, for the Board's consideration at its thirty-ninth meeting. (Decision B.38/51)

Readiness Programme

- 23. During the reporting period, the secretariat implemented the following activities under the Readiness Programme¹:
 - a) The secretariat hosted a virtual workshop on Accreditation on 9 June 2022. The workshop sought to enhance understanding on the Fund's accreditation process and criteria among developing countries, and discussed the common gaps and challenges, as well as requirements for the accreditation of a second NIE from a country.
 - b) The secretariat in cooperation with *Fundecooperación para el Desarrollo Sostenible* hosted an in person three-day international workshop on Enhanced Direct Access (EDA) in Costa Rica, on 21-24 June 2022. The workshop provided a platform for countries to share and exchange lessons, knowledge and experiences in the programming of climate adaptation finance, and the development of adaptation projects and encourage the programming of climate finance through Direct Access. The workshop, while focusing

on EDA, also offered an overview and recent updates on other recently established modalities available through Direct Access, such as innovation grants.

- c) The secretariat hosted the 2022 Annual NIE Seminar in Washington, D.C. from 26-30 September 2022. The seminar discussed various topics focused on peer peer learning between NIEs and between the secretariat and NIEs which included: navigating the different funding windows under the Fund, updated gender guidance document, proposal development, reaccreditation, the Fund's second Medium-Term Strategy (MTS) and the community of practice for direct access entities.
- d) The secretariat partnered with the UNFCCC secretariat on a series of training workshops on Climate Finance access and mobilization, and during the reporting period participated in three such training workshops, presenting in and facilitating thematic discussions at training sessions organized by the UNFCCC Secretariat Climate Finance team on an overview of the Fund, project formulation, climate change adaptation reasoning, Environment and Social Policy and Gender Policy compliance, and results-based management. The three workshops were targeted at the island states in the Indian Ocean (23-26 May 2022, Bandos, Maldives), Asian Least Developed Countries (8-11 August 2022, Bangkok, Thailand) and Arab States (18-20 August 2022, Tunis, Tunisia).
- e) The secretariat held a joint side event with one of the Fund's accredited NIEs, the Dominican Institute of Integral Development (IDDI), at the Latin America and Caribbean Climate Week 2022 organized by the UNFCCC secretariat, which took place from 18-22July, in the Dominican Republic, and hosted by the Government of the Dominican Republic.
- f) The secretariat launched and started the review process for readiness grants. The grants would be presented to the Board for its consideration intersessionally during its thirty-ninth and fortieth meetings.
- g) The secretariat held informal meetings with various partner organizations to explore collaboration opportunities through joint activities to enhance capacity-building impact through the Fund's readiness programme. Organizations included the United Nations Convention to Combat Desertification (UNCCD) and United Nations Forum on Forests (UNFF).

Communications

24. Since the thirty-eightht Board meeting, the secretariat continued an effective strategy of producing and disseminating engaging content in the news stream to highlight the Fund's work, project voices on the ground, growing demand for projects and adaptation finance needs, expanding funding windows and opportunities for countries, among other topics. The secretariat continued to utilized and innovate new communications avenues, including the Fund's original podcast series 'Building Climate Resilience' and worked closely with implementing partners and

other stakeholders to showcase the Fund's projects and programmes in action via videos and stories. It also presented key events and other outreach activities of the Fund through social media, photo albums, flyers and other platforms. These efforts significantly grew the Fund's website readership, as well as partnerships with key communications colleagues from other funds, implementing and executing entities, CSO's, UNFCCC and other stakeholders.

- 25. During the reporting period, the secretariat developed six original news releases on timely topics such as youth engagement, the release of new Fund's knowledge studies on accreditation and regional projects, and the Board meeting results; three project stories (including two in collaboration with partner Climate Home News to expand audience reach to key stakeholders) on key topics such as innovation projects in Mexico, urban adaptation in Mongolia, Fund's effective SIDS project in the Seychelles and resilient alpaca production in Peru; four videos on topics such as scaling up Fund's projects; two podcasts and two photo essays; as well as new overview flyers on Fund programmes. The secretariat also shared multiple external videos and written stories from implementing partners highlighting Fund projects. It developed several sets of talking points that were utilized in high-level speeches, media outreach and video recordings for key AF outreach events.
- 26. The secretariat posted frequently to the Fund's website and social media platforms, which drew continued significant growth across the board . . The Website had 32,361 new users and 218,622 page views (3.08% increase from previous year). The Fund put out 158 tweets and gained 413 new Twitter followers during the 15 April -1Augreporting period, reaching the milestone of 20,000 followers. Facebook rose to 16,708 followers, an increase of 4,543 followers. LinkedIn increased to 3,080 followers, an increase of 652.. The Fund also had 223 mentions in the press in the period, up from 145 during the same period last year. These included 130 in English, 76 in Spanish, and 17 in French.
- 27. The secretariat has continued to innovate and grow its communications platforms, including developing new podcasts, blogs and short videos as well as extending partnerships with media such as Climate Home News, which has enabled the Fund to reach larger audiences and additional project and programme areas in stories. The secretariat has started preparations for the COP27 conference in Egypt and is planning to host a pavilion with a branded design as well as side events on key Fund and adaptation themes such as development of the Fund's next Medium Term Strategy. The secretariat also worked with the IT team to continue to make periodic enhancements to ensure the website continues to be user-friendly, intuitive and secure.

Knowledge Management

- 28. The secretariat completed a study on "lessons learned from transboundary adaptation interventions in the Fund's portfolio" which examines the benefits of adaptation interventions at the regional level with case studies form the AF portfolio of project and programs.
- 29. The secretariat completed a second study on "lessons learned from youth engagement in climate change adaptation" aimed at implementing entities of the Adaptation Fund. The study examined the different aspects of youth engagement including, but not limited to innovative

solutions employed by this age category in strengthening resilience to climate change and includes brief case studies from the Fund's portfolio of projects and programs from different sectors. The findings of the study were presented during a Youth summit held in Rotterdam, the Netherlands organized by the Global Center on Adaptation.

- 30. The secretariat completed a third study on "lessons learned from the streamlined accreditation process" aimed at NIEs or prospective smaller applicant entities and provides a brief background of the streamlined process, details the assessment and results from the desk study and interviews conducted, provides a deeper dive into the process for three Small National Implementing Entities (SNIEs), and concludes with key lessons learned as well as recommendations for further improvement of the process.
- 31. The secretariat also initiated the work on a fourth study on "lessons learned from scalability of Fund projects and programs including case studies from the Fund's projects and programs" which examines the enabling factors that led to scalability of Fund projects and looks at the challenges and opportunities faced in the process. The study is close to completion.
- 32. The secretariat completed the development of an virtual training course for project scale-up grants aimed at increasing understanding of national implementing entities on the review criteria, eligibility and characteristic of project scale-up grants with the final purpose of submitting successful proposals. The course is self-paced and is available in English, Spanish and French.

Accreditation

33. The thirty-eighth meeting of the Accreditation Panel was held in a hybrid manner in Washington DC on 7-8 September 2022. The Panel has continued reviewing 17 re-accreditation applications (ten NIEs, two Regional Implementing Entities (RIEs) and five Multilateral Implementing Entities (MIEs)) and 13 accreditation applications of eleven potential NIEs, one potential RIE and one potential MIE that were previously reviewed but required additional information for the Panel's review. At the Panel's thirty-eighth meeting, the secretariat held a discussion on the TLMS taskforce and deliverables and present to the Panel a study it had commissioned on the lessons learned from the Fund's Streamlined Accreditation Process. The secretariat also presented a recap on the working modalities of the Panel and the AF-TERG briefed the Panel on the thematic evaluation on accreditation. The report of the Panel's thirty-eighth meeting has been published on the Fund's website as part of the documents for the thirty-ninth meeting of the Board.

Screening/technical review of project/programme proposals

- 34. In preparation for the thirty-ninth meeting of the Board in October 2022, the secretariat screened and prepared technical reviews of six fully-developed single-country project documents and twenty-four single country concepts, as well as three regional fully-developed project document, one regional concept, and one regional pre-concept. In addition, the secretariat screened and technically reviewed five innovation small grant proposals. For the two new funding windows, the secretariat screened and technically reviewed one fully-developed innovation single country proposal, two innovation single country project concepts, one innovation regional project concept, one enhanced direct access fully-developed project document and one enhanced direct access concept note. In performing these tasks, the team leader was supported by GEF Secretariat technical staff, and 11 contracted technical experts.
- 35. During the intersessional period between the thirty-eighth and thirty-ninth meetings of the Board, three projects were approved; one single-country project and two regional projects. Additionally, one single country concept notes and two regional ones were endorsed, each of which requested a project formulation grant (PFG).

Review of Project Performance Reports and project/programme no-cost extension requests

- 36. Following the Board Decision B.28/47 at its twenty-eighth meeting to delegate to the secretariat its authority to approve technical review and clearance of the Project Performance Reports (PPRs) prior to authorization by the Chair of the cash transfer of funding tranches, the secretariat has completed the review, cleared and made publicly available on the Fund's website:
 - (a) The second PPR for the projects implemented in: Chile, Ecuador (CAF, inception date: January 2020); Armenia (EPIU, inception date: September 2019); Albania, Macedonia, the former Yugoslav Republic of, Montenegro (UNDP, inception date: October 2019); Iraq (IFAD, inception date: December 2019); Sierra Leone (IFAD, inception date: May 2020);
 - (b) The third PPR for the projects implemented in: India (NABARD, inception date: May 2015); Nepal (WFP, inception date: October 2018); Colombia, Ecuador (WFP,

inception date: May 2018); Honduras (UNDP, inception date: March 2019); Federated States of Micronesia (MCT, inception date: July 2018); Cook Islands (MFEM, inception date: December 2018);

- (c) The fourth PPR for the projects implemented in Morocco (ADA, inception date: May 2017); India (NABARD, inception date: May 2015);
- (d) The fifth PPR for the project implemented in India (NABARD, inception date: May 2015);
- (e) The sixth PPR for the project implemented in South Africa (SANBI, inception date: December 2015);
- (f) The eighth PPR for the project implemented in Jamaica (PIOJ, inception date: November 2012).
- 37. In this intersessional period, the secretariat received four requests for project changes under the regular process. These were approved by the Board and a corresponding decision was transmitted to the IE. The requests received are listed below:
 - (a) Request for provision of direct project services: Zimbabwe (UNESCO);
 - (b) Request for extension of project completion date: Morocco (ADA);
 - (c) Request for extension of project completion date and revision of disbursement schedule: Colombia, Ecuador (WFP);
 - (d) Request for extension of project completion date: Kenya (NEMA).
- 38. As per Board Decision B.35.b/16, which includes a provision for temporary no-cost extension of the project completion date up to 12 months for projects/programmes which have been delayed due to COVID-19 and which are set to be completed within 24 months from the date of the extension request, the secretariat received intersessionally two no-cost project/programme extension requests. The secretariat proceeded screening the requests and found that they were compliant with the criteria as described in paragraph 33 of document AFB/EFC.26.b/4. The requests received and cleared by the secretariat as of the date of the issuance of this document are listed below:
 - (a) No cost extension of project completion date: India, project "Enhancing Adaptive Capacity and Increasing Resilience of Small and Marginal Farmers in Purulia and Bankura Districts of West Bengal" (NABARD);
 - (b) No cost extension of project completion date: Senegal, project "Reducing vulnerability and increasing resilience of coastal communities in the Saloum Islands (Dionewar and Fadial)" (CSE).

Gender

- 39. The secretariat produced a user-friendly version of the *study on* intersectional approaches to gender mainstreaming in adaptation-relevant interventions which was intersessionally submitted to the Board as an informational document (Document AFB/B.37-38/Inf.1).² The study examines the importance of intersectional approaches and the value they add to implementing gender mainstreaming strategies and practices to adaptation interventions and details adaptation sector-specific examples. The study found while there is no single approach to integrating intersectionality in gender mainstreaming in adaptation-relevant interventions, the concept of intersectionality has been used effectively in different contexts, which helps to understand and address wider structural inequalities.
- 40. The secretariat has updated its Guidance Document for IEs on Compliance with the Fund's Gender Policy,³ considering the results of the surveys of its IEs, DAs, AF civil society network and partner organizations conducted in 2021. The updated gender guidance document provides supplemental information and practical guidance for IEs to comply with AF gender policy and to enhance their gender responsive mainstreaming throughout the project lifecycle in an intersectional manner, accompanied by gender mainstreaming toolkits such as respective checklists for a preliminary gender analysis required for concept note and gender assessment required for fully developed project proposals, examples for sector-specific gender assessment considerations, and examples of gender-responsive indicators by sectors or theme. The secretariat also produced a summary version of the updated gender guidance document to make it serve as a handy tool for the IEs.
- 41. To help strengthen the capacity of NIEs to integrate gender considerations into the Fund's projects and programmes, the secretariat conducted a gender training focusing on the updated gender guidance document for IEs on compliance with the Fund's Gender Policy during the annual NIE seminar.
- 42. The secretariat continued to collaborate on gender work with other partner organizations including climate funds, the UNFCCC and other partner organizations, such as UN Women, InsuResilience Global Partnership, and Women and Gender Constituency. A representative of the secretariat participated in the high-level side event of the sixty-sixth session of the Commission on the Status of Women, and shared its experiences, insights and challenges related to strengthening financing mechanisms toward gender sensitive climate adaptation actions and financing gender and health in climate adaptation.

Resource mobilization

43. The Fund has continued to be very active in its effort to support activities related to resource mobilization both at the communication level and at a policy level. The secretariat has continued to have bilateral conversations with potential and existing contributors.

- 44. The Board at its thirty-sixth meeting (March 2021), requested the secretariat, in consultation with the Resource Mobilization Task Force, to prepare a draft resource mobilization strategy for the period 2021 – 2024 and a draft resource mobilization action plan and present them to the Board for its consideration at its thirty-seventh meeting (Decision B.36/36). The demand for support from the Adaptation Fund is high and is growing. The need of funding will increase as the country cap (the amount of funding that each country can access) has increased from 10 million to 20 million (Decision B.36/41). In April 2021, the Board also decided to enable the accreditation of up to two NIEs per country for eligible developing-country Parties (Decision B.36/42). At its thirty-seventh meeting, the Board took note of the Draft Resource Mobilization Strategy 2021-2024 (document AFB/B.37/4). The strategy lays out the current financial situation of the Fund, provides an overarching strengths, weaknesses, opportunities and threats (SWOT) analysis of the Fund's ability to mobilize resources, and builds on the SWOT analysis to define a framework for raising resources. Based on the defined framework an overarching resource mobilization strategy has been developed to guide the Adaptation Fund in its fund raising efforts and to support a Board decision in setting resource mobilization targets for the 2021-2024 timeframe.
- 45. At its thirty-eight meeting in March 2022, the Board continued the discussion on the updated Draft Resource Mobilization Strategy for the period 2021–2024 (AFB/B.38/6 Add.1) and a Draft Resource Mobilization Action Plan (AFB/B.38/6 Add.2) and decided to request the secretariat to conduct a survey for the Board Members during the intersessional period (B.38-B.39), with a view to receiving input on the draft resource mobilization strategy and action plan and to reflect the input provided by the Board through the intersessional survey for the Board's consideration at its thirty-ninth meeting.
- 46. To that end, the secretariat launched a survey to seek input from the Board.
- 47. The secretariat liaised with the United Nations Foundation (UNF) to transfer the financial donations received through the UNF's private donation route ("Donate Button").
- 48. The Fund has also started the preparation of 2022 AF Contributor Dialogue to be held during the COP27 in Sharm El Sheikh with the aim to build on the successful Contributor Dialogue on 8 November 2021, at the COP26.

Ad Hoc Complaint Handling Mechanism

49. The secretariat has not received any eligible complaint during this reporting period.

Personnel

50. Ms. Silvia Mancini, formerly working as an Operations Officer, was recruited as Senior Programme Officer on 16 May 2022 through an open competitive process.

- 51. Ms. Alyssa Gomes, formerly working as an Extended-Term Consultant, was recruited as Climate Change Specialist (innovation) on 15 July 2022 through an open competitive recruitment process.
- 52. Ms. Bianka Kretschmer transitioned from the position of Junior Professional Officer that was funded by the government of Germany to a position of Climate Change Specialist that is funded by the Adaptation Fund on 8 August 2022.
- 53. Mr. Ishak Mohammed, formerly working as a Short-Term Consultant, was recruited as Accreditation Analyst (Extended-Term Consultant) on 4 October 2022 through an open competitive process.
