REPORT ON ACTIVITIES OF THE SECRETARIAT

AFB/B.41/3

Background

1. This report lists the activities undertaken by the Adaptation Fund Board Secretariat (the secretariat) during the period of six months between the fortieth meeting in March 2023 and the forty-first meeting of the Adaptation Fund Board (the Board) in October 2023.

Finalization and posting of the report of the fortieth meeting

2. Following the fortieth meeting held in Bonn, Germany on 23-24 March 2023, the secretariat supported the Chair in finalizing the report of the meeting. As agreed by the Board, the report was completed and circulated to Board members and alternates for comments and approval. The Board approved the report, and it was posted on the website of the Adaptation Fund (the Fund) as document AFB/B.40/14.

Events and meetings

- 3. During the reporting period, the secretariat participated in, and presented at, the following events and meetings (excluding meetings organized by the readiness programme that are described in a separate section below).
 - (a) Five Needs-Based Finance (NBF) Training workshops on climate finance access and mobilization organized by the United Nations Framework Convention on Climate Change (UNFCCC); for the ASEAN region (20-23 March 2023, Metro Manila, Philippines), for the Eastern Caribbean States (OECS) (27-31 March 2023), for the East African Community (EAC) (17-19 April 2023), for the Central Asia & South Caucasus countries (3-7 July 2023), and for the ECOWAS member states (22-25 August 2023). The secretariat participated in the workshops and gave presentations on the overview of the Fund's portfolio, project/programme ideation process, and the Medium-Term Strategy for 2023-2027 which aims to optimize the Fund's impact with increased ambition to finance adaptation action.
 - (b) 26th meeting of the Technology Executive Committee (TEC) (21-24 March 2023, Songdo, South Korea): A member of the secretariat joined the meeting as observer and participated in the roundtable discussion between the Technology Mechanism and funding entities.
 - (c) NAP¹ Expo 2023 (27-30 March 2023, Santiago, Chile): A member of the secretariat participated in the meeting and presented the Fund's work and priorities under the Medium-Term Strategy in the plenary dedicated to accessing adaptation finance. The secretariat also presented in a session organised by the Least Developed Countries Expert Group (LEG) dedicated to the challenges faced by Least Developed Countries (LDCs) in accessing adaptation finance. In addition, the secretariat had a number of

- bilateral meetings with countries to answer questions on their portfolios or opportunities for accessing the Fund.
- (d) First Meeting of the Transitional Committee for the Loss and Damage (L&D) (27-29 April 2023 in Luxor, Egypt): The two representatives of the secretariat who were nominated to form part of the Technical Support Unit (TSU) to the UNFCCC, participated in the first meeting of the Transitional Committee on addressing loss and damage. A presentation was delivered on the role of the Adaptation Fund in averting and minimizing loss and damage through among other areas its work on disaster risk reduction, early warning systems and ecosystem-based adaptation. The representatives also supported the UNFCCC Secretariat in brainstorming on how best to support the L&D Transitional Committee in achieving its mandate.
- (e) First workshop on addressing loss and damage in the context of decisions 2/CP.27 and 2/CMA.4 (29 30 April 2023 in Bonn, Germany); The two representatives of the secretariat who were nominated to form part of the Technical Support Unit (TSU) to the UNFCCC, participated in the first workshop of the Transitional Committee on addressing loss and damage. The representatives supported the UNFCCC Secretariat in consolidating the ideas on how to respond to the mandate based on the various case studies presented and the discussions of the Transitional Committee.
- (f) Bahrain NAP Implementation Workshop (2 3 May 2023, virtual): A representative of the secretariat participated in the meeting and gave two virtual presentations on AF support to countries for NAPs implementation and challenges in scaling up NAPs implementation.
- (g) AIM for Climate Summit (8-10 May 2023, Washington D.C., USA): A representative of the secretariat attended the meeting hosted by the government of the United States as observer.
- (h) 7th meeting of the Global Network of Basins working on Climate Change Adaptation organized by United Nations Economic Commission (25-26 May 2023, virtual): A representative of the secretariat participated in the meeting virtually and presented AF's funding windows with emphasis on regional window and transboundary projects.
- (i) Second Meeting of the Transitional Committee for the Loss and Damage (25-27 May 2023 in Bonn, Germany): The two representatives of the secretariat who were nominated to form part of the Technical Support Unit (TSU) to the UNFCCC, participated in the second meeting of the Transitional Committee on addressing loss and damage. The representatives supported the UNFCCC Secretariat in its continued efforts to support the Technical Committee with consolidating the information presented on what currently obtains in the loss and damage landscape in order to tailor the most appropriate response through a fund and funding arrangements.

- (j) The Global NDC² Conference (31 May 2 June 2023, Berlin, Germany): A member of the secretariat participated in the Conference and engaged in the various sessions around adaptation in the Nationality Determined Contributions (NDCs) these including one on scaling up adaptation actions in NCD and National Adaptation Plans (NAPs), and one on options for engaging private sector in financing adaptation.
- (k) Sixth meeting of the Global Goal on Adaptation (GGA) (4-5 June 2023, Bonn, Germany): The secretariat was invited to present its work on funding adaptation and its results framework including adaptation metrics which could inform the discussions of the GGA. A member of the secretariat made a presentation and responded to questions from parties and observers including areas of collaboration with other partners under the climate funds collaborative platform on results.
- (l) Bonn Climate Change Conference (5-15 June 2023): The manager and representatives of the secretariat participated in the conference and organized an Adaptation Fund Information Event for Parties and Observers taking on 14 June, which was opened by the AFB Vice-Chair. The Board Vice-Chair also presented at a dialogue between the Chairs of Constituted Bodies on progress in integrating a gender perspective into constituted body processes. The manager and representatives of the secretariat also engaged in a number of bilateral meetings with the UNFCCC Executive Secretary, the incoming Presidency of the 2023 United Nations Climate Change Conference (COP28), interested recipient and contributor governments, and other AF stakeholders and relevant initiatives. The secretariat also participated in relevant UNFCCC mandated events, including the sixth workshop under the Glasgow-Sharm el-Sheikh work programme on the global goal on adaptation, the 6th technical expert dialogue (TED6) on the new collective quantified goal for climate finance, the second Glasgow Dialogue and gender related mandated events. The secretariat also presented on AF support at a number of relevant side events, including by other constituted bodies including the UN4NAPs³ side event on scaling up technical assistance for expediting NAPs implementation, a TEC organized event on accelerating the implementation and scaling up of technology solutions and innovation in water-energy-food systems, a workshop on forests and trees for adaptation organized by the Food and Agricultural Organization (FAO), a LEG event on support for LDCs, an event of the Paris Committee on Capacity-building (PCCB) on capacity building support for adaptation, and the collective impact gathering on the UNFCCC Gender Action Plan;
- (m) Fifth Systematic Observations Financing Facility (SOFF) Steering Committee meeting (20-21 June 2023, Copenhagen, Denmark): The manager and a representative of the secretariat represented the Fund as SOFF partner organization and intervened on relevant agenda items during the meeting.

- (n) The Summit for New Global Financing Pact (22-23 June 2023, Paris, France): The manager and a representative of the secretariat participated in the summit, and the manager talked on the panel in a side event "Falling Short: Addressing the Climate Finance Gap for Children organized by the Children Environmental Rights Initiative (CERI) coalition and UNICEF.
- (o) Micronesia Subregional Private Sector Climate Finance Workshop (27 June 2023, virtual): A representative of the secretariat gave a virtual presentation on AF's Innovation window.
- (p) Melanesia Sub-regional Private Sector Climate Finance Workshop (29 August 2023, virtual): A representative of the secretariat gave a virtual presentation on AF's Innovation window.
- (q) Thirty-sixth meeting of GCF Board (10-13 July 2023, Songdo, Incheon, Republic of Korea): A representative of the secretariat joined the GCF board meeting as observer and held multiple meetings with GCF secretariat colleagues working on areas of complementarity and coherence between the two funds. The discussions covered items previously discussed as part of the join roadmap of climate funds including (i) scaling up framework, (ii) joint efforts under the community of practise of direct access entities (CPDAE), (iii) potential areas for joint programming under the Fund's new medium-term strategy and new GCF strategic plan and (iv) joint outreach at the upcoming COP28 including the first-time joint pavilion for all climate funds.
- (r) 2023 Forum of the Standing Committee on Finance: Financing Just Transitions (17-18 July 2023, Bangkok, Thailand): A representative of the secretariat participated as observer and held various bilateral meetings with parties and observer organisations. The representative of the secretariat also moderated the session on "Experience of sub-national and local actors in mobilizing and accessing financing for just transitions".
- (s) Second workshop on addressing loss and damage in the context of decisions 2/CP.27 and 2/CMA.4 (22-23 July 2023 in Bangkok, Thailand); A representative of the secretariat who were nominated to form part of the Technical Support Unit (TSU) to the UNFCCC, participated in the second workshop of the Transitional Committee on addressing loss and damage. The representatives presented on; New funding arrangements for L&D possible under AF with some conditions; Two options possible with different timeline for setting up new funding arrangement; and the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA) or Board decision required for operationalization of new arrangements (1) New funding window or (2) standalone trust fund in the context of the Adaptation Fund.
- (t) Korea Global Adaptation Week (KGAW) 2023 (28 August 1 September 2023, Songdo, Incheon, the Republic of Korea): A representative of the secretariat attended KGAW participating in the Regional NAP Expo for Asia and the Pacific, the Regional UN4NAPs Forum for Asia and the Pacific; Adaptation Committee workshop and the 8th Asia-

Pacific Climate Change Adaptation Forum (APAN Forum). The representative spoke at the several meetings and events, showcasing the Adaptation Fund's work and experiences in financing adaptation and supporting countries in developing and implementing their NAPs. The representative also engaged in a number of bilateral meetings with the representative of developing countries seeking to access funding from the Fund and partner organizations exploring opportunities for further collaborations.

- (u) Third Meeting of the Transitional Committee for the Loss and Damage (28 August to 1 September 2023, Santo Domingo, Dominican Republic): The two representatives of the secretariat who were nominated to form part of the Technical Support Unit (TSU) to the UNFCCC, participated in the third meeting of the Transitional Committee on addressing loss and damage. The Adaptation Fund representatives supported the UNFCCC Secretariat in their availability to further clarify the written submissions by the TSU on paragraph 5 of decisions 2/CP.27 and 2/CMA.4: a) Establishing institutional arrangements, modalities, structure, governance and terms of reference for the fund; b) Defining the elements of the new funding arrangements; c) Identifying and expanding sources of funding; and d) Ensuring coordination and complementarity with existing funding arrangements. The Adaptation Fund representatives led the drafting of two of the five papers and also contributed to the development of the other three with support from the broader AFB secretariat.
- (v) The African Climate Summit and African Climate Week (4 8 September 2023, Nairobi, Kenya): The manager and representatives of the secretariat participated in the summit. The manager participated in four high level events highlighting the work of the Fund and its contribution to building resilience in Africa. Representatives of the secretariat also presented at various technical events. The manager and representatives of the secretariat also engaged in a number of bilateral meetings with the UNFCCC Executive Secretary, various Ministers of African nations, heads of implementing entities of the Funds in Africa as well as with other partners. Another representative of the secretariat also virtually participated in the second regional dialogue for National Gender and Climate Change Focal Points held in conjunction with the African Climate Week (4 5 September) sharing the Fund's experiences in integrating gender in its operations and supporting its implementing entities in mainstreaming gender in adaptation projects and programmes.
- (w) 27th meeting of the TEC⁴ and TEC-CTCN Joint Session (19-21 September 2023, Bonn, Germany): A representative of the secretariat attended the meeting and gave a presentation on Adaptation Fund's support to technology development and transfer, and collaboration with TEC and Climate Technology Center and Network (CTCN).

- (x) Climate Ambition Summit 2023 and General Assembly of the United Nations (UNGA) (19-22 September, New York, USA): The manager and representatives of the secretariat attended sessions organized under the UN Secretary-General Climate Ambition Summit and on the margin of the UNGA. The manager participated as speaker in various events including (i) UNSG Convening of the Principals of International Finance Institutions and Other Relevant Entities on "Loss and Damage", (ii) High-Level Thematic Session: "Delivering climate justice: Accelerating ambition and implementation on adaptation and early warnings for all", and (iii) High Level Side Event: "Delivering Early Warnings for All" hosted by Samoa. A member of the secretariat made presentations at (i) UN climate champion event on "Building an Impactful Climate Finance Marketplace" and (ii) Climate and Development Ministerial Technical Workshop 2 co-hosted by UK, Malawi, and Fiji. In addition, the manager accompanied by members of the secretariat held multiple meetings with existing and potential new donor countries including Canada, Denmark, European Commission, Germany, Japan, Ireland, and Spain. The manager also met with the COP28 presidency team including the COP28 Chief Executive Officer.
- (y) 19th meeting of the Executive Committee of the Warsaw International Mechanism (WIM ExCom) for Loss and Damage (21 September, Virtual): The manager was invited by the co-chairs of the WIM ExCom to brief the Committee on Adaptation Fund's relevant work to inform the members' deliberations on possible ways in which the Committee could explore collaboration with the AF. The manager delivered a virtual presentation and responded to questions posted by the WIM ExCom members including on possible areas of collaboration between the two bodies.
- (z) Adaptation Futures 2023 Conference (3-6 October, Montreal, Canada): The Adaptation Fund was one of the official main partners of the leading scientific and technical conference on climate change adaptation, and the manager and members of the secretariat attended. The manager spoke on the opening panel of the conference, and the secretariat organized a side event with on theme "Empowering the most vulnerable, women, youth, elderly, indigenous populations, and incorporating local and traditional knowledge". The secretariat organized a series of sessions related to adaptation innovation, as Innovation Days, with several of the Fund's NIEs and partners participating. The AF-TERG organized a pre-conference "master class" session on ex post evaluations on 2 October.

Preparations for the forty-first Board meeting

Meeting arrangements

4. The Board held its fortieth meeting in Bonn, Germany on 23-24 March 2023, preceded by the Project and Programme Review Committee and the Ethics and Finance Committee, respectively, on 21-22 March 2023.

- 5. The Board decided to hold its forty-first meeting in Bonn, Germany on 10-13 October 2023, including the meetings of the Project and Programme Review Committee (PPRC) and the Ethics and Finance Committee (EFC) and the meeting of the Board.
- 6. The secretariat issued letters of invitation to the Board members and alternates and made travel arrangements for eligible Board members.

Meeting documents

- 7. The secretariat, working closely with the Board Chair and the Committee Chairs and Vice-Chairs, the Technical Evaluation Reference Group for the Fund (AF-TERG) and the trustee, prepared the documents for the forty-first meeting of the Board and for the thirty-second meetings of the Project and Programme Review Committee (PPRC), and of the Ethics and Finance Committee (EFC).
- 8. The full list of documents is contained in document AFB/B.41/Inf.1, List of documents.

Membership of the Board

- 9. The following includes a list of the changes in the membership of the Board as of the date of the issuance of this document.

Implementation of decisions adopted by the Board at its fortieth and earlier meetings and during the ensuing intersessional period

Accreditation-related matter

- (a) Report of the Accreditation Panel
- 11. The secretariat officially communicated the decision to ANII and the Designated Authority of Uruguay, informing that ANII would be welcome to submit to the Adaptation Fund an accreditation application with the Designated Authority's endorsement thereof. (Decision B.40/3)
- (b) Report on the implementation of the top-level management statement
- 12. The secretariat also communicated decision B.40/5 to those applicant implementing entities that have expressed reservations with regard to the existing TLMS template. (Decision B.40/5)

Review of the expressions of interest to join the Adaptation Fund Climate Innovation Accelerator (AFCIA) partnership

13. The secretariat is in the process of planning increasing the outreach to IEs regarding the AFCIA partnership. (Decision B.40/57)

Options for further supporting the work of the Project and Programme Review Committee

14. The secretariat (i) prepared a progress report on the implementation of the pilot with further recommendations for improvement, as appropriate, taking into consideration the developments related to the new medium-term strategy (2023–2027), as well as any other relevant developments and (ii) developed proposals for updating the Operational Policies and Guidelines for Parties to Access Resources from the Adaptation Fund. The secretariat will present the

documents referred to (i) and (ii) to the Project and Programme Review Committee at its thirty-second meeting. (Decision B.40/59)

Assessment for extending the role of intermediary for the readiness package grant

15. The secretariat sent out a notification to all accredited implementing entities of the Fund of the decision B.40/60 by the Board on the extended role of intermediary in the delivery of support for the accreditation of an NIE via the readiness package grant to all accredited implementing entities of the Fund.

Principles and draft terms of reference for the advisory body for innovation

16. The secretariat, in consultation with the Innovation Task Force, finalized the draft of the terms of reference for the advisory body for innovation referred to in document AFB/B.39/10, taking into account the developments with the Adaptation Fund's medium-term strategy (2023–2027) and its implementation plan. The secretariat will present the finalized draft of the terms of reference for Board's decision at its forty-first meeting. (Decision B.40/62)

Report of the Chair of the Technical Evaluation Reference Group

17. The secretariat prepared a review of implications and options for the consideration of the EFC at its thirty-second meeting with regard to a separate budget line for evaluation costs and on evaluation budget guidance being provided to implementing entities as a specific range of the total project budget, including consulting with relevant stakeholders such as the AF-TERG and Adaptation Fund implementing entities. (Decision B.40/66)

Update on implications of the fiduciary issues related to the United Nations Development Programme

18. The secretariat continued engaging with the United Nations Development Programme (UNDP) with a view to ensuring that all completed projects funded by the Adaptation Fund and implemented by UNDP are financially closed, and that final audited financial statements are prepared and submitted in compliance with the Adaptation Fund's Operational Policies and Guidelines (OPG) for Parties to Access Resources from the Adaptation Fund and the project legal agreements between the Board and UNDP. As requested by the Board (decision B.40/68), the secretariat has prepared an update on the matter to the Ethics and Finance Committee at its thirty-second meeting and to be considered as confidential item. In addition, in response to decision B.40/68, paragraph (c) (iii), the secretariat has coordinated with UNDP to submit to the Board intersessionally an official letter addressing Board's requests set out in decision B.37/37, paragraph (c)

Request for a revision of legal agreement

19. The secretariat sent letters to the relevant designated authorities informing them about the delays resulting from the legal issues raised by FAO and communicated the present decision to FAO. The secretariat will report to the Ethics and Finance Committee at its thirty-second meeting on the outcomes of the requests to FAO and propose further steps as necessary. (Decision B.40/70)

Implementation Matter 001

20. The secretariat continued to follow up on Implementation Matter 001 by engaging with the implementing entity concerned and will report back to the Ethics and Finance Committee at its thirty-second meeting. (Decision B.40/71)

Implementation plan for the medium-term strategy of the Fund for the period 2023–2027

- 21. The Board approved the implementation plan for the Fund's medium-term strategy for 2023-2027 at its fortieth meeting. The secretariat was requested by the Board (i) to facilitate the implementation of the plan during the period 2023–2027, (ii) to include the administrative budget for implementing the plan in the administrative budget of the secretariat annually during the strategy period, for consideration by the Ethics and Finance Committee, (iii) to prepare, for each proposed type of new or adjusted grant or funding window, a specific document containing objectives, review criteria, expected grant sizes, implementation modalities, review process and other relevant features and present them for the Board's consideration in accordance with the tentative timeline in annex I to document AFB/B.40/5/Rev.1, (iv) to propose, as necessary following the consideration of the new types of support mentioned in subparagraph (b) (iii), amendments to the Operational Policies and Guidelines for Parties to Access Resources from the Adaptation Fund that would better facilitate the implementation of those new types of support. and (v) to monitor the progress of implementation of the medium-term strategy for 2023–2027, to report on it annually as part of the annual performance reports of the Fund and, if necessary, to propose possible adjustments to the plan during its implementation in conjunction with consideration of the annual work plan. (Decision B.40/72)
- 22. During this reporting period, the secretariat has started the analyses on the proposed funding modalities for Locally Led Adaptation. It is preparing consultations to be held on the margins of COP28 with key stakeholders.
- 23. The secretariat is in a process of preparing an analysis of the provisions of the Operational Policies and Guidelines for Parties to Access Resources from the Adaptation Fund related to the designated authorities of the Fund, with a view to providing options for Fund support to enhance the capacity of designated authorities. The secretariat will present the analysis to the Board for consideration at its forty-second meeting. (Decision B.40/73)

Strategic discussion on objectives and further steps of the Fund. Potential linkages between the Fund and the Green Climate Fund

- 24. The secretariat continued discussions with the Green Climate Fund to advance the collaborative activities identified at the annual dialogue on climate finance delivery channels held in November 2020 and to make progress in implementing the seven activities of the 2019 climate funds collaboration road map (annex I to document AFB/B.36/6). In accordance with the Board decision B.40/74 requesting the secretariat to update the Board annually on the matter referred to in subparagraph (b) (i) of decision B.40/74 through the report on the activities of the secretariat, the secretariat will not provide a written report at this stage. Further update will be provided to the Board at the forty-second meeting of the Board (March 2024).
- 25. The secretariat will update the Board annually on the matter through the report on the activities of the secretariat. (Decision B.40/74)

Options to further enhance civil society participation and engagement in the work of the Board

26. The secretariat (i) updated the draft Adaptation Fund Vision and Guidelines on Enhanced Civil Society Engagement set out in annex 1 to document AFB/B.40/7, based on the discussion at the fortieth meeting of the Board, including discussion of the remaining recommended items by the Adaptation Fund Civil Society Network and (ii) prepared draft guidelines for participation of active civil society observers, taking into account practices of other climate funds. The secretariat will submit the documents to the Board for consideration at its forty-first meeting. (Decision B.40/75)

Objectives and indicators for innovation aspects of projects

27. The secretariat is planning to adopt a comprehensive approach that considers relevant developments concerning results-based management, readiness and knowledge management and their linkages to innovation prior to proposing amendments to the Strategic Results Framework of the Adaptation Fund. The secretariat, in carrying out option 2, will plan to continue consulting with the Technical Evaluation Reference Group of the Adaptation Fund as needed. (Decision B.40/76)

Carbon footprint of the Fund

28. The secretariat considered possible options for reducing the carbon footprint of the Adaptation Fund and prepared a document for the consideration of the Board at its forty-first meeting. (Decision B.40/79)

Issues arising from seventeenth session of the Conference of the Parties serving as meeting of the Parties to the Kyoto Protocol (CMP 17), the fourth session of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA 4) and the twenty-seventh session of the Conference of the Parties (COP 27)

29. The secretariat commissioned an independent review of the Environmental and Social Policy of the Adaptation Fund (ESP) with a view to updating the ESP. In parallel, the secretariat

also launched the surveys of the ESP targeting the Board, Implementing Entities, Designated Authorities, and Civil Society Organizations, respectively, and the survey results have been fed into the review of the ESP. The secretariat will present the outcome of the independent technical review of the ESP and the results of the ESP surveys to the Board at its forty-first meeting. (Decision B.40/80)

- 30. The secretariat also prepared a document with options for a policy on safeguarding against sexual exploitation and abuse and sexual harassment (SEAH) and will present it to the Board at its forty-first meeting. (Decision B.40/80)
- 31. The secretariat, in line with the request to produce a report on actual aggregated project results to be included in its annual report to the CMP at its eighteenth session and the CMA at its fifth session, is preparing an addendum on aggregated results of finalized projects and programmes funded by the Adaptation Fund, in particular across the Fund's five core indicators, accompanied by qualitative analysis of successes, challenges and lessons learned. Additionally, in line with the Board's request to update and strengthen the Fund's Strategic Results Framework (SRF) in alignment with the Medium-Term Strategy II, the secretariat commissioned the work for the revision of the Fund's SRF, which will be finalized taking into account recent programmatic developments under the MTSII and will be submitted for the Board's consideration at its Forty-Second meeting.
- 32. The secretariat continued consultations with the secretariat of the United Nations Framework Convention on Climate Change, the trustee and any other relevant stakeholders with a view to the timely preparation of the arrangements for the transition of the Adaptation Fund from the Kyoto Protocol to the Paris Agreement, as per decision 1/CMP.14, paragraph 2 and will report on the status of the work to the Board at its forty-first meeting. (Decision B.40/80)
- 33. The secretariat, with the trustee, continued consultations with the secretariat of the United Nations Framework Convention on Climate Change and any other relevant stakeholders with a view to the timely development of a strategy on monetization of Article 6, paragraph 4, emission reductions (A6.4ERs) and will report on the status of the work to the Board at its forty-first meeting. (Decision B.40/80)

Readiness Programme

34. During the reporting period, the secretariat implemented the following activities under the Readiness Programme⁵:

a) The secretariat completed the review process for readiness grants for the intersessional period between the fortieth and forty-first meetings of the Board.

- b) The secretariat hosted the 15th Webinar in the Funds readiness webinar series on 24 April 2023, under the topic "Climate change reasoning for adaptation project development.". The webinar discussed the Fund's approach to adaptation reasoning and the lessons that can be learnt from previous project submissions.
- c) The secretariat participated virtually at the Fourth Meeting of the PCCB Network on 25 April 2023. The meeting represented the third anniversary of the PCCB and discussed achievements of the PCCB in 2022, the upcoming events in 2023 and three areas of collective engagement: engagement with non-governmental organizations (NGOs) and civil society organizations (CSOs); engaging the public and private sector; and engaging academia and research institutions.
- d) The secretariat facilitated a climate finance readiness workshop on Enhanced Direct Access in Kigali, Rwanda on 9-11 May 2023. The workshop provided a platform for countries to share and exchange lessons, knowledge, and experiences in the programming of EDA funding, to boost confidence as well as encourage the programming of climate finance through EDA.
- e) The secretariat hosted a webinar on gender on 24 May 2023. The webinar discussed gender-responsive project/programme design and implementation reporting and provided participants with technical tools and good practices to ensure compliance with the AF Gender Policy.
- f) The secretariat hosted a country exchange in Indonesia held on 5-9 June 2023 in Semarang and Pekalongan (Central Java), Indonesia, under the theme: Ecosystem Based Adaptation. The event was held in partnership with the Fund's accredited NIE, the Partnership for Governance Reform in Indonesia (Kemitraan). The country exchange facilitated interaction and engagement between participating accredited National Implementing Entities (NIEs) and multiple Kemitraan project stakeholders, and benchmarking for best practice for projects and programmes under this sector.
- g) The secretariat hosted the 2023 Annual NIE Seminar in Santo Domingo, Dominican Republic on 12-15 September 2023 for its accredited national implementing entities. The seminar provided a platform for entities to discuss monitoring and evaluation of ecosystem-based interventions/adaptation actions, enhancing access to climate finance under the AF new funding windows, mainstreaming of environmental, social, and gender issues in adaptation projects and programmes, AF project Innovations, and project performance report submissions.
- h) The secretariat plans to host the following event in October 2023:
 - Adaptation Fund Readiness Webinar #16 as part of the AF readiness webinar series for the Fund's accredited NIEs.

Communications

- 35. Since the 40th meeting of the Board, the secretariat continued an effective strategy of producing and disseminating engaging content in the news stream highlighting tangible actions on the ground, emerging Fund programs and ongoing adaptation demand targeting key stakeholder audiences to highlight the Fund's work, project beneficiaries on the ground, key Fund events and project sharing knowledge exchanges in countries. The secretariat worked closely with implementing partners and other stakeholders to showcase the Fund's projects and programmes in action via videos, stories, outreach, and media. It also presented other activities of the Fund through social media, photo albums, flyers, and other platforms. These efforts significantly grew the Fund's website readership, as well as partnerships with key communications colleagues from other funds, implementing and executing entities, CSOs, UNFCCC and other stakeholders.
- 36. From 24 March to 24 July 2023, the secretariat developed five original news releases, four project stories in collaboration with partner Climate Home News, as well as two Flickr photo essays, two videos, and two original project stories as well as a podcast and brochure, and timely e-newsletters. It also reshared stories and videos on projects developed by the Fund's partners. It set up dedicated webpages on timely events, such as the Bonn Climate Change Conference (5-15 June 2023, Bonn, Germany) and the Adaptation Futures Conference (2-6 October 2023, Montreal, Canada). It developed various sets of talking points utilized in high-level speeches made in the Indonesia country exchange, media and other events.
- 37. The secretariat posted frequently to the Fund's website and social media platforms, which drew continued significant growth across the board. From 24 March to 24 July 2023, the website had 40,062 users (a 9.3% increase over the 35,050 it had in the same period last year) and 38,465 new users (9.7% rise over 36,652). It also had 303,364 page views, marking a 16.5% increase over last year's number of 260,441. On social media, the Fund gained 674 new Twitter followers, reaching 22,100. It also added 612 Facebook followers and 857 LinkedIn followers, bringing it to nearly 6,000 on LinkedIn.
- 38. The secretariat has continued to innovate and grow its communications platforms, including developing new podcasts, blogs and short videos as well as emerging platforms, and extending partnerships with media such as Climate Home News, enabling the Fund to reach larger audiences and additional project and programme areas and story themes. It visited an innovative project and country exchange in Indonesia, and gathered drone footage, many photos and interviews to put together a series of written and multimedia stories for the website and social media, which were widely shared and resonated well. The secretariat is also in regular contact with communications colleagues from implementing entities, UNFCCC, and others to share key Fund stories and multiply reach to targeted audiences. The secretariat also worked with a new IT team to monitor and make periodic enhancements to ensure the website continues to be user-friendly, interconnected, intuitive and secure.

Knowledge Management

- 39. The secretariat completed a study on "the role of national financial institutions and trust funds in providing climate adaptation lessons learned from the Adaptation Fund". The study provides an overview of the role financial entities can have in channeling climate finance, presents an assessment of the seven AF NIEs identified for this study and draws lessons learned from their experience.
- 40. The secretariat completed a second study on "strengthening resilience through disaster risk reduction and early warning systems". This study offers an overview of the Fund's experience and lessons learned on disaster risk reduction and early warning systems interventions in strengthening long-term resilience to climate change, including case studies from across the portfolio. The secretariat plans to disseminate and share the findings of this study at a side event at the COP28 and in other global relevant conferences.
- 41. A third study completed during this reporting period focuses on climate change adaptation in fragile and conflict-affected countries. The study presents an overview of the Fund's experience and lessons learned from addressing climate change adaptation and strengthening long-term resilience to climate change in fragile and conflict-afflicted countries.
- 42. The secretariat prepared terms of reference for another study on lessons learned from adaptation interventions in least developed countries. The study will include case studies from the Fund's portfolio to capture knowledge from different projects and programs showcasing adaptation interventions and impact achieved so far in strengthening resilience to climate change in the LDCs.
- 43. The secretariat completed a training course on enhanced direct access grants aimed at increasing understanding among national implementing entities on the review criteria, eligibility, and characteristics of enhanced direct access grants with the final purpose of submitting successful proposals. The course is self-paced and is available in English, Spanish and French.
- 44. The secretariat initiated the work on updating the existing Knowledge Management Strategy and Action Plan whose objective is to help enhance recipient countries' knowledge to reduce vulnerability and increase adaptive capacity, especially of the most vulnerable communities. The initial survey is scheduled to go out to Fund's stakeholders in mid-September.
- 45. The secretariat organized a Knowledge Fair as part of the Country Exchange organized jointly with the host NIE in Indonesia. The Knowledge Fair builds on Country Exchange goals and approach to enhance capacities for project design through adult-learning and knowledge sharing for participating projects and NIEs. The objective of this Knowledge Fair was to exchange lessons learned, challenges and experiences among the participating NIEs from the implementation of their projects with elements of ecosystem-based adaptation. A brochure on lessons learned from the knowledge fair is in the final stages of completion and will be shared with all participants.
- 46. The secretariat also participated at the Adaptation Futures Conference 2023 in Montreal, Canada in October 2023. The secretariat organized a side event that featured Fund's impact and results in climate adaptation, particularly as it relates to locally led action.

Accreditation

47. The fortieth meeting of the Accreditation Panel was held in Washington, D.C. on 5-6 September 2023. During the reporting period, the secretariat received new accreditation applications from two applicant NIEs. The Panel continued reviewing 14 re-accreditation applications (nine NIEs, one Regional Implementing Entities (RIEs) and four Multilateral Implementing Entities (MIEs)) and 15 accreditation applications of 13 potential NIEs, one potential RIE and one potential MIE that were previously reviewed but required additional information for the Panel's review. During the meeting, the secretariat provided updates on the two technical intersessional meetings it facilitated on 13 April and 19 May 2023 during which Panel experts discussed a range of issues aimed at improving efficiency and effectiveness in the review of (re)accreditation applications. The secretariat also informed the Panel about a study it had commissioned on the lessons learned from the Fund's (re)accreditation of national financial institutions and trust funds and the role of such entities in providing climate adaptation. The overarching goal of the study was to help reduce the time required for the completion of (re)accreditation applications from prospective applicants with similar characteristics by sharing the experiences of others in the process. During the meeting, the secretariat also indicated to the Panel that it had, as per Decision B.40/80, commissioned an independent review of the Fund's ESP with a view to updating the policy. Preliminary findings from the review were shared with the Panel and the implications of the review on the (re)accreditation process discussed. The Panel also discussed matters related to the Quality at Entry and Project Performance Review and the progress of both the Panel and the secretariat in developing a scorecard for assessing relevant re-accreditation applications as per paragraphs 18-20 of Fund's re-accreditation policy. The secretariat also presented the readiness support for (re)accreditation under the second Medium-Term Strategy (2023-2027) of the Fund and lessons learned from its participation at five UNFCCC Needs-based Finance regional workshops as well as engagement with UN4NAPS at the 58th intersessional conference of the subsidiary bodies held in June 2023 in Bonn, Germany. The report of the Panel's fortieth meeting is available on the Fund's website as part of the documents for the forty-first meeting of the Board.

Screening/technical review of project/programme proposals

48. In preparation for the forty-first meeting of the Board in October 2023, the secretariat screened and prepared technical reviews of four fully-developed single-country project

documents and four single country concepts, as well as one regional fully-developed project documents, one regional concepts, and one regional pre-concepts. In addition, the secretariat screened and technically reviewed one innovation small grant proposal. The secretariat screened and technically reviewed three fully-developed global proposals for the Adaptation Fund Climate Innovation Accelerator (AFCIA) which provide coordination services for the AFCIA partnership, as well as two fully-developed proposals and two concept note proposals for Enhanced Direct Access. In performing these tasks, the secretariat team was supported by GEF Secretariat technical staff, and seven contracted technical experts.

49. During the intersessional period between the fortieth and forty-first meetings of the Board, two projects that were waitlisted at the forty-first meeting were approved: one single-country project and one regional project.

Review of Project Performance Reports and project/programme no-cost extension requests

- 50. Following the Board Decision B.28/47 at its twenty-eighth meeting to delegate to the secretariat its authority to approve technical review and clearance of the Project Performance Reports (PPRs) prior to authorization by the Chair of the cash transfer of funding tranches, the secretariat has completed the review, cleared, and made publicly available on the Fund's website:
 - (a) The first PPR for the project implemented in Argentina and Uruguay (CAF, inception date: August 2021);
 - (b) The second PPR for the project implemented in: Benin, Burkina Faso, Ghana, Niger, Togo (BOAD, inception date: November 2020); Niger (BOAD, inception date: March 2020); Guinea-Bissau (BOAD, inception date: January 2020); Lao People's Democratic Republic (UN-Habitat, inception date: June 2020) Malawi (UNWFP, inception date: June 2020); Tajikistan (UNDP, inception date: August 2021); Special Financing Window in Support of Innovation for Adaptation (UNEP, inception date: October 2020); Adaptation Fund UNDP Innovation Small Grant Aggregator Platform (ISGAP) (UNDP, inception date: October 2020);
 - (c) The third PPR for the project implemented in Albania, Montenegro, North Macedonia (UNDP, inception date: October 2019);
 - (d) The fourth PPR for the projects implemented in Ethiopia, Kenya, Uganda (WMO, inception date: August 2018); Panama (Fundación Natura, inception date: June 2018);
 - (e) The fifth PPR for the project implemented in Lao People's Democratic Republic (UN-Habitat, inception date: February 2017);
 - (f) The sixth PPR for the project implemented in Jordan (MOPIC, inception date: July 2016).

- 51. In this intersessional period, the secretariat received five requests for project changes under the regular process. These were approved by the Board and a corresponding decision was transmitted to the IE. The requests received are listed below:
 - (a) Request for revision of disbursement schedule: Special Financing Window in Support of Innovation for Adaptation (UNEP);
 - (b) Request for change of project pilot sites: Central Asia (UNESCO);
 - (c) Request for no-cost extension of project completion date: Armenia Innovation mall Grant (EPIU);
 - (d) Request for no-cost extension of project completion date: Jamaica (PIOJ);
 - (e) Request for no-cost extension of project completion date: Uganda (OSS).
- 52. As per Board Decisions B.35.b/16 and B.40/69, which include a temporary provision for a maximum of two no-cost extensions of the project completion date up to 12 months for projects/programmes which have been delayed due to the COVID-19 pandemic and which are set to be completed within 24 months from the date of the extension request, the secretariat received intersessionally six no-cost project/programme extension requests. The secretariat proceeded screening the requests and found that they were compliant with the criteria referred to in both decisions mentioned above. The requests received and cleared by the secretariat as of the date of the issuance of this document are listed below:
 - (a) No cost extension of project completion date: Lao People's Democratic Republic (UN-Habitat):
 - (b) No cost extension of project completion date: Madagascar, Malawi, Mozambique, Union of Comoros (UN-Habitat);

Gender

- 53. The secretariat held the second Gender Webinar in May 2023 targeting its implementing entities (IEs). This webinar provided opportunities for IEs to enhance understanding on the Gender Policy of the Fund and its updated gender guidance document as well as available financial and technical support related to gender mainstreaming in the Fund. Additionally, it included an interactive session where IEs shared best practices for and challenges in conducting gender assessment, establishing gender-disaggregated indicators and designing gender responsive interventions and gender action plan for project and programme.
- 54. In June 2023, the secretariat held a gender session during the Fund's Enhanced Direct Access (EDA) workshop in Rwanda, focused on how to integrate gender considerations in

designing an EDA proposal, prepare and implement gender-responsive budgeting and report gender progress made in the projects through Fund's Project Performance Report template.

- 55. The Fund's updated Gender Guidance Document for IEs on Compliance with the Fund's Gender Policy has been also translated into French and Spanish are available on the Fund's website.
- 56. The secretariat has developed and started implementing the AF gender scorecard (GSC) with the aim of enhancing the Fund's monitoring of its GP implementation at the Fund's portfoliowide level. GSC is to produce an outcome of a process of data and information collection and analysis of the Fund's portfolio. In this initial phase the secretariat has started applying the GSC against regular projects and programmes at two stages: (i) at entry; and (ii) during implementation and exit. The secretariat will annually report outcome of the GSC to the Board through the AF annual performance report.
- 57. Collaboration on gender considerations with partner organizations, including other climate funds, and the UNFCCC secretariat continued. The Vice-Chair of the Board participated in the 51st session of the Subsidiary Bodies (SB 51) mandated in-session dialogue between Chairs of UNFCCC constituted Bodies on progress in integrating a gender perspective into constituted body process, sharing AF experiences, achievement, key enablers, and collaboration with other organizations in integrating gender into the Fund's work.

Resource mobilization

- 58. The Fund has continued to be very active in its effort to support activities related to resource mobilization both at the strategic and communication levels. The Fund's MTS 2023 2027 and its Resource Mobilization Strategy and Action Plan 2022 2025, both approved at the Board's 39th meeting, collectively provide a framework for how the Fund intents to engage with various stakeholders to secure increasing resources from various sources in order to support the most vulnerable communities in adapting to climate change. The secretariat has continued its efforts in implementing the approved resource mobilization strategy and action plan and second MTS.
- 59. The secretariat is taking steps for active outreach and communication to existing and potential new contributor governments on the new resource mobilization target of USD 300 million per year from a higher number of contributors than the previous year, as set by the Board at its 40th meeting. The current status of the AF Resource Mobilization for year 2023 is reported in Annex III. The steps for active outreach are as follows:
 - (a) The secretariat has started active engagement with the incoming COP28 Presidency and the UNFCCC Secretariat on their support in advocating for the AF's resource mobilization target, including through the organization of the 2023 contributor dialogue, to be convened in conjunction with COP 28 in Dubai, UAE;

- (b) The secretariat has also started the publication of a quarterly resource mobilization newsletter with relevant AF updates and themes of interest to existing and potential new contributor governments; and
- (c) The secretariat has reached out and met bilaterally with a number of interested contributor governments during the SB58 Bonn Climate Change Conference in June 2023 and the UN Climate Ambition Summit.
- 60. The Fund also took further action in the area of contributions from sources alternative to government funding, such as foundations, charitable organizations, non-profit organizations, private individuals and private sector companies. The secretariat liaised with the United Nations Foundation (UNF) to transfer the financial donations received through the UNF's private donation route ("Donate Button"), established in 2012. The Fund periodically promoted the opportunity for the private sector and individuals to donate to the Trust Fund.
- 61. The secretariat, together with the trustee, has been actively engaging with UNFCCC and other relevant stakeholders on the timely development of a strategy of monetization of Article 6, paragraph 4, emission reductions (A6.4ER). The secretariat has also been engaging with relevant stakeholders on other relevant carbon trading schemes, such as the Integrity Council for Voluntary Carbon Markets (ICVCM) the IMO on their discussions on emissions trading in the shipping sector.

Ad Hoc Complaint Handling Mechanism

62. The secretariat has not received any eligible complaint during this reporting period.

Personnel

- 63. Ms. Naysa Ahuja was recruited through an open competitive process as Program Officer (accreditation) and entered on duty on 15 May 2023.
- 64. Mr. Marcus Johannesson was recruited as Senior Climate Change Specialist, funded by the Government of Sweden, through a targeted competitive process, to support the secretariat across different areas of the secretariat, and entered on duty on 15 May 2023.
- 65. Ms. Ishani Debnath, a former Short-Term Consultant, was recruited through an open competitive process as an Extended-Term Consultant to support the Readiness Programme within the Countries and Partnerships Unit and entered on duty on 2 October 2023.

Annex III: Report on the Adaptation Fund Resource Mobilization for year 2023

1. RESOURCE MOBILIZATION TARGET FOR CALENDAR YEAR 2023

The Adaptation Fund Board, at its fortieth meeting, having considered its discussions at its previous meeting on resource mobilization strategy and action plan for the period 2022–2025, and following discussions at the fortieth meeting, set a new resource mobilization target of (a) an amount of USD 300 million for 2023 and (b) a higher number of contributors than the previous year (decision B.40/77). The target can be viewed against the active pipeline of projects and programmes already submitted to the Board for consideration but not yet approved, totaling USD 480 million, and the projected range of programming during the second Medium-term Strategy (MTS II) for 2023–2027 of USD 1.2 billion to 2.0 billion under the main funding window alone.

2. 2023 YEARLY PLEDGED AMOUNT AS AT 5 OCTOBER 2023

As at 5 October 2023 a total of USDeq 37.7 million in new pledges has been publicly announced or communicated to the secretariat, by contributor governments towards the 2023 resource mobilization target of USD 300 million set by the Board through decision B.40/77. In addition, based on multiyear pledges announced as such in previous years, it is expected that a total of USD 7.9 million will be transferred to the Fund by contributor governments in 2023 as the scheduled tranches of those multiyear pledges, thereby bringing the currently expected, previously unaccounted funding to USD 45.6 million.

With regard to pledges made in previous years without reference to a disbursement calendar at the time of pledging, about USDeq 162.4 million is outstanding, including USD 100 million pledged by the United States, EUR 50 million pledged by the European Commission, EUR 5 million by France and CHF 4 million by Switzerland (noting with appreciation that the Fund has received EUR 50 million contributed by the European Commission, EUR 5 million by France and CHF 6 million by Switzerland).

3. RESOURCE MOBILIZATION PROSPECT FOR 2023

The resource mobilization prospect for the Fund for 2023 is currently uncertain as several contributor governments have not yet signaled their pledges. Different contributor governments have in informal communications referred to competing priorities during the current year. Then again, judging by the experience of prior years, contributor governments often make decisions on the size of their contributions rather late, and therefore the absence of pledges at the time of the 41st Board meeting does not necessarily predict lower resource mobilization outcome.

It is worth noting that some governments had made to the Fund pledges that were at the time of pledging understood to be regular, once-disbursable contributions, but have afterwards been specified to instead be disbursed over a number of years. This, in practice, lowers the expectation of resource mobilization per annum.

There is no evident reason to believe the trend of the total value received through sales of CERs will drastically change in FY24. The share of proceeds of 5 percent to be derived from the mechanism under Paris Agreement Article 6.4 has not yielded revenue to the Fund, yet.
