BOARD DECISIONS ON ROLLING BASIS

AFB39

- To invite the implementing entities of the Adaptation Fund to submit, on a rolling basis as described under option 3 in document AFB/PPRC.30/55, proposals for projects or programmes under the innovation, enhanced direct access, learning and scale-up grants funding windows, on a pilot basis; **(Decision B.39/53)**

AFB40

- To extend the piloting of the rolling-basis submissions, in line with the elements described and improvements suggested under paragraph 18 of document AFB/PPRC.31/60, to concrete adaptation projects under the action pillar of the Adaptation Fund's medium-term strategy for 2023–2027 (single country and regional projects); **(Decision B.40/59)**

AFB41

- Maintain the piloting of the rolling-basis submissions process for all funding windows, as described in document AFB/PPRC.31/60 and approved by decision B.40/59; **(Decision B.41/21)**



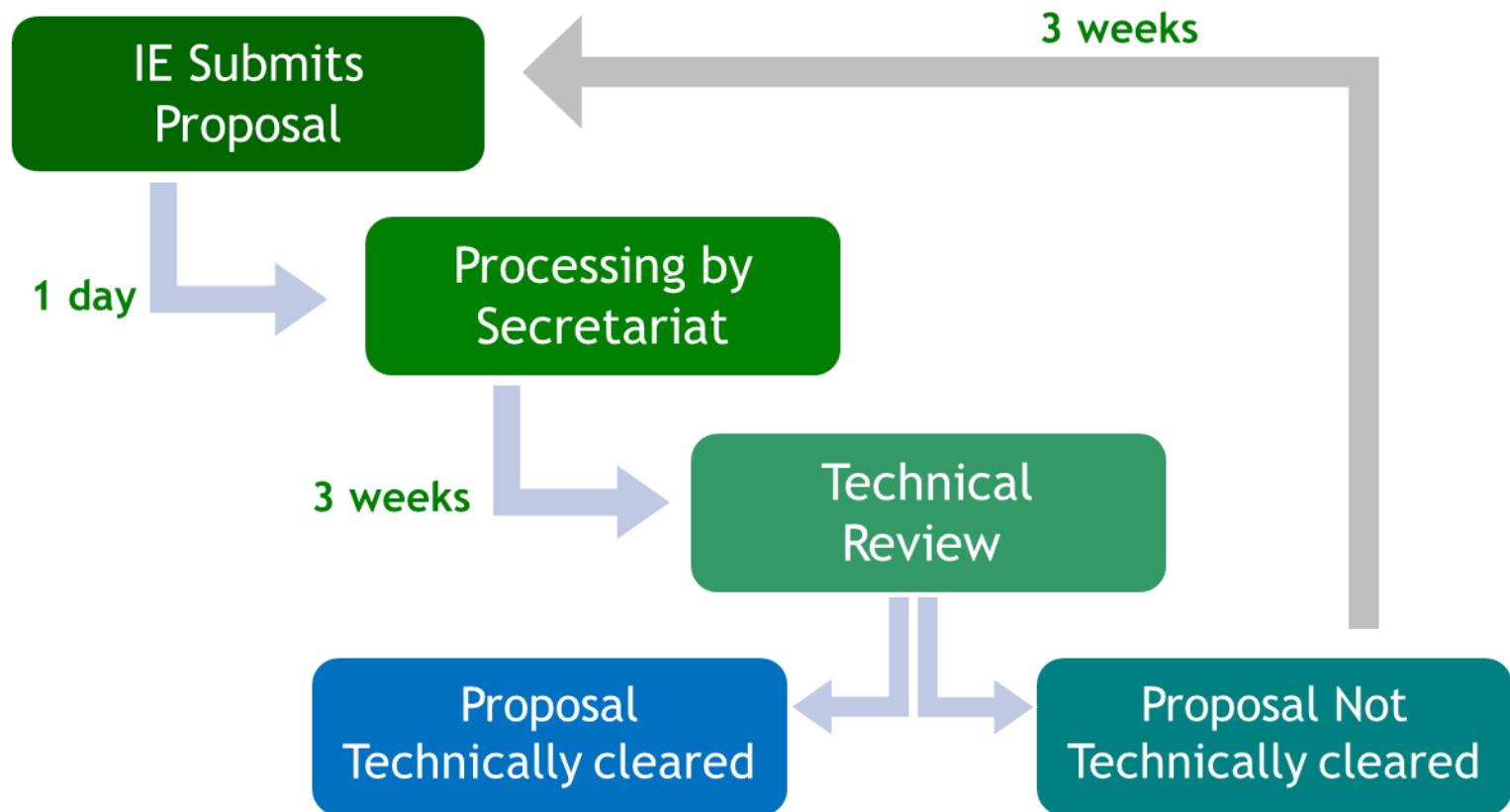
ADAPTATION FUND

Implementation steps

- **Formal notification** to the IEs on 17 April 2023 by the Head of the Adaptation Fund Board Secretariat.
- **Email reminders:** Subsequent reminders sent by the Secretariat in May and July 2023.
- **Webinars** explaining the changes in the pilot process. These webinars were held on May 19, May 25 and June 1, 2023
- **Posting:** Proposals under review page
- **Notifications** to the Board at least 3 weeks before Board meeting and CSO Network

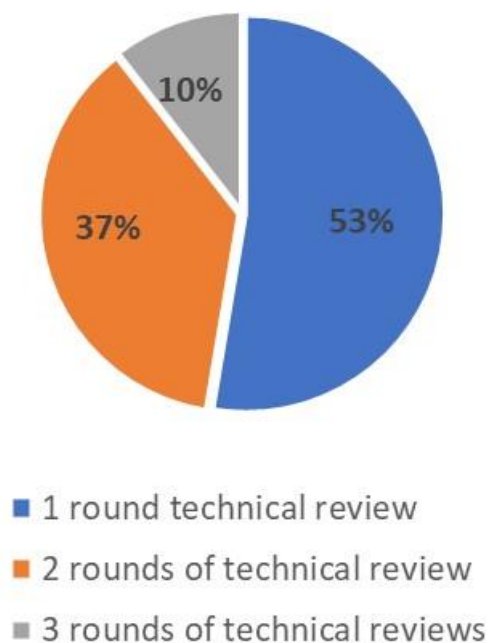


Rolling basis SUBMISSION process

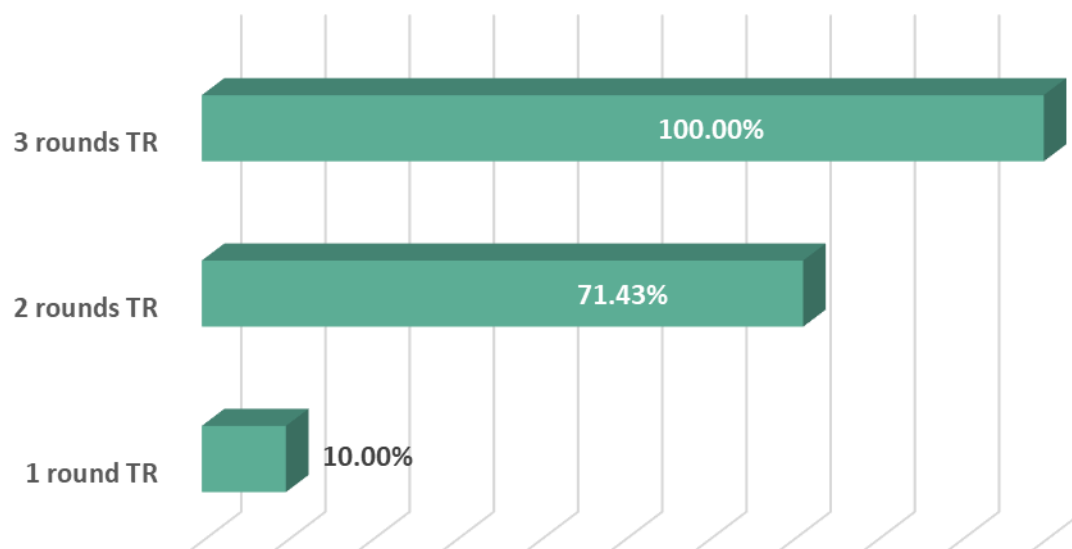


Regular Proposals submitted at AFB41
