REPORT OF THE FORTY-THIRD MEETING OF THE ACCREDITATION PANEL

Strategic Issues

- a) Reporting on the work of the Accreditation Panel with respect to accreditation and reaccreditation application portfolio
- b) The number of (re)accreditation applications in the pipeline is increasing considerably, with a total of 46 applications out of which 30 under review
- c) The secretariat received new accreditation applications for three (3) National Implementing Entities (NIEs) and one (1) Regional Implementing Entity
- d) The Panel adopted a guidance document and approach document as living documents, after a thorough consultation, to ensure consistency and efficiency in the review process and the preparation of assessment reports for (re-)accreditation applications
- e) During the intersessional period between the forty-second and the forty-third meetings of the Panel, the Panel recommended not to re-accredit NIE069 as the entity could not meet all the standards and criteria required to achieve reaccreditation as per the reaccreditation process of the fund
- f) Considering the preliminary analysis of (re)accreditation pipeline and the current workload presented by the Secretariat, which has potential impact on the turnaround time for completing application reviews, the Panel proposed a recommendation for the Board's consideration at its forty-fourth meeting

Purpose

 This board paper asks the Board to note the updates on the (re-)accreditation portfolio and to approve the Accreditation Panel's recommendation requesting the secretariat to conduct an indepth analysis of the re-accreditation approach with the view to assess the long-term operational and budgetary implications.

Recommended Decision

- 2. Having considered the preliminary reporting on the status of re-accreditation process at the Fund, the Accreditation Panel recommends that the Board requests the secretariat:
 - a) to initiate work to conduct an in-depth analysis of the re-accreditation approach with the view to assess the long-term operational and budgetary implications, and
- b) to present the outcome of said analysis to the Accreditation Panel at its forty-fourth meeting.

(Recommendation AFB/AP.43/1)

3. Having considered the recommendation of the Accreditation Panel, the Adaptation Fund Board decides to accredit the National Environment Trust Fund (NETFUND) of Kenya as a National Implementing Entity (NIE) of the Adaptation Fund for five years, as per paragraph 39 of the operational policies and guidelines for Parties to access resources from the Adaptation Fund. The accreditation expiration date is 10 April 2030.

(Recommendation AFB/AP.43/2)

4. Having considered the recommendation of the Accreditation Panel, the Adaptation Fund Board decided to re-accredit the Protected Areas Conservation Trust (PACT) as a National Implementing Entity (NIE) of the Adaptation Fund for five years, as per paragraph 39 of the operational policies and guidelines for Parties to access resources from the Adaptation Fund. The accreditation expiration date is 10 April 2030.

(Recommendation AFB/AP.43/3)

5. Having considered the recommendation of the Accreditation Panel and following the reaccreditation process approved by Decisions B.28/38 and B.34/3, the Adaptation Fund Board decides to re-accredit the Interprofessional Fund for Agricultural Research and Advice (FIRCA) of Côte d'Ivoire as a National Implementing Entity (NIE) of the Adaptation Fund for five years, as per paragraph 39 of the operational policies and guidelines for Parties to access resources from the Adaptation Fund. The accreditation expiration date is 10 April 2030.

(Recommendation AFB/AP.43/4)

Background

- 6. The Accreditation Panel (the Panel) continued its work reviewing existing applications. The Panel held its forty-third meeting (AP43) on 3-4 February 2025 in Washington DC. The Chair of the Accreditation Panel, Mr. Naresh Sharma (Nepal, Least Developed Countries), presided over the meeting.
- 7. For the forty-third Panel meeting, the Adaptation Fund Board Secretariat (the secretariat) received new accreditation applications for three national implementing entities (NIEs) and one regional implementing entity (RIE). The Panel continued reviewing 14 re-accreditation applications (10 NIEs, two Regional Implementing Entity (RIEs), and two Multilateral Implementing Entities (MIEs)) and 19 accreditation applications of 18 potential NIEs and one potential RIE that were previously reviewed but required additional information for the Panel's review. The accreditation applications of two of the NIE candidates have been dormant for at least 6-month period. Therefore, in accordance with Decision B.31/26, the Secretariat sent the first, letters notifying the respective DAs about the inactivity of the entities on 3 February 2025.
- 8. After considering the recommendation by the Panel, the Adaptation Fund Board (the Board) had intersessionally approved during the period from 30 August 2024 to 2 February 2025, the fast-track re-accreditation of the Agence pour le Développement Agricole (ADA) as NIE of the Fund (Decision B.42-43/24); accreditation of the Fondo para la Acción Ambiental y la Niñez (Fondo Acción) of Colombia as NIE of the Fund (Decision B.43-44/2); and fast track accreditation of the Nature Trust for Nature Conservation (NTNC) of Nepal as NIE of the Adaptation Fund (Decision B.43-44/7).

- 9. During the intersessional period between the forty-second and the forty-third meetings of the Panel, the Panel recommended the de-accreditation of NIE069 as the entity could not meet all the standards and criteria required to achieve reaccreditation as per the re-accreditation process of the fund. During the same period, the Panel completed the assessment of the regular accreditation application from NIE142 and made a recommendation to the Board for accreditation. At the time of this report, the Panel recommendation for accreditation was being considered by the Board.
- 10. As of the forty-third meeting of the Panel,19 accreditation applications, comprising of 18 potential NIEs and one potential RIE were under review by the Panel as per the following list:

GENERAL TRENDS




Figure 2. LDCs and SIDS among accredited NIEs





Figure 3. Accredited NIEs and RIEs by region

11. As of 4 February 2025, the total number of accredited implementing entities amounted to 58: 34 NIEs, nine RIEs, and 15 MIEs (Figure 1). Among the 34 NIEs, there were 11 accredited NIEs that were from Least Developed Countries (LDCs) and six accredited NIEs that were from Small Islands Developing States (SIDS) (Figure 2). Out of the 58 accredited implementing entities of the Fund, 40 entities (69%) had been re-accredited: 21 NIEs, 6 RIEs and 12 MIEs. With respect to the geographic coverage of the 34 NIEs and 9 RIEs, 16 entities were from Latin America and the Caribbean (LAC), 14 were from Africa, 12 were from Asia-Pacific and 1 was from Eastern Europe (EE) (Figure 3). As per Decision B.36/42, the Secretariat has to date, received nominations from the Designated Authorities (DAs) of 11 countries for a second NIE to pursue accreditation with the Fund.

Figure 1. Accredited Implementing Entities by type

OTHER MATTERS

Streamlining of AP assessment reports:

13. This discussion was led by a former Panel member who was engaged by the secretariat during the intersessional period between the AP42 and AP43 meetings to lead the ongoing efforts to streamline assessment reports in line with the Board Decisions B.42/4 and B.43/2. During the intersessional period between the AP42 and AP43 meetings, the consultant engaged in extensive consultations with both the Panel and the secretariat. These consultations led to the development of two key documents: (i) a guidance document for preparing the Panel's assessment reports on (re-)accreditation applications and the associated note to the Board, and (ii) an approach document defining the roles and responsibilities of the Panel with respect to quality assurance, aimed at enhancing efficiency in the application review process. During the meeting, it was clarified that the guidance document establishes the Panel's agreed principles and procedures for preparing assessment reports, fostering greater consistency and efficiency in the Panel's operations. The approach document, on the other hand, focuses on detailing the Panel's working practices, further promoting efficiency and quality assurance throughout the review of (re-)accreditation applications. The consultant emphasized the robustness of the consultation process, which involved nine meetings and detailed discussions with both the Panel and the secretariat. The Panel commended the thorough and inclusive approach, noting that their comments and inputs were thoughtfully incorporated. They expressed satisfaction with the progress made and the quality of the documents developed during the intersessional period. The Panel agreed to adopt the documents as guidance to ensure consistency and efficiency in the review process and the preparation of assessment reports for (re-)accreditation applications. The Panel recognized these as living documents, subject to periodic revision based on practical experience, with the aim of continually enhancing the efficiency, consistency, and quality assurance of the (re-)accreditation application review process.

Brainstorming on Adaptation Fund re-accreditation process:

14. The Secretariat presented an analysis of the (re-)accreditation pipeline, highlighting the current workload, the distribution of applications among Panel Experts, the pipeline of applications under screening, and the potential impact on the turnaround time for completing application reviews. Additionally, recent developments at the Green Climate Fund (GCF) concerning reaccreditation were presented, emphasizing their implications for operational complementarity between the two funds on (re-)accreditation. The Secretariat outlined key insights from the 37th meeting of the GCF Board, where an analysis of the accredited entities portfolio identified some challenges with the GCF re-accreditation process. These included the time-consuming and resource-intensive nature of the process for both the GCF Secretariat and applicant entities. In response, the GCF Board decided, through Decision GCF/B.37/18, to temporarily pause reaccreditation. Further developments were detailed in Decision GCF/B.40/15, where the Board acknowledged the inefficiencies in the existing accreditation process and highlighted the need for a revised accreditation framework. This background information provided valuable context for the Panel's discussion on the matter. Following deliberations, the Panel advised that further intersessional analysis of the issue would be essential to informing the next steps for the AF reaccreditation process. Consequently, the Panel proposed the recommendation outlined in this document for the Board's consideration at its forty-fourth meeting, scheduled for April 2025.

Update on the Strategic Results Framework of the Adaptation Fund:

15. This was an information session, during which the secretariat informed the Panel of the ongoing efforts to revise the Strategic Results Framework (SRF) of the Fund. The secretariat highlighted the key activities undertaken thus far, including consultations with implementing entities conducted both in-person and virtually; a preliminary analysis of the results frameworks of sister climate funds to identify gaps and best practices; and a draft analysis of the gaps and challenges and potential solutions. The Secretariat emphasized that the revised SRF aims to align more closely with the Global Goal on Adaptation, provide flexibility to accommodate local conditions and realities, address challenges related to measurement and attribution, and focus on capacity building to support use and uptake. The Panel found the discussion insightful and emphasized the importance of the ongoing work in the context of the (re-)accreditation process. They mentioned that the revised SRF will be critical for the Panel's assessment of project implementation competencies and project performance for entities in the Workflow.
