REPORT OF THE FORTY-FIFTH MEETING OF THE ADAPTATION FUND BOARD

Introduction

1. The forty-fifth meeting of the Adaptation Fund Board (the Board) was held in person in Bonn, Germany, on 9 and 10 October 2025, back-to-back with the thirty-sixth meetings of the Project and Programme Review Committee (PPRC) and Ethics and Finance Committee (EFC) of the Board on 7 and 8 October 2025. The meeting was preceded by an informal session, held on 6 October and continued on the afternoon of 8 October, to discuss the implications of decision 1/CMA.6, on the new collective quantified goal on climate finance.
2. The list of the members and alternate members who participated in the meeting is attached as annex I. A list of accredited observers present at the meeting can be found in document AFB/B.45/Inf.2.

Item 1. Opening of the meeting

3. As the Chair of the Board was unable to attend the meeting, the meeting was opened at 9.15 a.m. on 9 October 2025 by the Vice-Chair, Washington Zhakata (Zimbabwe, Africa), in accordance with paragraph 11 of the Rules of procedure of the Adaptation Fund Board.

Item 2. Adoption of the agenda

4. The Board adopted the agenda for its forty-fifth meeting on the basis of the provisional agenda (AFB/B.45/1). The agenda is set out in annex II to the present report.
5. In adopting the agenda, the Board agreed to consider two matters under agenda item 20, “Other matters”:
 - (a) Application of the “roll over” principle for terms of members and alternates;
 - (b) Constitution of task forces and working groups.

Item 3. Report on the activities of the Chair

7. Given the absence of the Chair, the Vice-Chair proposed that the Board take note of the Chair's report on the activities undertaken on the Board's behalf during the intersessional period between the Board's forty-fourth and forty-fifth meetings (AFB/B.45/2).
8. The Board took note of the information provided in the report.

Item 4. Report on activities of the secretariat

9. The Manager of the secretariat reported on the activities of the secretariat (AFB/B.45/3).
10. Following his presentation, several members raised concerns regarding the late issuance of documents, saying that it significantly hindered their preparation for the meeting and affected the Board's ability to make informed decisions in a timely, constructive and responsible manner. One member suggested that the secretariat issue the documents by the agreed deadline and then issue revised versions as needed. He also noted that the reports of the Chair and the secretariat could be issued later to ensure that they included all the activities carried out during the intersessional period.
11. Responding to members' concerns, the Manager of the secretariat assured the Board that the situation would be rectified and that documents would be issued in a timely manner in future.
12. One member requested a number of changes to the wording of the report, including the removal of the reference to a submission made to the Global Solidarity Levies Task Force, on the grounds that the secretariat had not been given a mandate to make such a submission and the Global Solidarity Levies Task Force did not hold consensus multilateral endorsement as a mechanism contributing to the Fund, which was required. He also asked that the wording used to refer to a gender knowledge study be brought into line with the Board-endorsed

wording used in the report of the Board to the Conference of the Parties serving as meeting of the Parties to the Kyoto Protocol (CMP) and the Conference of the Parties serving as the Meeting of the Parties to the Paris Agreement (CMA); other members, however, noting that the reference was to a knowledge product of the Adaptation Fund, said that they did not see the need for such alignment.

13. The Manager of the Secretariat clarified that the submission to the Global Solidarity Levies Task Force had been made as part of a mandate related to the existing resource mobilization strategy and entailed no commitment on behalf of the Fund, but assured the Board that the secretariat would follow the Board's guidance regarding the appropriateness of such initiatives.

14. The Board took note of the information provided, on the understanding that a revised version of the document would be issued with the requested amendments. The revised report was subsequently issued as document AFB/B.45/3/Rev.1.

Item 5. Dialogue with civil society organizations

15. The dialogue with civil society organizations consisted of presentations in accordance with the agenda for the dialogue (AFB/B.45/4), followed by a short question period. The report on the dialogue is set out in annex III to the present report.

16. The Board took note of the presentations and recommendations of the civil society organizations.

Item 6. Status of the transition of the Adaptation Fund to serve the Paris Agreement

17. A representative of the secretariat presented the status of the transition of the Adaptation Fund to serve the Paris Agreement (AFB/B.45/5).

18. The Board continued its discussion in a closed session, following which it adopted the decision below.

19. The Adaptation Fund Board (the Board), having considered document AFB/B.45/5 and its addenda, which included draft new Terms and Conditions of Services to be Provided by the World Bank as Trustee, the trustee's discussion note and a draft memorandum of understanding with the Global Environment Facility Council for secretariat services to the Board, decided:

(a) To express its appreciation for the efforts of the World Bank in drafting new terms and conditions of services to be provided by the World Bank as trustee of the Adaptation Fund Trust Fund ("Terms and Conditions") prepared for the forty-fifth meeting of the Board (AFB/B.45/5/Add.2);

(b) To reaffirm decision 1/CMP.14, which states that the Adaptation Fund shall continue to receive a share of proceeds, if available, from activities under articles 6, 12 and 17 of the Kyoto Protocol to the United Nations Framework Convention on Climate Change;

(c) To take note of the progress made during the forty-fifth meeting of the Board concerning the draft memorandum of understanding (MOU) regarding secretariat services to the Board;

(d) To express its intention to further revise and finalize the draft Terms and Conditions and the draft MOU regarding secretariat services, as appropriate, in the light of any additional guidance that may be provided by the Conference of the Parties serving as the Meeting of the Parties to the Kyoto Protocol and/or the Conference of the Parties serving as the Meeting of the Parties to the Paris Agreement, as appropriate, regarding the Adaptation Fund's transition to exclusively serve the Paris Agreement.

(Decision B.45/1)

Item 7. Assessment of the implications of new collective quantified goal on climate finance (NCQG) decision

20. The representative of the secretariat presented the secretariat's assessment of the implications of the new collective quantified goal on the Fund's operations (AFB/B.45/6), which included three possible scenarios for the Fund's contribution to the collective goal of US\$ 300 billion per year and the broader ambition to scale up financing to US\$ 1.3 trillion per year. He also addressed various comments made and concerns raised during the informal session held on the matter just prior to the Board meeting. In the secretariat's view, he said, the three scenarios outlined in the document would not entail any change to the Fund's mandate or operating model. Eligible parties would continue to receive grant-based funding on a full-cost-of-adaptation basis, driven by their needs, views and priorities and would not incur any debt. They would not be expected to provide co-financing and would continue to choose the implementing entity with whom they wished to work. He noted various concerns raised during the informal session, including with respect to the effectiveness of blended finance; the potential for earmarking to be based on donor, private sector or philanthropic interests and concerns that such funders might change the governance of the fund; the relationship between the US\$ 300 billion target and the broader ambition of scaling up financing to US\$ 1.3 trillion; and the need for direction from the CMA. He also noted that Board members had expressed general interest in receiving more information, including information on the three possible scenarios and their potential impact on the Fund's operations.

21. During the ensuing discussion, members expressed appreciation for the secretariat's report and generally recognized it as being intended to generate discussion, although one said that the discussion at the Board's forty-fourth meeting had only called for the secretariat to review the funding caps with a view to supporting the mandate to tripling the funding outflow, not a full analysis or interpretation of the decision on the new collective quantified goal on climate finance (NCQG).

22. Several members indicated an interest in further exploring scenario 3, saying that it offered the best chance of meeting the NCQG, although individual members flagged the need to further explore how the funds would be channelled and the impact of a tripled outflow on the recipients' side, as well as the eventual need for a framework to enable joint investment by accredited entities such as multilateral development banks, as well as for technical reviews, system enhancements and improvement in performance measurement to establish funding windows.

23. Other suggestions of areas for further analysis included the Fund's role in the overall landscape of climate finance provision and its added value; the track record, in terms of quality, impact and level of finance, of the other organizations providing adaptation finance; and the entire NCQG decision in the light of the Board's comments.

24. Various concerns were also raised or reiterated with respect to scenario 3, as well as scenario 2, including regarding the Fund's capacity to explore new funding instruments given the workload entailed by the recent increases in the project and country caps; the advisability of engaging in new, uncertain and complicated operations; the use of funding modalities that might potentially impose debt or other additional burden on developing countries, even for those that leveraged external funds; and governance issues related to who would decide where the funds went and what they were used for.

25. Following a proposal by one member, the Board agreed to further consider the matter in the context of the discussion under agenda item 8, on the resource mobilization strategy. Therefore, having considered document AFB/B.45/6, the Adaptation Fund Board took note of the documents prepared by the secretariat and the deliberations of the Board on the matter, noting the varying views of the Board members.

Item 8. Resource mobilization strategy

26. A representative of the secretariat presented the draft Adaptation Fund resource mobilization strategy for the period 2026–2029 (AFB/B.45/7).

27. In the ensuing discussion, members underscored the importance of a new resource mobilization strategy for the Fund and said that although the draft strategy was a strong starting point it would require further refinement before they could approve it. They underscored the importance of, among other things, avoiding any impact on the governance of the Fund and its full-cost-of-adaptation and grant-based nature; having a clearly defined resource mobilization process; allowing for technology transfer; integrating the private sector more effectively; ensuring that earmarking did not affect other countries' access to the Fund; and ensuring that strong communication with current donors was not lost in the search for new donors.

28. Some members were in favour of affording the secretariat broad flexibility to develop non-traditional sources of funding and explore policy issues related to the use of innovative approaches to resource mobilization, including engagement with a non-traditional donor base. One also recommended including the private sector's perspective more explicitly in the case for investment in the Fund, including articulating the Fund's role in derisking, enabling market development and offering targeted investment windows potentially aligned with corporate environmental, social and governance priorities. Other members, however, called for caution with respect to private sector investment, saying that such non-traditional financing was only acceptable as a supplement and complement to public financing. Some also said they would not support any innovative sources of funding that would place a burden on developing countries, in particular through the application of international levies or taxes on their consumers, and one cautioned against the introduction of any category of country other than "developed" and "developing".

29. Several members said that it would be important to leave the current resource mobilization strategy in place until a new strategy was approved, and one requested that any draft resource mobilization strategy to be discussed at the forty-sixth Board meeting be sent to members no later than three weeks before travel to the Board meeting began. There was also general support for engaging in intersessional work on the draft strategy.

30. Responding, the Manager of the secretariat acknowledged that the secretariat had limited capacity to implement a targeted resource mobilization strategy. Although all the

secretariat staff contributed to resource mobilization, strategy implementation was a main task of the Countries and Partnerships Unit, which was a small unit, even though it would soon have an additional staff member as approved by the Board at its forty-fourth meeting. He also reminded Board members that the secretariat welcomed any support they could provide as ambassadors of the Fund, including in identifying new contributors and innovative ways of raising funds.

31. Also responding to members' questions, the representative of the secretariat drew attention to the significant increase in the average annual level of resource mobilization under the current strategy compared with the first strategy, which she attributed to the hard work of the Board and secretariat as well as the innovative approaches adopted. Noting that the secretariat had learned from the first two strategies, she drew attention to the case for investment included in the new strategy, an innovative feature that had been added based on feedback from contributors regarding the need to ensure that funding was based on the Fund's impact and results. Finally, she assured the Board that the secretariat was committed to preserving the grant-based nature of the Fund and that the new strategy was entirely based on a country-driven approach built around direct access.

32. The Adaptation Fund Board (the Board), having considered the information contained in document AFB/B.45/7, decided to request the secretariat:

(a) To revise the draft resource mobilization strategy for the period 2026–2029 contained in annex I to document AFB/B.45/7, taking into account the Board's discussion at its forty-fifth meeting and guidance from the Board's resource mobilization task force, for the Board's consideration at its forty-sixth meeting;

(b) To consult with the Board during the intersessional period to support the preparation of the next draft;

(c) To continue to implement the current resource mobilization strategy until the next strategy was approved.

(Decision B.45/2)

Item 9. Strategic results framework

33. A representative of the secretariat presented the proposed update to the Adaptation Fund's Strategic Results Framework (AFB/B.45/8), prepared by the secretariat pursuant to the implementation plan for the Fund's Medium-Term Strategy 2023–2027.¹

34. Following the presentation, one Board member sought clarification whether the proposed updates would hinder project funding and increase the burden on implementing entities, as they might not have the requested data on hand and cultural barriers could distort data collection. . Noting that there were costs associated with collecting data, she underscored that information should not be collected for its own sake or as a public relations exercise, that it would be preferable to have indicators that could be applied flexibly, and various collection methods should be considered. Another member added that only the data

needed to fulfil the Fund's mandate should be required, and that any changes should not be applied retrospectively.

35. Other members, however, noted that 24 implementing entities had been consulted on the updates, including some that had piloted them. The updates had been country-driven and were meant to create a streamlined process that provided better, disaggregated data; they were unlikely to increase the burden on the implementing entities given that they were already familiar with the results framework.

36. The representative of the secretariat confirmed that the revisions were meant to reduce the reporting requirement on the entities and that data would not be collected for its own sake. She highlighted that the total number of indicators would be reduced through the proposed changes and the updates had been developed in consultation with the implementing entities, based on their feedback on existing indicators. The mandatory reporting requirements for implementing entities would remain unchanged as they only had to report on the indicators relevant to their projects as determined by themselves. She also explained that the secretariat proposed to update outcome and output indicators by incorporating sectoral disaggregation, in order to better align the framework with the crosscutting themes of the medium-term strategy, especially locally led adaptation, and the sector and dimensions approach of the Global Goal on Adaptation targets.

37. The Adaptation Fund Board (the Board), having considered the information contained in document AFB/B.45/8, including the development of specific indicators for the innovation and locally led adaptation portfolio and alignment of current indicators with the global goal on adaptation and other developments, decided:

(a) To approve the proposed revisions to the Strategic Results Framework (SRF) as contained in document AFB/B.45/8, taking into account the guidance provided by the Board;

(b) To request the secretariat to revise the project performance report templates as needed and develop a guidance document on the revised SRF and related revised project performance report templates, and to share them with the implementing entities, with the understanding that implementing entities were only required to report, per current practice, on the proposed indicators relevant to their country context, with mandatory alignment to at least one core indicator;

(c) To consult with the Board when preparing the guidance document;

(d) That the SRF would come into effect three months after the revised project performance report templates and guidance documents referred to above were shared with the implementing entities.

(Decision B.45/3)

Item 10. Report of the Accreditation Panel

38. The Chair of the Accreditation Panel presented the report of the Panel's forty-fourth meeting (AFB/B.45/9).

39. Following his presentation, a representative of the secretariat presented the outcome of an in-depth analysis of the Fund's reaccreditation approach (AFB/B.45/9, annex), prepared by the secretariat in response to decision B.44/5.

40. During the ensuing discussion, there was general agreement that a structural change was needed to ease the burden of reaccreditation, particularly on national implementing entities. Several members voiced support for option 3, with individual members noting that it would support institutional effectiveness and performance and fast-track direct access, maintain ongoing control over accreditation and address issues of institutional changes arising from political instability.

41. Other members expressed the view that the Fund was not ready for option 3, citing a variety of reasons, including a lack of adequate resources within the secretariat and substantial cost increases for national implementing entities. Several were instead in favour of extending the accreditation term to 10 years with a mid-term review, but others countered that an extension would not work for all implementing entities, and that it would remove the Board's ability to monitor implementing entities' capacity, as the only monitoring criteria would then be project implementation.

42. Members posed many questions, regarding, among other things, the adequacy of the Fund's current monitoring and accountability frameworks; whether the goal of option 3 was to further align with the GCF processes; the time needed for the secretariat to assess the implications of option 3; and the next steps.

43. Responding, the representative of the secretariat assured the Board that project performance was already an integral factor in reaccreditation; the Panel would not proceed with a reaccreditation without the secretariat's findings on project performance. Furthermore, an implementing entity with no record on project implementation was subject to a full reaccreditation process, while those that had already implemented a project could be fast-tracked through certain steps. On the question of alignment with the GCF, she noted that the Fund had eight years of operational linkage with the GCF on accreditation and reaccreditation. The GCF was overhauling its accreditation process but fast-track accreditation from the Adaptation Fund remained one of the pillars of its framework. The standard for accreditation remained unchanged and would continue to be valid for the continuous accreditation proposed in option 3. Noting the considerable effort invested in accreditation by the countries, Accreditation Panel and secretariat, she stressed that the reason for the proposed changes was to ensure an efficient, effective process for all those involved. .

44. Turning to the question of increased costs for national implementing entities, the representative of the secretariat said that significant increases were not expected under option 3. She explained that there was ongoing discussion between the Accreditation Panel and the various units within the secretariat to ensure that the evidence-based accreditation and reaccreditation process had been validated by all stakeholders, including the implementing entities with respect to added costs. The Fund had operational linkages in place with other multilateral climate funds in readiness as well as accreditation, and ways of enhancing the readiness programme to better support the implementing entities had been discussed during the readiness programme evaluation. Furthermore, as the Accreditation Panel only recommended accreditation once it was sure that the country seeking accreditation had a solid monitoring and compliance handling system and the needed institutional capacity, the most important capacity assessment and strengthening was already done during the accreditation process.

45. In terms of next steps, the representative of the secretariat said that the secretariat would develop a detailed proposal for implementation and transitional arrangements and associated costs for the preferred option and report back to the Board at its forty-sixth meeting.

The secretariat was confident of its ability to report back at the forty-sixth meeting as it had been discussing the matter with the Panel since the forty-fourth meeting. She also assured the Board that no changes would be made to the reaccreditation process prior to the Board's forty-sixth meeting.

46. Also addressing the question of the secretariat's operational capacity, another representative of the secretariat specified that under the proposed options 2 and 3, where the secretariat would serve as the first line of detection and escalation, more upfront work would be required to set up an appropriate information system, and further work would be needed to determine whether the data currently collected annually was sufficient. Once the information requirements and triggers were determined, an automated system and dashboard system would be developed, entailing upfront costs that remained to be estimated.

47. Several members, while supporting further analysis of option 3 by the secretariat, stressed the need for a detailed proposal for implementation that captured the financial and operational risks and the implications in terms of transparency and accountability, and provided clarity for national implementing entities regarding the elements and actions that would lead to the cancellation of accreditation.

48. The Board then closed the session to discuss the matters considered by the Panel at its forty-fourth meeting, following which it adopted the decisions below.

49. The Adaptation Fund Board (the Board), having considered document AFB/B.45/9, and recalling its decision B.44/5 requesting the secretariat to assess the operational implications of the current reaccreditation model and develop options for its revision, decided:

(a) To take note of the three options for revising the Adaptation Fund's reaccreditation process as presented in document AFB/B.45/9;

(b) To request the secretariat, taking into account guidance provided by the Board at its forty-fifth meeting and in consultation with the Accreditation Panel, to prepare a detailed proposal for option 3 as presented in document AFB/B.45/9, including the financial and operational implications and transitional period arrangements, as well as any necessary amendments to policies, for consideration by the Board at its forty-sixth meeting.

(Decision B.45/4)

50. Having considered the recommendation of the Accreditation Panel, the Adaptation Fund Board decided to reaccredit the World Food Programme as a multilateral implementing entity of the Adaptation Fund for five years, as per paragraph 39 of the operational policies and guidelines for Parties to access resources from the Adaptation Fund, with an accreditation expiration date of 10 October 2030.

(Decision B.45/5)

Item 11. Report of thirty-sixth meeting of the Project and Programme Review Committee

51. The Chair of the PPRC presented the report of the thirty-sixth meeting of the PPRC (AFB/PPRC.36/43).

52. During consideration of the recommendation to endorse the concept note submitted by the World Food Programme for the Bolivarian Republic of Venezuela (AF00000436, a

member representing the Western Europe and Others constituency asked that the following statement be included in the present report:

“Sweden wishes to emphasize the importance of transparency in all aspects of the Fund’s project financing. Equally vital is the consistent and thorough application of the Fund’s established risk and control frameworks. These mechanisms are designed to safeguard the integrity of our operations and to mitigate financial, operational and reputational risks. This is particularly critical in contexts where administrative systems may face challenges related to transparency and accountability. In such cases, we expect the secretariat and the PPRC to exercise heightened diligence, ensuring that project planning, execution and reporting are fully aligned with the Fund’s governance standards.”

53. The Board took note of the report of the PPRC and adopted the decisions below on matters considered by the PPRC at its thirty-sixth meeting.

Approach to initial application of the country cap

54. The Adaptation Fund Board decided to request the secretariat to prepare options concerning access to funding under the country cap, with a view to clarifying and/or updating decision B.36/41, paragraph (a), for the consideration of the Project and Programme Review Committee at its thirty-seventh meeting.

(Decision B.45/6)

(a) Review of single-country project and programme proposals

Single country project and programme proposals: fully developed project proposals – proposals from national implementing entities:

Armenia: Enhancing the Land-based Adaptation of Communities Adjacent to Arid Zones and Forest Protected areas of Armenia by Duplicating and Expanding the Successful Mechanisms of the Previous Projects (fully-developed project; Environmental Project Implementation Unit (EPIU); AF00000363; US\$ 4,097,546)

55. Having considered the recommendation of the Project and Programme Review Committee, the Adaptation Fund Board decided:

(a) To approve the fully-developed project proposal, as supplemented by the clarification responses provided by the Environmental Project Implementation Unit (EPIU) to the request made in the technical review;

(b) To approve the funding of US\$ 4,097,546 for the implementation of the project, as requested by EPIU;

(c) To request the secretariat to draft an agreement with EPIU as the national implementing entity for the project.

(Decision B.45/7)

Armenia: Enhancing Resilience of Communities to Climate Change in Shirak Marz Leveraging Best Practices of the Pilot Project Implemented in Artik Community (fully-developed project; Environmental Project Implementation Unit (EPIU); AF00000368; US\$ 4,472,630)

56. Having considered the recommendation of the Project and Programme Review Committee, the Adaptation Fund Board decided:

(a) To approve the fully-developed project proposal, as supplemented by the clarification responses provided by the Environmental Project Implementation Unit (EPIU) to the request made in the technical review;

(b) To approve the funding of US\$ 4,472,630 for the implementation of the project, as requested by EPIU;

(c) To request the secretariat to draft an agreement with EPIU as the national implementing entity for the project.

(Decision B.45/8)

Ethiopia: Transforming Communities: A Nexus of Climate-Smart Agriculture, Livelihood Diversification, and Women's Economic Empowerment (fully-developed project; Ministry of Finance and Economic Cooperation of the Federal Democratic Republic of Ethiopia (MOFEC); AF00000410; US\$ 9,999,328)

57. Having considered the recommendation of the Project and Programme Review Committee, the Adaptation Fund Board decided:

(a) To approve the fully-developed project proposal, as supplemented by the clarification responses provided by the Ministry of Finance and Economic Cooperation of the Federal Democratic Republic of Ethiopia (MOFEC) to the request made in the technical review;

(b) To approve the funding of US\$ 9,999,328 for the implementation of the project, as requested by MOFEC;

(c) To request the secretariat to draft an agreement with MOFEC as the national implementing entity for the project.

(Decision B.45/9)

Indonesia: Sustainable Landscape Governance; Towards Climate Resilience of Community in Tempe Lake Ecosystem (fully-developed project; Partnership for Governance Reform (Kemitraan); AF00000302; US\$ 993,081)

58. Having considered the recommendation of the Project and Programme Review Committee, the Adaptation Fund Board decided:

(a) To approve the fully-developed project proposal, as supplemented by the clarification responses provided by the Partnership for Governance Reform (Kemitraan) to the request made in the technical review;

(b) To approve the funding of US\$ 993,081 for the implementation of the project, as requested by Kemitraan;

(c) To request the secretariat to draft an agreement with Kemitraan as the national implementing entity for the project.

ANNEX III

DIALOGUE WITH CIVIL SOCIETY, 9 OCTOBER 2025, BONN, GERMANY

1. The Vice-Chair of the Adaptation Fund Board invited the Board to enter into a dialogue with civil society organizations (CSOs). The dialogue was moderated by a representative of Germanwatch.
2. A representative of HelpAge International explained the actions that CSOs took jointly with the Board and provided examples. The CSO network's online discussion group was a platform for active civil society observers and included some 200 participants. The benefit of CSO engagement were that the Fund had trusted allies to help when strengthening its policy commitments, making its policies more inclusive. The CSO network connected the Fund with hundreds of accredited observers, expanding its reach and visibility, bringing insights from excluded groups and ensuring that its decisions were informed by local realities.
3. A representative of Women's Environment and Development Organization commented on the issues being addressed by Board at its forty-fifth meeting. She said that the new collective quantified goal for climate finance (NCQG) would fundamentally change the Adaptation Fund's funding model by leveraging external funds, potentially undermining its stated goal of tripling its outflow and its grant-based approach. With respect to resource mobilization, she called on the Fund to exceed its targets, set more ambitious resource mobilization "floors"; focus on expanding contributions from existing donors and securing consistent, multi-year contributions; and avoid using fiscal year 2022 as a baseline when assessing financial needs. Turning to the policy on safeguarding against sexual exploitation and abuse and sexual harassment (SEAH), she said that it had positive aspects but could be improved by stating that sexual abuse could be both physical and psychological; including concrete examples of SEAH to help implementing entities recognize it when developing their own policies and capacity; and avoiding references to "good faith", which perpetuated the myth that many SEAH reports were false or malicious. With respect to update of the Fund's Environmental and Social Policy, she averred a number of shortcomings, including a failure to sufficiently address the overlapping issues among vulnerable groups; a lack of clear definitions, standards or guidance for ensuring meaningful engagement; the lack of a list of activities that could not be funded; a lack of clear guidance on the use of free prior and informed consent, intersectional vulnerability assessments and meaningful consultations; the inclusion of unclear project criteria; and the use of aspirational terms instead of enforceable commitments, which weakened accountability. In terms of the strategic results framework, there was a need to explicitly specify those who had been excluded and marginalized and ensure that they were listed in disaggregated reports. Further guidance was needed on intersectional assessments, meaningful consultations and accessible monitoring tools, and to that end community-based organizations had to be included in assessments, consultations and monitoring. On the topic of observer participation, she called for geographic balance and funding for travel and other costs; observer participation in selected closed sessions; and a mechanism for reporting on civil society recommendations. In her view, the elderly, Indigenous Peoples and community-based organizations should not be captured under the broad term "civil society", and funding, capacity-building and logistical support should be made available to marginalized and smaller groups for their participation in Board meetings, consultations and

workshops. CSO recommendations had to be integrated into the Fund's evaluation and learning framework to ensure a measurable influence on Board decisions.

4. A representative of the International Institute for Environment and Development presented issues and lessons learned on the direct access modality. He highlighted the fact that far more funding was being allocated to multilateral implementing entities (MIEs) than to national implementing entities; only 19 small-island developing States or least-developed countries had a national implementing entity accredited with the Green Climate Fund and just 13 had one with the Adaptation Fund. Only 48 direct access projects had been funded across the two funds, and those were concentrated in just 15 countries. Readiness support, a simplified accreditation process and funding criteria were critical to changing that situation, as was a regional or in-country presence. During the question and comment period, Board members generally agreed that the presentation ought to be circulated but had divergent views on the CSO recommendations for SEAH. Some expressed the view that the risks of reputational harm from frivolous, malicious or otherwise unfounded complaints meant that the policy ought to be treated cautiously. Others, however, said that such concerns were overstated, and that the real issue was the abuse of power that underlay SEAH, especially when money was involved. One member stressed the seriousness of such abuse of power and said that any individual or entity with a reputation for tolerating such abuse ought to be prohibited from receiving Adaptation Fund support. With respect to leveraging external funds, some members were surprised that the CSOs expected it to lead to less available funding. The presenters were also asked how equitable and balanced participation from all the different regions could be ensured.

5. Responding to Board member's comments and questions, the representatives of CSO said that regionally balanced and equitable participation by observers in Board meetings could not be ensured unless the travel cost of at least some of the participants were covered; otherwise, the observers would come mainly from the Global North. Addressing the SEAH-related comments, they said that the SEAH policy should not simply offer a remedy for abuse but should serve to prevent it, which was more important, as remedies were inadequate consolation for the victims, who never completely recovered from the abuse. With respect to the NCQG concept note, they called on the Board to remember its mandate, noting that while private sources of funding could open doors, that often came with unanticipated costs. They urged the Board to instead aim to increase the flow of resources based on public sources of funding.

6. The Vice-Chair thanked the civil society organization representatives for their presentations and recommendations and recalled that the Board would discuss civil society's participation in the work of the Board under agenda item 15.
