- 1 Regional LLA Aggregator programme approved **USD 10M**
- **Total: USD 40.5M/USD 196.6M**

# Other Programming-related Decisions

1. **Clarification on approach to utilization of country cap.**
  1. **Decision B.45/6 requested the Secretariat to** prepare options concerning access to funding under the country cap with a view to clarifying and/or updating the existing guidance and present them 46<sup>th</sup> meeting of the Board.
2. **Decommitment of PFG grants.**
  1. 3 PFGs were de-committed for Costa Rica, Cuba & Panama, and Chad & Sudan with a total value of USD250,000 through **Decisions B.45/45, B.45/46 and B.45/47**
3. **Post approval changes.**
  1. 2 post approval changes were approved for Bangladesh and Chile as per **Decisions B.45/48 and B.45/49**
