PROJECT FORMULATION GRANT FOR BOLIVIA

I. Background

1. The Board at its eleventh meeting discussed the document "Funding for Project Formulation Costs" (AFB/11/6) and agreed, in its Decision B.11/18, that:

- i. project formulation grants (PFG) should be given once a project concept has been approved
- ii. consideration should be given in terms of differentiating between NIEs and MIEs, since some NIEs might have financial difficulties in trying to formulate project or programme proposals;
- iii. a flat rate should be given for project formulation costs;
- iv. a list of eligible activities and items still needed to be prepared; v. the grant should be additional to the project cost; and
- v. the fate of funds if the final project document was rejected should be determined.

2. There was consensus that a three-tiered system should be considered for project formulation grants: endorse a project concept with a PFG amount, endorse a project concept without a PFG amount, or reject the project concept.

3. Following the discussion, the Board decided:

To request the secretariat to reformulate the document, to include a comparison of eligible activities provided by other funds for project formulation grants, to take into account guidance provided by the Board at the present meeting, and to submit the document to the Board at its twelfth meeting, through the EFC. The EFC should review and finalize the process and policy of the project formulation grant focusing, in particular, on: the issue of unspent project funds; the procedures followed by other funds in that regard; and the determination of a flat-rate.

4. A document was prepared by the secretariat in response to the above mandate and presented at the third EFC meeting, which made specific recommendations to the Board at its twelfth meeting. Having considered the recommendation of the Ethics and Finance Committee, the Board, in its Decision B.12/28, decided that:

(a) Project Formulation Grants (PFGs) will only be made available for projects submitted through NIEs. The Board would continue reviewing the question of PFGs for projects submitted through MIEs and would solicit comments from members and alternate members by February 14, 2011; the views would be compiled by the secretariat for presentation to the Board at its March 2011 meeting;

(b) If a country required a project formulation grant, a request should be made at the same time as the submission of a project concept to the secretariat. The secretariat will review and forward it to the PPRC for a final recommendation to the Board. A PFG could only be awarded when a project concept was presented and endorsed;

(c) A PFG form, reproduced in Annex V, should be submitted;

- (d) Only activities related to country costs would be eligible for PFG funding;*
- (e) A flat rate of up to US\$30,000 shall be provided, inclusive of the management fee, which cannot exceed 8.5 per cent of the grant amount. The flat fee would be reviewed by the Board at its thirteenth and all subsequent meetings;*
- (f) If the final project document is rejected, any unused funds shall be returned to the Adaptation Fund Trust Fund;*
- (g) Once a project/programme formulation grant is disbursed, a fully developed project document should come to the Board for approval within 12 months. No additional grants for project preparation can be received by a country until the fully developed project/programme document has been submitted to the Board; and*
- (h) The Trustee was instructed to remove the set-aside of US\$100,000 for project preparation that had been decided at the June 2010 meeting, as project preparation would be approved on a project-by-project basis.*

5. In its twenty-fourth meeting, the Board had initiated steps to launch a pilot programme on regional projects and programmes, not to exceed US\$ 30 million and had requested the secretariat to prepare for the consideration of the Board a proposal for such a pilot programme (Decision B.24/30). In its twenty-fifth meeting, the secretariat submitted such document and the Board decided to:

- (a) Approve the pilot programme on regional projects and programmes, as contained in document AFB/B.25/6/Rev.2;*
- (b) Set a cap of US\$ 30 million for the programme;*
- (c) Request the secretariat to issue a call for regional project and programme proposals for consideration by the Board in its twenty-sixth meeting; and*
- (d) Request the secretariat to continue discussions with the Climate Technology Center and Network (CTCN) towards operationalizing, during the implementation of the pilot programme on regional projects and programmes, the Synergy Option 2 on knowledge management proposed by CTCN and included in Annex III of the document AFB/B.25/6/Rev.2.*

(Decision B.25/28)

6. The approved document AFB/B.25/6/Rev.2 contained provisions for the approval of project formulated grants for regional project and programme proposals, at different development stages, as follows:

“It is proposed that the Board open a structured call for MIEs and RIEs to submit pre-concepts for regional projects and programmes. The optional pre-concepts would be very brief proposals of maximum 5 pages that would explain the proposed regional adaptation project/programme. The pre-concepts would be screened and technically reviewed by the

secretariat, and subsequently reviewed by the PPRC. Together with the pre-concept, the proponent could submit a Phase I PFG request, up to the maximum level of US\$ 20,000. While endorsing the pre-concept, the Board could also approve the Phase I PFG request. The endorsement of the pre-concept would not create an obligation for the Board for later funding. As the next step, the proponent would submit a concept, and with it the proponent could submit a Phase II PFG request. The maximum AFB/PPRC.18/25/Add.1 level of the Phase II PFG would be US\$ 80,000 for proposals that had been previously granted Phase I PFG, and US\$ 100,000 for proposals that bypassed the optional pre-concept stage. While endorsing the concept, the Board could also approve the Phase II PFG request. The endorsement of the concept would not create an obligation for the Board for later funding, as it is the case for the national projects. The final stage of the proposal process would be the submission of the fully-developed regional project document”.

II. The Project Formulation Grant Request

7. This addendum to the document AFB/PPRC.37/15 “Proposal for Bolivia” includes a request for a Project Formulation Grant, requesting a budget of US\$ 150,000, which was received by the secretariat along with the concept for the project AF00000494 “AGUA Bolivia: Building Climate Resilience through Integrated Forest and Watershed Management in Vulnerable Micro-Catchments”. This proposal was submitted by International Bank of Reconstruction and Development (IBRD), which is a Multilateral Implementing Entity of the Adaptation Fund, in time for consideration by the Adaptation Fund Board at its forty-sixth Board meeting.

8. In accordance with Decision B.12/28, paragraph (b), the secretariat carried out an initial review of the PFG request and found that the document provided detailed information on the use of the requested funds. The proposed activities were aligned with the goal of the project and would support: comprehensive consultation process; vulnerability assessment studies; development of project options, implementation arrangements and preliminary indicators through participatory design; Design of Locally Led Adaptation (LLA) small-grants facility; Environmental, Social, Gender and Indigenous Peoples safeguards framework; and development of the project results framework, M&E and learning approach.

9. Therefore, the PPRC may want to consider and recommend to the Board to approve the PFG Request, provided that the related concept proposal is endorsed.

Technical Summary

The project “AGUA Bolivia: Building Climate Resilience through Integrated Forest and Watershed Management in Vulnerable Micro-Catchment” aims to increase the resilience of vulnerable communities in selected watersheds and water recharge zones of the Bolivian Amazon basin. This will be done through the three components below:

Component 1: Locally Led Adaptation for Water & Livelihoods (USD 3,800,000);

Component 2: Community Climate Services & Preparedness (USD 2,200,000);

Component 3: Micro-Watershed Ecosystem-based Adaptation (EbA) (USD2,347,877).

Requested financing overview:

Project/Programme Execution Cost: USD 870,000

Total Project/Programme Cost: USD 9,217,877

Implementing Fee: USD 782,123

Financing Requested: USD 10,000,000

The proposal package includes a project formulation grant in the amount of USD 150,000.

The first technical review raises several issues, such as justifying the project on its own adaptation merits; revising components financing table; revising components description and providing details on the activities; clarifying few

	<p>issues related to USPs; providing initial gender assessment; adding theory of change and specifying the AF outcomes/ objectives supported by the project; providing more information on related national plans and adding a list of applicable national technical standards; adding missing information on conducted consultations; clarifying the learning and knowledge management aspects; providing a list of related projects along with a discussion on their complementarity; justifying the project on the basis of full cost of adaptation reasoning; revising alignment with AF RF table and AF E&S checklist as per AF requirements; among others indicated in the Clarification Requests (CRs) and Corrective Action Requests (CARs) raised in the review.</p> <p>The second technical review finds that the proposal has addressed most of the CRs and CARs requests and adequately reflects the comments raised in the first technical review through track changes. The proposal still needs to address, a number of CRs and CARs related to, strengthening the explanation how vulnerable groups were involved in the consultation process stage of submission, modification of PFG request form, full cost of adaptation and addressing some issues with the alignment table. 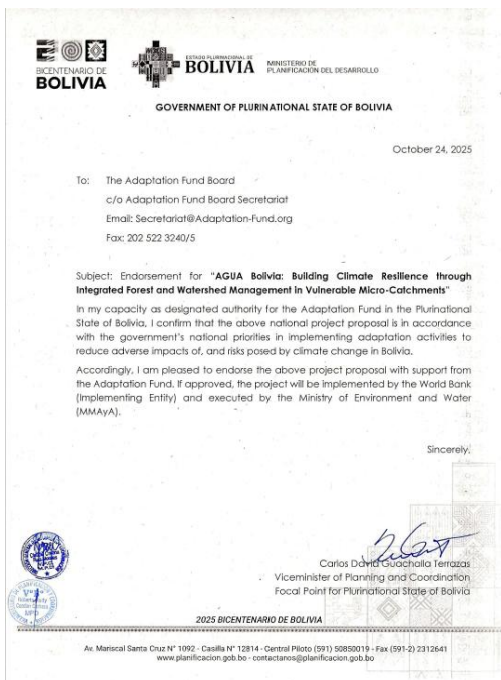

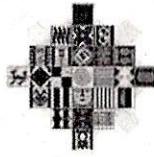

Description of Activities:

Activity 1. Country- and site-specific climate risk, vulnerability and adaptation options assessment

(US\$1820,000)

This activity will support a country- and site-specific assessment of climate risks and vulnerabilities, including the preliminary identification and prioritization of specific micro-watersheds and water recharge zones to be targeted under AGUA Bolivia. The assessment will focus on key climate hazards—particularly droughts, floods and wildfires—together with exposure pathways and vulnerability drivers affecting water security, ecosystems and climate-sensitive livelihoods.

The activity will include the compilation and review of existing climate, hydrological and environmental data; analysis of hazards, exposure and vulnerability at micro-watershed level; and the application of technical prioritization criteria (including climate risk, ecosystem condition, water security relevance and socio-economic vulnerability) to preliminarily prioritize micro-watersheds for project intervention. It will also identify and screen feasible adaptation and hazard mitigation options appropriate to local biophysical and socio-economic conditions. Outputs will be consolidated in technical notes and a synthesis report to inform subsequent project design.

This activity is required to ensure that project interventions are grounded in site-specific climate risks and clearly defined geographic priorities, in line with Adaptation Fund eligibility requirements. The requested budget reflects a focused technical consultancy covering analysis, prioritization and documentation, without financing new large-scale studies.

Activity 2. Development of project options, implementation arrangements and preliminary indicators through participatory design (US\$2830,000)

This activity will support the development and refinement of concrete project and sub-project options through a structured participatory design process. Building on the climate risk and vulnerability assessment, the activity will translate adaptation priorities into clearly defined project components, activities, implementation arrangements and cost estimates, ensuring technical feasibility and operational readiness.

The activity will include: (i) preparation of background technical papers and option notes; (ii) structured, non-territorial technical design workshops with the executing entity, subnational actors and technical experts to deliberate on design choices; and (iii) the participatory identification of preliminary, design-level indicators and milestones to support internal project structuring and decision-making. These preliminary indicators will be identified through participatory design processes and are intended solely to support internal project structuring, coherence and feasibility at the design stage

The activity will also assess the institutional and operational capacity of executing partners, identifying capacity gaps and implementation risks to inform final project arrangements. The requested budget reflects the combination of specialized technical inputs and multiple structured design workshops required to support a credible and participatory design process.

Activity 3. Design of Locally Led Adaptation (LLA) small-grants facility (USP – fixed framework) US\$325,25000

This activity will design the operational architecture of the LLA small-grants facility, which is a central element of AGUA Bolivia. At Concept Note stage, community-level interventions qualify as Unidentified Sub-Projects within a fixed framework, requiring a clearly defined operational design prior to submission of the full proposal.

The activity will define the full grant cycle, eligibility criteria and typologies of sub-projects, devolved decision-making roles and responsibilities, fiduciary flows and approval procedures. It will also deliver operational guidelines, templates and tools, including sub-project application and appraisal templates, screening and eligibility checklists, and decision-making matrices. These outputs will be developed and refined through structured LLA co-design workshops with the executing entity, subnational actors and technical experts.

The design of the LLA facility will be informed by inclusive and participatory principles consistent with the spirit of Free, Prior and Informed Consent (FPIC), while recognizing that proposed interventions are small-

scale, community-driven adaptation actions and do not involve large-scale infrastructure. The requested budget reflects the specialized and operational nature of this work and the need for iterative co-design to operationalize devolved decision-making.

Activity 4. Environmental, Social, Gender and Indigenous Peoples safeguards framework for USPs
US\$235,000

Given the use of a community-driven USP approach, this activity will develop a proportional environmental, social, gender and Indigenous Peoples safeguards framework compliant with the Adaptation Fund Environmental and Social Policy and Gender Policy, as well as the World Bank Policies. The framework will include risk categorization, exclusion criteria, screening checklists, mitigation measures, culturally appropriate engagement approaches consistent with FPIC principles, and a project-level grievance redress mechanism.

The activity will combine specialized safeguards consultancy inputs with technical validation workshops to ensure that the framework is practical, proportionate to risk, and usable within a LLA adaptation context. Particular attention will be given to aligning safeguards requirements with devolved decision-making processes under the LLA facility.

This activity is required to enable community-driven decision-making within the LLA framework, while ensuring environmental integrity, social inclusion and protection of rights. The requested budget reflects the need for specialized expertise and iterative validation of safeguards instruments, which is particularly important when financing multiple community-driven sub-projects.

Activity 5. Territorial consultations and participatory validation in selected micro-watersheds
US\$235,000

This activity will support territorial participatory and consultative processes in selected micro-watersheds to validate geographic priorities, locally relevant adaptation options, and key elements of the LLA design. Engagement will involve Indigenous peoples, women's groups, youth representatives, community organizations and municipal authorities, using culturally appropriate approaches and local languages where required.

The activity is intended to ensure that project design reflects local knowledge, differentiated vulnerabilities and community perspectives, and to strengthen the legitimacy and relevance of locally led adaptation actions. These processes are participatory and consultative in nature, proportionate to the scale and scope of the proposed project interventions.

The requested budget reflects costs associated with facilitation, local travel, translation, documentation and iterative engagement at the territorial level.


Activity 6. Development of the project results framework, M&E and learning approach (aligned with the Adaptation Fund Results Framework) (US\$135,000)

This activity will support the development of the project-level results framework, building on the indicators and results logic already outlined at the concept stage and ensuring alignment with the Adaptation Fund Results Framework. It will further define project-specific outcomes, outputs and indicators, together with indicative baselines, targets and means of verification, consistent with Adaptation Fund requirements.

The activity will also articulate the project's monitoring, evaluation and learning approach at the design stage, including the overall logic for tracking results across locally led sub-projects and outlining the basis for a monitoring plan to be fully developed during the implementation phase.
